Notes to the Financial Statements

A. Description of the Plan

The following brief description of the Evergreen Health Group 401(k) (plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The plan is a defined contribution plan designed to provide retirement savings benefits to eligible employees of the company through tax deferred voluntary contributions by employees.

Employees are eligible to participate in the plan after attaining the age of eighteen and completion of three months of service. Employees can enter the plan on the next monthly date upon satisfaction of the eligibility requirements. Employees who are covered by a collective bargaining agreement, a non-resident alien who received no earned income, a leased employee or an employee paid on a commission basis are not eligible to participate in the plan.

Magnolia NH LLC, Houston NH LLC, Port Lavaca NH LLC and Zephyr NH LLC are all adopting employers.

Contributions

Participants may elect to defer a percentage or dollar amount of their salary each pay period up to 100% of their annual eligible compensation, as defined by the plan document, in the form of pre-tax contributions. Participants may also contribute eligible rollovers from other qualified defined benefit or defined contribution plans and individual retirement accounts. The plan also allows Roth contributions. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions.

The Plan has an automatic elective deferral contribution of 3%. No automatic increase applies.

The Plan does not provide for employer contributions.

Participant's accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately and fully vested in their voluntary contributions and rollover contributions plus actual earnings thereon.

Notes to the Financial Statements

A. Description of the Plan - Continued

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 7.75% to 8.50%. Principal and interest is paid ratably through payroll deductions. The loan term may not exceed 5 years, except that any loan used to purchase your principal residence may be repaid over a longer period.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

If an active participant has attained age fifty-nine and one-half (59 ½), they may elect to withdraw all or a portion of their account while still employed by the company. Hardship distributions are permitted.

Forfeited accounts

Forfeitures represent the non-vested benefits remaining from employees who have withdrawn from the plan before coming fully vested. Forfeited amounts are retained in the plan and will first be used to pay administrative expenses. Any remaining forfeitures will be used to reduce any employer contribution to the plan. Forfeited non-vested accounts amounted to \$0 as of July 31, 2025.

B. Summary of Significant Accounting and Reporting Policies

Basis of accounting

The financial statements are maintained on the liquidation basis of accounting for the year ended July 31, 2025, in accordance with U.S. generally accepted accounting principles.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. See Note C for a discussion of fair value measurements.

B. Summary of Significant Accounting and Reporting Policies – Continued

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Operating expenses

Certain administrative expenses of maintaining the plan are paid by the company. Contract administrative fees are paid by the plan.

Subsequent events

The plan has evaluated subsequent events through December 22, 2025, the date the financial statements were available to be issued.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

C. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2025 and December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Collective investment trust: Valued at net asset value (NAV) of units of the collective investment trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the collective investment trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

D. Related Party and Party In Interest Transactions

During 2025, the plan investments were investments managed by Principal Trust Company. Principal Trust Company is a custodian as defined by the plan and, therefore, a party in interest with respect to the plan. These transactions are covered by an exemption from the “prohibited” transaction provisions of ERISA and the IRC.

E. Plan Termination

The company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. See Note J for further information.

F. Tax Status

On June 30, 2020, the IRS stated that the prototype adopted by the plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The plan has not received a determination letter specific to the plan itself; however, the plan administrator and the plan’s tax counsel believe that the plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. Custodial Certification

The plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Principal Trust Company and was not subjected to any auditing procedures performed by the independent public accountants:

- a.* Total investments as shown in the accompanying statements of net assets available for benefits of \$0 as of July 31, 2025 and \$400,963 as of December 31, 2024.
- b.* Net investment income as shown in the accompanying statement of changes in net assets available for benefits of \$16,466 for the period ended July 31, 2025.
- c.* All investment-related information in the accompanying supplemental Schedule H, Line 4i—Schedule of Assets (Held at End of Year) as of July 31, 2025.

I. Failure to Timely Transmit Participant Contributions

The Company failed to remit to the Plan certain participant contributions and loan repayments during 2025 totaling \$25,664 and \$153,828 during 2024, for a grand total of \$179,492 within the period prescribed by DOL's regulations. Plan officials adopted stricter oversight in this area and will make contributions to the affected participants' accounts to compensate those participants for potential lost earnings and correct the prohibited transaction by filing Form 5330 Return of Excise Taxes Related to Employee Benefit Plans.

J. Liquidation Basis of Accounting

On March 31, 2025, the Plan adopted a resolution to terminate the plan. Plan assets will continue to be held on behalf of participants and their beneficiaries until distributed in accordance with the Plan terms. Participants shall be 100% vested in their accounts. Management determined the liquidation basis of accounting was appropriate on July 31, 2025 and December 31, 2024.

The assets of the Plan have been fair valued based on the market at year end. Income and expense cannot be reasonably estimated through termination and have not been accrued in these financial statements. Income from investments along with the corresponding investment fees of the plan and fees for distributions will be reported annually. Management cannot reasonably determine when all participants will request their distributions.
