Independent Auditors' Report

To the Participants and the Ohio Education Association Group Benefit Plan Committee Ohio Education Association Group Benefit Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Ohio Education Association Group Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of August 31, 2025 and 2024, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Ohio Education Association Group Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended August 31, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report.

We are required to be independent of the Ohio Education Association Group Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, as described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of these financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Ohio Education Association Group Benefit Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Independent Auditors' Report

To the Participants and the Ohio Education Association Group Benefit Plan Committee Ohio Education Association Group Benefit Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Ohio Education Association Group Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of August 31, 2025 and 2024, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Ohio Education Association Group Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended August 31, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report.

We are required to be independent of the Ohio Education Association Group Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, as described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of these financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Ohio Education Association Group Benefit Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Ohio Education Association Group Benefit Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Ohio Education Association Group Benefit Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) – modified cash basis as of August 31, 2025 and the supplemental schedule of reportable transactions – modified cash basis for the year ended August 31, 2025 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules – modified cash basis, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules – modified cash basis related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to the Financial Statements – Modified Cash Basis

1. Plan Description

The following description of the Ohio Education Association (the Employer and Sponsor) Group Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was restated effective September 1, 2025, provides certain benefits to eligible employees as provided under an active benefit plan related to collectively bargained benefits. The Plan provides medical, dental, prescription, vision, life and disability benefits to eligible employees and their dependents. These benefits are provided through insurance contracts. Dental benefits for retired participants are provided through insurance contracts fully paid by retired employees.

The Plan offers dependent care reimbursement accounts, and a tuition reimbursement program. In addition, the Plan offers an insurance opt out program and a Medicare Part B reimbursement program. The Plan also provides certain health care benefits to retired employees and severance benefits to terminated employees. These benefits are included in benefit payments on the accompanying financial statements.

Administrative expenses

Certain administrative expenses are paid by the Sponsor.

2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Certain revenues are recognized when received rather than when earned. Certain expenses are recognized when paid and insurance premiums are recognized in the period required for income tax return reporting rather than when the obligation is incurred.

The income tax return reporting periods for the Plan's insurance providers are as follows:

For the year ended August 31, 2025

- Medical Mutual – for the time period 01/01/2024 – 12/31/2024
- Delta Dental – for the time period 01/01/2024 – 12/31/2024
- Hartford – for the time period 01/01/2024 – 12/31/2024
- Vision Service Plan – for the time period 01/01/2024 – 12/31/2024

For the year ended August 31, 2024

- Medical Mutual – for the time period 01/01/2023 – 12/31/2023
- Delta Dental – for the time period 01/01/2023 – 12/31/2023
- Hartford – for the time period 01/01/2023 – 12/31/2023
- Vision Service Plan – for the time period 01/01/2023 – 12/31/2023

Estimates

The preparation of financial statements on a modified cash basis of accounting requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from these estimates.

Contributions

Participant contributions consist of the contributions to health care reimbursement accounts and dependent care reimbursement accounts and specified amounts for elected health coverage. The Sponsor makes contributions as necessary to provide for current benefits and may elect to make additional contributions based on information obtained from the Plan's actuary.

Investment valuation

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on the trade date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties

The Plan invests in various investments that are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with such investments, it is reasonably possible that changes in the values of such investments will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Plan termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination, the assets then remaining shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement.

Subsequent events

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through March 17, 2026, the date on which the financial statements were available to be issued.

3. Information Certified by the Trustee

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the trustee, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits – modified cash basis as of August 31, 2025 and 2024 and the supplemental schedule of assets (held at end of year) – modified cash basis as of August 31, 2025 and the related investment activity reflected in the statements of changes in net assets available for benefits – modified cash basis for the years ended August 31, 2025 and 2024 and the information reflected on the supplemental schedule of reportable transactions – modified cash basis for the year ended August 31, 2025.

4. Fair Value Measurements

A framework for measuring fair value is established using a fair value hierarchy that prioritizes the inputs to valuation. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under generally accepted accounting principles are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurements level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets at fair value.

- *Interest-bearing cash:* Valued at observable market quotations for identical assets and are priced on a daily basis.
- *Registered investment companies:* Valued at observable market quotations for identical assets and are priced on a daily basis.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Postretirement Obligation – Healthcare Benefits

The Sponsor provides certain health care benefits to retirees. As of August 31, 2025 and 2024, the Sponsor provides such coverage related to collectively bargained benefits. In general, all eligible employees are entitled to receive certain medical benefits upon meeting certain age and service requirements at the time of retirement.

Relevant information with respect to the postretirement benefit obligation for healthcare benefits at August 31, 2025 and 2024 can be summarized as follows:

For fiscal year 2025, annual increases in Pre-Medicare medical costs were initially assumed to total approximately 8.7% per year and gradually decline to 4.4% by approximately 2034. For fiscal year 2025, annual increases in Post-Medicare medical costs were assumed to total approximately 4.5% per year.

For fiscal year 2024, annual increases in Pre-Medicare medical costs were initially assumed to total approximately 8.6% per year and gradually decline to 4.4% by approximately 2034. For fiscal year 2024, annual increases in Post-Medicare medical costs were assumed to total approximately 4.5% per year.

Other significant assumptions used in the postretirement benefit obligation valuations as of August 31, 2025 and 2024 were as follows:

- End of year weighted-average discount rates increased to 5.20% from 5.0%.
- Termination rates for Management Employees increased from the prior year, while professional and associate staff termination rates remained unchanged from prior year.
- Changes in the assumed spouse coverage election rate changed from 60 percent to 50 percent.
- Life expectancy of participants is unchanged and is based on the 2012 base rates from the Pri-2012 Mortality Study with Blue Collar and White Collar Adjustments projected generationally from 2012 with Scale MP-2021 for August 31, 2025 and August 31, 2024.

The rationales for selecting the assumptions, including changes in assumptions not mandated or set by a reporting standard, are based on an actuarial assumption review performed and dated June 30, 2025.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

6. Postemployment Obligation – Severance Benefits

The Sponsor provides certain severance benefits in accordance with provisions of collective bargaining agreements (for professional staff and associate staff). In general, all eligible employees are entitled to receive certain severance benefits upon meeting certain service and vesting requirements at the time of termination.

The postemployment obligation includes the provision for future severance benefits that have not yet been distributed through the Plan. The Plan administrator believes that the provision is adequate. The provision is an estimate based upon the following actuarial methods and assumptions:

Actuarial Method:

The obligation is the anticipated amount of severance compensation payable at termination. Benefits are attributed to each year of service until fully vested. A benefit is payable as of the date of the employee's termination.

Actuarial Assumptions:

- The estimated termination date for associate staff hired prior to April 17, 1993 is assumed to be the earliest retirement date of the employee.
- The estimated termination date for associate staff hired on or after April 17, 1993 is assumed to be age 62 with at least 5 years of service, or any age with 32 years of service.
- Associate staff employees are assumed to receive from 5 to 35 days of salary as a severance benefit, based on estimated years of continuous service.

- The estimated termination date for professional and management staff and officers of the Sponsor is assumed to be the earliest retirement date.
- Professional and management staff and officers are assumed to receive from 1 to 7 weeks of salary as a severance benefit, based on estimated years of continuous service and an additional 2 weeks of salary for those staff reaching retirement.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postemployment benefit obligations.

7. Income Tax Status

The Plan received an exemption letter from the Internal Revenue Service dated September 8, 2004, in which the Internal Revenue Service stated that the trust is tax-exempt under the provisions of Internal Revenue Code (IRC) Section 501(c)(9) as a Voluntary Employee Beneficiary Association. The Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status. The Plan has been amended since receiving the exemption letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan’s financial statements.

8. Medicare Prescription Drug, Improvement and Modernization Act of 2003

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 introduced a prescription drug benefit under Medicare (Medicare Part D) as well as a federal subsidy to sponsors of retiree health care benefit plans that provide a benefit that is at least actuarially equivalent to Medicare Part D.1. The accumulated postretirement benefit obligation and the changes in the benefit obligation have not been adjusted for any amount associated with the Medicare subsidy. The Plan has not applied for reimbursement under Medicare Part D due to the minimal financial impact it would have on the Plan. The Plan Sponsor, therefore, has not undergone the expense to determine whether the Plan’s benefits are actuarially equivalent to Medicare Part D.1.
