Independent Auditor's Report

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of NanoString Technologies Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through September 30, 2024, and the related notes to the financial statements ("2024 Financial Statements").



Note 1 - Description of the Plan

The following description of the NanoString Technologies Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established effective January 1, 2005. The Plan was restated effective June 23, 2021 and most recently amended on that date. The Plan covered all eligible employees of NanoString Technologies Inc. (the "Company"). Employees became eligible in the Plan once they reached 21 years of age.

On September 30, 2024, the Plan merged into the Bruker 401(k) Plan. See Note 8.

The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan administrator was responsible for oversight of the Plan. The Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance and reports to the Plan administrator.

Contributions

Employees could elect to defer up to 90% of their compensation as pre-tax or Roth contributions. The Plan had adopted an automatic enrollment feature under which new employees were enrolled with a 2% pre-tax deferral unless they formally waive participation or elect a different participation level. The automatic enrollment deferral percentage increased by 1% each year to a maximum of 10%. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other eligible defined benefit or defined contribution plans (rollover).

The Company could make discretionary employer matching contributions. For the period from January 1, 2024 through September 30, 2024, the Company elected to match 100% of deferrals up to the first 2% of compensation, and 50% of the next 4% of compensation up to a total maximum employer matching contribution of \$4,000. The Company could also make discretionary profit sharing contributions. There were no profit sharing contributions made for the Plan period ended September 30, 2024. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts

Each participant's account was credited with the participant's contributions, and matching contributions, as well as allocations of the Company's nonelective contributions (if any) and plan earnings. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account. Participants directed the investment of their account into various investment options offered by the Plan.

Vesting

Participants were immediately vested in all contributions plus actual earnings thereon.

Notes receivable from participants

A participant could borrow the lesser of \$50,000 or 50% of his or her vested balance, with a minimum loan of \$1,000. Loan terms ranged from one to five years or up to 30 years for the purchase of a primary residence. The interest rate was set at 2.0% above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

Payment of benefits

Upon termination of service, retirement, death, or disability, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allowed for hardship withdrawals in accordance with provisions specified in the Plan document. Participants with a vested balance less than \$1,000, who do not elect a form of distribution, received a lump-sum distribution equal to the value of the vested portion of their account. Participants with a vested balance between \$1,000 and \$5,000, who did not elect a form of distribution, had their vested balance rolled over to an individual retirement account.

Forfeited accounts

Forfeited nonvested accounts could have been used to pay administrative expenses and to reduce future Company contributions. Forfeited nonvested accounts totaled \$0 and \$2,347 as of September 30, 2024 and December 31, 2023, respectively. During 2024, \$1,295 of forfeitures were used to offset employer contributions and \$294 of forfeitures were used to offset administrative expenses.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance companies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Contributions

Contributions from Plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Revenue credit program

The Plan's recordkeeper has designed a participant revenue credit program which the Plan participates in. Fidelity Management Trust Company ("Fidelity") deposits excess revenue received in connection with plan services to a suspense account in the Plan. The expense account can be used to pay plan expenses or allocated to participant accounts. Revenue credits generated are used to reduce recordkeeping fees otherwise paid by the Plan. During 2024, revenue sharing deposits into the Plan offset recordkeeping fees by \$60,836. The balance in the revenue sharing account was \$0 and \$5,632 as of September 30, 2024 and December 31, 2023, respectively.

Subsequent events

The Plan has evaluated subsequent events through January 6, 2026, the date the financial statements were available to be issued.

Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at September 30, 2024 and December 31, 2023, and investment income and interest income on notes receivable from participants for the period from January 1, 2024 through September 30, 2024, that are disclosed in the accompanying financial statements, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Collective trust fund: Valued at the NAV ("net asset value") of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are actively traded.

Note 5 - Related party transactions and party-in-interest transactions

Certain Plan investments were invested in funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Effective February 1, 2021, Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MPSA") between the Company and Fidelity. Fidelity receives revenue from mutual fund and collective trust fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by Fidelity from such mutual fund or collective trust fund service providers exceeds the amount owed under the MPSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

Note 6 - Tax status

The volume submitter Plan document, which the Plan has adopted in a nonstandardized adoption agreement, obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the volume submitter plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan's adoption agreement has been amended since receiving the opinion letter on the volume submitter plan, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in statements of net assets available for benefits.

Note 8 - Plan merger

As discussed in Note 1, the net assets of the Plan were merged into the Bruker 401(k) Plan on September 30, 2024.
