Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note (3) to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements December 31, 2024 and 2023

(1) **Description of the Plan:**

The following description of the National University College 401(k) Plan (“the Plan”), provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan’s provisions.

(a) **General** -

On June 15, 2009, National College of Business & Technology Company, Inc. (“the Plan Sponsor”) adopted a defined contribution profit sharing plan for the Florida Technical College division, in the form of the Ascensus Prototype Document Sponsorship Service, for the purpose of providing retirement benefits to employees and to encourage and assist them in adopting a regular savings program by means of payroll deductions through a plan that qualifies under applicable laws of the Internal Revenue Service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The adoption agreement signed by the Plan, assigned Ascensus Trust Company as the Trustee for an indefinite period of time. The effective date of the Plan was June 15, 2009.

Effective March 29, 2018, the Plan was amended and restated, as a result of a reorganization transaction among the Plan Sponsor and its subsidiaries. Such reorganization was effective on February 1, 2018.

There were 210 and 226 participants with account balances in the Plan as of December 31, 2024 and 2023, respectively.

(b) **Eligibility** -

The Plan covers all employees of the Plan Sponsor after completion of one (1) year of service and are age twenty-one (21) or older. The Plan excludes employees covered by a collective bargaining agreement.

(c) **Contributions** -

Participants can make pre-tax contributions up to \$23,000 per year. Catch-up contributions by participants with age fifty (50) or over at the end of the plan year are set up to \$7,500 per year.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct all or a portion of the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various funds as investment options for participants. Effective January 1, 2020, the Plan Sponsor matches participants’ savings contributions at the rate of 50 cents for each dollar of participants’ pre-tax contribution, up to a maximum of 6% of the participants’ compensation.

(d) **Participant accounts** -

An account is maintained for each participant, credited with the participant’s contribution, Sponsor’s matching contributions and, allocation of investment income based on participant’s account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

(e) **Vesting** -

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Sponsor’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three (3) years of eligible service.

(f) **Forfeitures** -

Forfeitures of non-vested account balances in any given year are to be applied to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$57,374 and \$39,052, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce Plan Sponsor contributions.

(g) **Notes receivable from participants** -

Participants may borrow from their vested account balance in the Plan a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 less the highest outstanding loan balance during the prior twelve (12) months or 50% of their vested account balance. The loans are secured by the balance in the participant's account, and bear interests based on the prime rate plus 1%. Principal and interest is paid through bi-weekly payroll deductions and are reinvested to the participants' investment accounts based on their investment elections in effect at the time of reinvestment. Outstanding balance of notes receivable from participants as of December 31, 2024 and 2023, amounted to \$58,339 and \$5,375, respectively.

(h) **Payment of benefits** -

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, partial payments, or a direct rollover to an individual retirement account or to another qualified plan.

(2) **Summary of Accounting Policies:**

(a) **Basis of accounting** -

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

(b) **Basis of presentation** -

The Plan's fiscal year ends on December 31st of each year. All references to year in these notes to financial statements represent calendar years unless otherwise noted. The Plan has evaluated subsequent events through March 19, 2026, the date the financial statements were available to be issued.

(c) **Use of estimates** -

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

(d) **Investment valuation and income recognition** -

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See related Note (4) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(e) **Notes receivable from participants** -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivables from participants are reclassified as a distribution based upon the terms of the plan document.

(f) **Payment of benefits** -

Benefits paid directly to participants are recorded when paid.

(g) **Administrative expenses** -

Except for loan origination fees associated with notes receivable from participants, all administrative fees are paid by the Plan's Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. In addition, certain investment related expenses are included in net appreciation of fair value of investments. See Note (6).

(h) **Excess participants contributions payable** -

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as liability with a corresponding reduction to contributions. See Note (5).

(i) **Risks and uncertainties** -

The Plan invests in various investments securities which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(3) **Information certified by trustee:**

The Plan Administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the investments and notes receivable from participants' information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) were obtained or derived from information obtained by the Plan Administrator and certified as complete and accurate by Ascensus, qualified institution, and in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Ascensus, the trustee of the Plan, held the Plan's investment assets and executed investment transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Information obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Ascensus:

- Investments (at fair value and contract value), and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024, as follows:
 - Interest and dividend income in the amount of \$29,063
 - Net appreciation in fair value of investments in the amount of \$185,966
- The information for all investments and the participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024 as shown in the ERISA-required supplemental schedule.

(4) **Fair value measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

(a) Quoted prices for similar assets or liabilities in active markets;

(b) Quoted prices for identical or similar assets or liabilities in inactive markets;

(c) Inputs other than quoted prices that are observable for the asset or liability;

(d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market account: Valued at the amount of cash balances on deposit.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Excess participants' contributions:

The Plan failed to pass the Average Deferral Percentage (ADP) test for the years ended December 31, 2024 and 2023. Excess participants' contributions refunds amounting to \$41,102 and \$65,839, were recorded as a liability in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, respectively. The Plan reimbursed the 2024 excess contributions to its participants on December 5, 2025. The Plan reimbursed the 2023 excess contributions to its participants on August 5, 2024.

(6) Administrative fee:

The Trustee charges an administrative fee for the services performed under the Plan Agreement associated with Plan recordkeeping, accounting, and trustee services. Total administrative fees paid for the year ended December 31, 2024, amounted to \$14,854 of which \$11,183 was paid directly by the Plan's Sponsor and \$3,671 was paid using plan assets.

(7) Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, the rights of all affected participants in their accounts, up to the date of such termination, shall become non-forfeitable.

(8) Party-in-interest investments and prohibited transactions:

Plan investments are managed by Ascensus Trust Company. Ascensus Trust Company is the trustee and Ascensus, LLC is the recordkeeper of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

As required by ERISA Section 2510.3-102, the Sponsor is required to segregate participants' contributions from its general assets as soon as practicable when amounts are contributed by participants or withheld from their wages for a pension benefit plan such as the Plan.

During the year ended December 31, 2024, there was an unintentional non-withholding of participants contributions which was corrected during the year 2025. These amounts were recorded as employee and employer contributions receivables amounting to \$3,012 and \$1,344, respectively, in the accompanying statements of net assets available for benefits as of December 31, 2024. The Plan's Sponsor will absorb the costs incurred by the Plan as a result of the untimely remittances of the participants' contributions.

(9) Tax status:

The Plan has received its latest determination letter from the Internal Revenue Services ("IRS") dated January 1, 2018, stating that the Plan is qualified under section (401) of the Internal Revenue Code, and therefore, the related trust is exempt from taxation.

The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

(10) Subsequent events:

Effective July 31, 2025, National College of Business & Technology, Inc. d/b/a Florida Technical College was removed as a trustee of the Plan and National College of Business & Technology US, LLC was appointed as successor trustee of the Plan.
