Opinion

NOTE 1 – Description of the Plan and Summary of Significant Accounting Policies

The following description of the Valley Detroit Diesel Allison Employee Benefit Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a welfare benefit plan that provides benefits to substantially all full-time employees of Valley Power Systems, Inc. and affiliates (collectively, the Company), including employees' covered spouses and dependents, following 60 days of employment, working a minimum of 30 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Qualified beneficiaries may continue health benefits as mandated under the Consolidated Omnibus Budget Reconciliation Act (COBRA). The Plan's Trustees are responsible for oversight of the Plan.

Benefits

The Plan provides health benefits (medical, prescription, dental, vision, long-term disability, accidental death, dismemberment, and short-term disability), and life insurance benefits for eligible employees of the Company and their dependents. Benefits for medical, prescription, vision, long-term disability, accidental death, dismemberment, and short-term disability are provided through fully insured contracts.

Self-insured Benefits

Benefits for dental coverage are provided through a self-insured trust which is funded by the Company and employee contributions. The claims for self-insured benefits are processed by the Plan's third-party claims processor. The claims processor pays claims directly to or on behalf of participants and is then reimbursed by the Plan's VEBA trust (the Trust). Despite the Plan's utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

Funding Policy

The Company makes monthly estimated contributions to provide sufficient funds for insurance premiums and benefit payments. Employees make voluntary contributions to the Plan for a portion of the total premiums for their own coverage and, if elected, coverage for their spouses and dependents, which are funded each pay period.

Benefit Obligations and Net Decrease in Benefit Obligations

Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan’s contract administrator based on claims data provided by the Plan’s third-party administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment. The plan accrued \$16,053 for incurred but not reported or processed claims at December 31, 2023. There was no such accrual at December 31, 2024.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation. Employer contributions are recorded in the period in which they are due to the Plan in accordance with the Plan's funding policy.

Payment of Benefits

Claim payments are recorded when paid by third-party claims processors.

Other Benefit Payments

Effective December 31, 2024, the Plan discontinued the use of the Trust. Amounts remaining in the Trust were transferred to the general assets of the Company and were used to pay benefits until fully expended. These amounts are reflected as other benefit payments on the statement of changes. Beginning in 2025, all employee premium contributions have been included in the general assets of the Company, and claims and premiums paid have been made directly from the Company's general assets.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, accounting, and management services, are paid by the Company on behalf of the Plan and are not included in these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through February 18, 2026, the date the financial statements were available to be issued.

NOTE 2 – Tax Status

The Trust received an exemption letter from the Internal Revenue Service (IRS) stating that the Trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the Trust may be subject to income taxes. No federal or state income taxes have been recorded for the years ended December 31, 2024 and 2023 for unrelated business taxable income.

In addition, the Plan and the Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions.

NOTE 3 – Related-Party Transactions

Administrative expenses include fees paid to Delta Dental of California and Igoe Administrative Services, third-party claims processors. Therefore, transactions entered into by these service providers qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 4 – Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants and to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.
