NOTE 1 – Description of the Plan

The following description of the Valley Power Systems, Inc. FSA Plan (the Plan), formerly known as Valley Power Systems, Inc. Amended and Restated Cafeteria Plan, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a welfare benefit plan that provides benefits to substantially all full-time employees of Valley Power System, Inc. and affiliates (collectively, the Company), including covered beneficiaries and dependents, following 60 days of employment, if scheduled to work an average of at least 40 hours per week and if eligible for the group medical plan. Union members, non-resident aliens, and leased employees are excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan.

Benefits

The Plan permits employees of the Company to elect between certain non-taxable fringe benefits and cash compensation to the extent permitted by applicable law. The Plan is intended to meet the requirements of Section 125 of the Internal Revenue Code (IRC) and is designed to establish procedures under which employees may elect to participate in the ERISA covered welfare benefit plans offered under this Plan.

Employees shall make such election by entering into a Participation Agreement and electing any one or more of the options available as follows: Premium Expense Account covering health, dental, and vision insurance premiums, Dependent Care Flexible Spending Account (DCFSA) covering childcare costs, Limited Purpose Flexible Spending Account (LPFSA) covering preventive care, dental, and vision expenses and Health Flexible Spending Account (HFSA) which covers non-reimbursed medical, dental, and vision expenses. Changes can be made once a year during an open enrollment period. Changes may also be made if an employee has a qualifying event as defined in the plan document.

Funding Policy

The Plan is funded by contributions in amounts equal to the salary waived by employees who elect to receive contributory coverages. The Company may provide an additional non-elective contribution in the form of employer funding into the employee's account. For the year ended December 31, 2024, the Company made a \$2,654 contribution.

NOTE 1 – Description of the Plan (Continued)

Forfeitures

The amount credited to a participant's account for any calendar year is used only to reimburse the participant for expenses incurred during such fiscal year. The participant must apply for reimbursement from the LPFSA and HFSA on or before 120 days after the calendar year. The DCFSA requires application for reimbursement on or before 90 days after the calendar year. For the years 2024 and 2023, a participant can carryover up to \$640 and \$610, respectively, of their unreimbursed LPFSA and HFSA account balance into the subsequent year. Any unreimbursed account balance in excess of the carryover amount is forfeited. For the year ended December 31, 2024, approximately \$6,300 were forfeited. Forfeitures may be used to pay administrative costs or used to provide additional benefits under the Plan.

Other Benefit Payments

Effective December 31, 2024, the Plan discontinued the use of the Trust. Amounts remaining in the Trust were transferred to the general assets of the Company and were used to pay benefits until fully expended. These amounts are reflected as other benefit payments on the statement of changes. Beginning in 2025, all employee premium contributions have been included in the general assets of the Company, and claims and premiums paid have been made directly from the Company's general assets.

NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - Summary of Significant Accounting Policies (Continued)

Contributions

Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation. Employer contributions are recorded in the period in which they are paid.

Payment of Benefits

Benefit claims are recorded as deductions from net assets available when paid by the Plan.

Administrative Expenses

The Company pays for certain accounting, legal, administrative, and management services without charge to the Plan. Expenses paid by the Company are not included in these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through February 18, 2026, the date the financial statements were available to be issued.

NOTE 3 – Tax Status

The Trust received an exemption letter from the Internal Revenue Service (IRS) stating that the Trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the Trust may be subject to income taxes. No federal or state income taxes have been recorded for the years ended December 31, 2024 and 2023 for unrelated business taxable income.

In addition, the Plan and the Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

NOTE 3 – Tax Status (Continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions.

NOTE 4 – Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants and to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.
