As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from ADP Retirement Trust Services, LLC as of December 31, 2024, and for the period from April 5, 2024 to December 31, 2024, and Voya Retirement Insurance and Annuity Company as of December 31, 2023 and for the period from January 1, 2024 to April 4, 2024 stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Time Out America, LLC 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note A

Description of Plan

The following description of the Time Out America, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan established on February 1, 1997, and has been amended and restated throughout the years to comply with tax legislation. The Plan is maintained by Time Out America, LLC and certain affiliated companies (the "Sponsor" or the “Company”). The Plan covers all employees, except leased employees, residents of Puerto Rico, student/interns, temporary employees and certain part-time employees, of the Company who have attained the age of 21. Temporary or part-time employees are required to complete one year of Eligibility Service determined using the 1,000 Hours of Service Method. Effective January 1, 2022, the Plan was amended and restated to comply with the Internal Revenue Service's "IRS" Cycle 3 restatement requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment oversight.

Plan Amendments:

Effective April 1, 2024, the Plan changed trustees and transferred Plan assets from Voya Retirement Insurance and Annuity Company to ADP Retirement Trust Services, LLC. Also effective April 1, 2024, the Plan was restated to adopt the non-standardized defined contribution pre-approved plan sponsored by ADP, Inc. As part of this restatement, the entry date was modified to the first day of the month coinciding with or next following the date eligibility requirements are met, modified the elective deferral limit to 90% of compensation, and added a traditional automatic contribution arrangement on a prospective basis to withhold 3% of compensation unless a participant makes an affirmative election.

Contributions:

Each year, eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or after-tax Roth contributions to the Plan, subject to the maximum amount allowed by the Internal Revenue Code. For participants who have attained age 50, catch-up contributions are also allowed by the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Additionally, the Company may make discretionary matching and profit sharing contributions. The matching contributions formula is applied and determined on each payroll period. For the year ended December 31, 2024, the Company contributed 100% of the first 3% of base compensation that a participant contributed to the Plan. There were no profit sharing contributions for the year ended December 31, 2024. Contributions are subject to certain statutory limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts:

Each participant's account is credited with the participant's contributions, Company matching contributions and allocations of the Company's discretionary profit sharing contribution, if any, and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings, thereon, is based on years of continuous service. A participant is 100% vested after four years of credited service.

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions, on an after-tax basis. Generally, loan terms range over a period not extending beyond five years from the date of the loan, unless such loan is used to acquire a dwelling unit that within a reasonable time (determined at the time the loan is made) will be used as the principal residence of the participant. The interest rate is the Prime rate plus 1% and will be established in the month the loan is effective.

Payment of Benefits:

Participants may elect to receive a lump-sum amount equal to the value of their vested interest upon retirement (age 65), early retirement (age 55 and 5 years of service), termination of service, death or disability. A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document.

Forfeitures:

If a participant terminates employment before being fully vested in any employer contributions, then the non-vested portion of the terminated participant's account balance is forfeited and remains in the plan. These forfeited amounts may first be used to pay administrative expenses, and then to reduce employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$26,298 and \$11,121, respectively. For the year ended December 31, 2024, forfeited amounts totaling \$41,667 were used to reduce employer contributions.

Note B

Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition:

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions:

Participant contributions and the related Company matching contributions are recognized in the period the participant contribution is withheld from compensation.

Payment of Benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Company personnel perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as plan expenses. Fees related to participant recordkeeping and specific participant transactions are charged directly to each participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value investments.

Excess Contributions Payable:

At December 31, 2024 and 2023, amounts payable to participants totaling \$60,870 and \$36,734, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability with corresponding increase to distributions. The Plan Sponsor processed the 2023 excess contribution refunds by the March 15 statutory deadline. However, the Plan Sponsor was unable to distribute the 2024 excess contribution refunds by March 15. As a result, those refunds were distributed after the required deadline, and the Plan Sponsor may be required to calculate and fund any associated excise taxes, as applicable.

Subsequent Events:

The Plan has evaluated subsequent events through March 12, 2026, the date the financial statements were available to be issued.

Note C

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three Levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the U.S. Securities and Exchange Commission and are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at their accumulation unit value (AUV). The separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts (typically the beginning AUV is \$10) and is then determined daily based on the net asset value of shares of the underlying fund, the fund's dividends and the contract's separate account charges. The Plan's pooled separate account investments include large-cap equity funds that seek capital appreciation with some also pursuing current income, small- and mid-cap and specialty equity funds that primarily seek long-term capital growth (including index funds tracking mid- and small-cap benchmarks), and global and international equity funds that seek long-term capital appreciation with certain strategies also providing current income. Balanced, asset allocation, and target-date funds pursue a combination of capital appreciation and current income consistent with their respective risk profiles and target retirement glide paths. Bond and income funds seek to maximize current income, provide inflation protection, or generate total return through income and capital appreciation, depending on the fund's stated objectives.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E

Investment Contract with Insurance Company

The Plan invested in a fully benefit-responsive investment contract (“Voya Fixed Account”) with the Voya Retirement Insurance and Annuity Company (“Voya”) (the “Issuer”). The amounts invested, as of December 31, 2024 and 2023, were \$- and \$263,333, respectively. The Issuer maintains the contributions in its general account with no maturity date. The account is credited with earnings and charged for participant withdrawals and administrative expenses.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Issuer, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the Issuer’s ability to meet its financial obligations. The Issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. Generally, there are no events that limit the ability of the Plan to transact at contract value with the Issuer. There are no events or circumstances that would allow the Issuer to terminate the fully benefit-responsive contract with the Plan and settle at an amount different from contract value.

Note F

Related Party and Party-In-Interest Transactions

Certain plan investments are investments managed by Voya Retirement Insurance and Annuity Company and ADP Retirement Trust Services, LLC. Voya Retirement Insurance and Annuity Company and ADP Retirement Trust Services, LLC are the trustees, as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. The Company also utilizes third-party recordkeepers, Angel Pension Group, Inc. and ADP, Inc., to provide certain other administrative services. These transactions are exempt from being prohibited transactions by ERISA.

Note G

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note H

Non-Exempt Transactions

During the years ended December 31, 2024 and 2023, the Company failed to remit to the Plan's trustee certain participant contributions and loan repayments totaling \$182,937 within the period prescribed by Department of Labor regulations. Consequently, the Plan is considered to have engaged in non-exempt transactions with a party-in-interest. The Company is required to rectify the matter by paying lost earnings on the participant contributions that were remitted late.

Note I

Tax Status

On October 6, 2020, the Internal Revenue Service ("IRS") stated that the non-standardized pre-approved plan adopted by the Plan, as then designated, qualifies under Section 401(a) of the IRC. The Plan administrator timely adopted the approved Plan. The Plan administrator believes that the Plan is currently being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the tax authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the tax authorities; however, there are currently no audits for any tax periods in progress.

Note J

Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the financial statements.
