1. Description of Plan

The following description of the Employee Benefit Plan of The Arc of Hunterdon County, Inc (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan, which became effective July 1, 1986, was subsequently amended and restated as of July 1, 2015, is a defined contribution retirement plan covering substantially all eligible employees of The Arc of Hunterdon County, Inc. (the “Arc”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Plan management oversees governance of the Plan. The trustees determine the appropriateness of the Plan’s investment offerings, monitor investment performance, and report to the Plan’s management.

Administration of the Plan

The general administration of the Plan and the responsibility for carrying out its provisions shall be placed on the Arc. The Arc shall be the Plan administrator and has the authority to appoint or remove the trustee. The Arc has engaged the services of an independent profit sharing and pension plan administration firm to assist it with the performance of its duties. Mutual of America Life Insurance Company serves as the trustee of the Plan (the “Trustee”).

Eligibility

Employees are eligible to participate in the Plan for elective deferral purposes on the first day of the first month and seventh month of the Plan year following attainment of twenty-one years of age. Employees are eligible to receive employer contributions on the first day of the first month and seventh month of the Plan year following attainment of twenty-one years of age and completion of one year of service with a minimum of 1,000 hours of service, as defined in the Plan document. In addition, as defined in the Plan document certain employee classes are excluded by the Plan.

Beginning on April 1, 2023, eligible employees who have satisfied the age requirement will become a participant of the Plan for elective deferral purposes immediately.

Contributions

Participants may make a salary deferral election to have their compensation reduced for the year in any amount selected by the participant subject to limitations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rates set initially at 1% of eligible compensation and their contributions are invested in a balanced fund until changed by the participant.

The Arc is required to make employer contributions to the Plan on behalf of each eligible participant who is employed by the Arc on the last day of the Plan year. The Arc's contributions are determined based on 4% of participants' eligible compensation, as defined in the Plan document. Employer contributions for the years ended June 30, 2025 and 2024 were \$348,681 and \$378,172, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution, employer's contribution, and an allocation of Plan's earnings or losses and charged with an allocation of any administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Arc's employer contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and may not borrow more than three times in any 12-month period.

Note terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a range of 4.25% to 9.50%, which commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through biweekly payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of his or her vested account balance if the balance is less than \$1,000. The participant will otherwise have the option to elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or an annuity distribution as defined by the Plan document.

Forfeitures

In the event a participant's employment with the Arc is terminated before becoming fully vested, the non-vested portion of his or her account, if any, will be used to reduce future employer contributions. During the years ended June 30, 2025 and 2024, forfeitures of \$80,178 and \$25,411 were used to reduce employer contributions, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP"), requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is stated at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's accounts and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of June 30, 2025 and 2024. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Arc. Expenses that are paid by the Arc are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan's administrator has reviewed subsequent events and transactions that occurred after June 30, 2025 through the date of the independent auditors' report and the date the financial statements were available to be issued, February 20, 2026. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles. The Plan's administrator has determined that there are no non-recognized subsequent events that require additional disclosure.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024, respectively.

Pooled separate accounts: These accounts invest in securities which generally have publicly quoted prices which are used in determining the net asset value of the pooled separate account. The NAV, as provided by the trustee, is the basis for current transactions and can be redeemed at NAV as of the measurement date. Therefore, these investments have a readily determinable fair value.

While the underlying asset values are quoted prices, the net asset value of a separate account is not publicly quoted. Pooled separate accounts are an accounting entity rather than a legal entity. Separate accounts are credited with the income, gains or losses resulting from the assets allocated to that specific account only. The return on separate accounts is not guaranteed as the value of an interest in a separate account increases or decreases based on the value of the assets held in the separate account. Each plan that invests in the pooled separate accounts obtain units of participation in the pooled account and through those units of participation, share in the gains and losses of all investments in the pooled account. Pooled separate accounts can be redeemed on a daily basis.

4. Mutual of America Life Insurance Company’s General Contract

The Plan offers an investment in the Interest Accumulation Account of Mutual of America Life Insurance Company's General Account (Interest Accumulated Account) totaling \$42,904 and \$41,796 at June 30, 2025 and 2024, respectively. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value. This account is credited with interest at a rate determined by Mutual of America, and it reserves the right to change interest rates applicable to the amounts held in the Interest Accumulation Account at its discretion. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Interest Accumulation Account credits interest at a rate that is declared from time to time, and which may increase or decrease at Mutual of America’s discretion.

Mutual of America guarantees that they will credit interest for the life of the contract to amounts in the Interest Accumulation Account at a rate of at least equal to the greater of (1) any contractual minimum guarantee provided by the contract or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners (NAIC) standard nonforfeiture law. The NAIC minimum rate is determined in accordance with a formula and cannot be less than 1.00% or more than 3.00% in any event. Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year.

The current minimum rate has been set at 1.00% in accordance with this formula for all contracts that do not have a contractual minimum guarantee of 3.00% or 1.50%.

If the contract has a contractual guaranteed minimum rate of 3.00% or 1.50%, the interest rate under the participant’s contract will not go below that amount regardless of the minimum rate that is set for a calendar year. Mutual of America may credit a higher rate of interest to the participant’s contract amounts in the Interest Accumulation Account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Interest compounds daily on the contract amounts in the Interest Accumulated Account to produce an effective annual yield that is equal to the stated interest rate. This guarantee is subject to Mutual of America’s financial strength and claims-paying ability.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

7. Plan Termination

Although it has not expressed any intention to do so, the Arc has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, participants would become 100% vested in their account.

8. Tax Status

The Internal Revenue Service has determined and informed the Arc by letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code "IRC". Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirement of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Party-in-Interest Transactions

Plan investments are managed by Mutual of America. Mutual of America is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
