## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee

**Iten Industries, Inc. 401(k) Profit Sharing Plan and Trust**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed the audits of the financial statements of Iten Industries, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2025 and 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### NOTE 1 - DESCRIPTION OF PLAN

The following description of Iten Industries, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document and the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### *GENERAL*

The Plan is a defined contribution 401(k) retirement plan available to substantially all employees of Iten Industries, Inc. (the "Company"). Employees are eligible to begin employee contributions the first day of the month following the completion of six months of service and are eligible to receive any employer matching and nonelective employer contributions upon completion of one year with 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *CONTRIBUTIONS*

Participants may elect to defer up to ninety-five percent (95%) of their annual eligible compensation subject to Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Additionally, participants who have attained age fifty (50) before the end of the plan year are eligible to make catch-up contributions. Participants are automatically enrolled when they first become eligible at six percent (6%) of their pay. The Plan allows the Company to make discretionary matching and nonelective employer contributions. The Company made discretionary matching contributions equal to one percent (1%) of the first three percent (3%) to six percent (6%) of eligible compensation and two percent (2%) of all contributions six percent (6%) and greater of eligible compensation that a participant contributed to the Plan for 2025 and 2024. The Company made no nonelective employer contributions for 2025 or 2024.

#### *PARTICIPANT INVESTMENT ACCOUNT OPTIONS*

The Plan allows participants to direct varying portions of their contributions and account balances among the different investment options offered by Fidelity Management Trust Company (Fidelity), including a selection of mutual funds.

#### *PARTICIPANT ACCOUNTS*

Each participant's account is credited with the participant's deferral contribution, the Company's discretionary matching contribution, and an allocation of the Company's discretionary nonelective contribution, if any, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested, and charged with an allocation of administrative expenses. Allocations are based upon the participant's eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *VESTING*

Participants are immediately vested in their deferral contributions plus earnings thereon. Participants vest in the Company's discretionary matching and nonelective employer contributions plus earnings thereon based upon years of service. A participant is 100% vested after five years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

#### *NOTES RECEIVABLE FROM PARTICIPANTS*

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. The minimum amount that can be borrowed is \$1,000. The loans are secured by the balance in the participant's account and bear interest at the prevailing interest rate charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest is repaid ratably through payroll deductions. A participant may have no more than one (1) loan outstanding at any time.

#### *PAYMENT OF BENEFITS*

Upon termination of service a participant may elect to receive either a lump sum amount equal to the value of the participants vested interest in his or her account, or annual installments over a period of time, as defined in the plan document. Withdrawals by a participant while employed are limited to those requested upon the attainment of age 59½.

#### *FORFEITED ACCOUNTS*

If an employee terminates before his or her Company discretionary matching and nonelective employer contribution accounts have become fully vested, such portion of the accounts is forfeited. Participant forfeitures will be used to first pay administrative expenses of the Plan then to reduce future Company contributions.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *BASIS OF ACCOUNTING*

The financial statements of the Plan are prepared using the accrual method of accounting.

#### *USE OF ESTIMATES*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### *INVESTMENT VALUATION AND INCOME RECOGNITION*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *CONTRIBUTIONS*

Contributions from Plan participants and the matching discretionary contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *NOTES RECEIVABLE FROM PARTICIPANTS*

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of June 30, 2025 and 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and benefit payment is recorded.

#### *PAYMENT OF BENEFITS*

Benefits are recorded when paid.

#### *ADMINISTRATIVE EXPENSES*

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Certain investment related expenses are included in net appreciation in fair value of investments.

### NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2025 and 2024.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments consists of shares of mutual funds managed or offered by Fidelity. Fidelity is the trustee as defined by the Plan, therefore, these investments and related investment transactions qualify as party-in-interest transactions. Fees paid directly to the trustee totaled \$7,885 and \$3,342 for the years ended June 30, 2025 and 2024, respectively. The Company pays directly any other fees related to the Plan's operations.

#### NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### NOTE 7 - TAX STATUS

The IRS has determined that the Non-Standardized Pre-Approved Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and has informed the trustee of such in a letter dated June 30, 2020. Plan management has adopted the Non-Standardized Pre-Approved Profit Sharing Plan and believes that the Plan and related trust is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### NOTE 8 - RISKS, UNCERTAINTIES AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Approximately 36% and 37% of the Plan's investments were invested in the Fidelity Freedom 2060 Fund Class K and Fidelity Freedom 2030 Fund Class K as of June 30, 2025 and 2024, respectively.

### NOTE 9 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through March 18, 2026, which is the date that the financial statements were available to be issued. No significant matters were identified for disclosure.
