Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of JCK/KB Restaurants 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of JCK/KB Restaurants 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Plan Description

The following description of JCK/KB Restaurants 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective January 1, 2021.

General

The Plan is a defined-contribution plan covering all eligible employees of Team JCK, LLC.; KBR Group, LLC.; JCK SUBS, LLC.; JCK Coffee, LLC.; and JCK Birdz, LLC. (collectively, the Employers). The Plan was established October 1, 2006. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute, on a pre-tax or after-tax (Roth) basis, up to 100 percent of their annual compensation, limited to the amounts provided by the Internal Revenue Code (IRC). Participants are eligible beginning on the first day of the quarter after attaining age 21 and completing one year of service. Participants may also contribute rollover amounts, representing distributions from qualifying plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions.

The Employers may make a discretionary matching and/or profit sharing contribution. The amount of the contribution is determined by the Employers on a discretionary basis. The Employers also make a Safe Harbor matching contribution up to 4 percent of eligible compensation. Participants are eligible for the Employers contributions beginning on the first day of the Plan year quarter after attaining age 21 and completing one year of service. For the year ended December 31, 2024 and 2023, the total Safe Harbor contributions were \$332,018 and \$264,320, respectively. For the years ended December 31, 2024 and 2023, the Employers made total discretionary matching contributions of \$70,234 and \$50,729 and profit sharing contributions of \$-0-. In 2024 and 2023, the discretionary matching contributions percentage was 3 percent.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employers' contributions, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, in accordance with the Plan's provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their accounts into various investment options offered through Empower Retirement Advisory Services. All accounts are fully participant directed.

1. Plan Description, continued

Vesting

Participants are vested immediately in deferral, rollover and Safe Harbor contributions, plus actual earnings thereon. Vesting in discretionary employer matching and profit sharing contributions is based on years of service, defined as one calendar year in which the participant has at least 1,000 hours of service, according to the following schedule:

Payment of Benefits

Upon retirement, death, disability, or termination, participants (or their beneficiaries) may elect to receive part or all of the vested interest in their accounts in a lump sum, substantially equal installments, or partial withdrawals, in accordance with the appropriate provisions of the Internal Revenue Code (IRC) and applicable state laws. In addition, participants may elect to receive withdrawals, at any time, of part or all of the interest in their accounts related to prior rollover contributions. In-service withdrawals are allowed at age 59½ from all accounts that are fully vested.

Hardship Withdrawals

If a participant has an immediate and heavy financial need, hardship withdrawals are allowed under the Plan in an amount not to exceed the lesser of the participant's vested balance or the participant's immediate and severe financial need.

Forfeited Accounts

During the years ended December 31, 2024 and 2023, there were forfeited amounts of \$3,463 and \$10,527, respectively. At December 31, 2024 and 2023, there were unused forfeitures of \$1,084 and \$11,410, respectively. These amounts were available to be used to reduce employer contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The Plan allows only one outstanding loan for each participant at any one time. The loans are secured by the balance in the participant's account and bear interest at rate which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Loan terms range up to five years, unless the loan is used to purchase principal residence, in which case the loan must be repaid within a reasonable period of time determined by the Plan Administrator. Principal and interest on participant loans is paid ratably through bi-weekly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Contributions

Participant and employer contributions are recorded in the year in which they are withheld or the underlying compensation is paid.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit responsive investment contract which is reported at contract value. See Note 5 for a discussion of investments at contract value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Interest and dividend income are recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses and Fees

Certain costs of administering the Plan are absorbed by the Employers and are therefore excluded from these financial statements. Certain other administrative and participant transaction fees are paid from participant accounts. Investment related expenses are included in net change in fair value of investments and a reduction from investment income.

Revenue Sharing

The Plan contains a revenue sharing expense offset arrangement where the Plan is credited a fixed, monthly amount which is used to pay investment advisory expenses. For the years ended December 31, 2024 and 2023, \$40,622 and \$32,658, respectively, was credited to the account and used to pay investment advisory expenses. The balance in the Plan's revenue sharing account as of December 31, 2024 and 2023 was \$852 and \$840, respectively.

Excess Contributions Payable

At December 31, 2024 and 2023, a liability of \$0 and \$8,494, respectively, was recorded for amounts refundable by the Plan to participants for deferral contributions deposited in excess of elected or allowable amounts, including as a result of required compliance testing. This amount is included as excess contributions payable, with a corresponding reduction to participant deferral contributions, on the accompanying financial statements.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employee and employer contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by the Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, have certified that the following information included in the accompanying financial statements and supplemental schedules are complete and accurate as of and for the years ended December 31:

4. Plan Termination

Although the Employers have not expressed any intent to discontinue its contributions and terminate the Plan Agreement, it may do so at any time subject to the provisions set forth in ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employers' discretionary contributions.

5. Investment Contract

The Plan's fixed account investment option is provided through a fixed annuity contract with Empower Annuity Insurance Company of America classified as a general insurance contract. Under the terms of the contract, a crediting rate is established for amounts invested in the fixed account. Participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. The fixed account investment option is considered fully benefit responsive notwithstanding the liquidation value events under the contract that limit the ability of the Plan to transact at contract value. The declared interest rate as of December 31, 2024 and 2023 was 1.41 percent and 1.23 percent, respectively.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

7. Fair Value Measurements, continued

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: The Plan's investments are units of mutual funds held within a group annuity contract. These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end, mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA. Pension Plan Specialists, PC, the sponsor of the prototype plan, received an opinion letter from the IRS dated June 30, 2020 that the adoption agreement and basic Plan document satisfy Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

9. Party-in-Interest Transactions

Certain Plan investments are managed by the custodians of the Plan, and therefore these transactions qualified as party-in-interest transactions. Administrative fees paid to Empower Annuity Insurance Company of America for 2024 and 2023 totaled \$17,422 and \$14,430, respectively. Additionally, investment management fees paid to Empower Advisory Group, LLC, an affiliate of the custodian, totaled \$4,882 and \$2,452 in 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

10. Non-exempt Transactions

For the years ended December 31, 2024 and 2023, participant contributions totaling \$20,138 and \$118, respectively, were not remitted to the Plan within the appropriate time period by the Employers. Additional late contributions from years prior to 2023 were also pending correction as of December 31, 2024 in the amount of \$69,694. These transactions constitute prohibited transactions as defined by ERISA. The Employers are taking the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest and are further implementing procedures to ensure that all future remittances are made within the prescribed time period.

11. Subsequent Events

Management evaluates events and transactions that occur after the statements of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.

Effective April 21, 2025, JCK Ohana, LLC elected to become a participating employer in the Plan.
