INDEPENDENT AUDITOR'S REPORT

To the Participants, Plan Administrator, and Those Charged with Governance
Abbott Industries, Inc. Employee Stock Ownership Plan

Opinion

We have audited the financial statements of Abbott Industries, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of September 30, 2024 and 2023, and the changes in its net assets available for benefits for the year ended September 30, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Investments

As discussed in Note 8, the Plan's investments consist primarily of Abbott Industries, Inc. common stock, for which fair value has been estimated by an independent appraisal in the absence of readily ascertainable fair values, with the assistance of management and approved by the trustee. Because of the inherent uncertainty of the valuation, the estimated value may differ significantly from the value that would have been used had a market for the investment existed, and the difference could be material. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

September 30, 2024 and 2023

Note 1 – Description of the Plan

Abbott Industries, Inc. sponsors the Abbott Industries, Inc. Employee Stock Ownership Plan (the Plan). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Abbott Industries, Inc. (the Company) is the Plan sponsor and Covington Aircraft Engines, Inc. (collectively, the Employer) is a participating employer of the Plan. The Company established the Plan effective as of October 1, 1998. The Plan operates as an employee stock ownership plan established for the benefit of the Employer's employees, except for employees under a collective bargaining agreement unless terms of such agreement specifically provides for participation in the Plan, leased employees, or nonresident aliens who do not receive any earned income from the Employer which constitutes United States source income. The Plan is designed to comply with Section 4975(e)(7) and 401(a) and the regulations thereunder of the Internal Revenue Code of 1986 (the Code), as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Plan Committee appointed by the Company's board of directors. The Plan Committee is comprised of four persons, who also serve as Plan trustees. Principal Financial Group maintains the records of the participant data.

The primary purpose of the Plan is to enable eligible employees of the Employer to share in the growth and prosperity of the Employer and to provide eligible employees with an opportunity to accumulate capital for their retirement needs. All Plan investments are allocated to participants and are nonparticipant directed.

Eligibility

Nonexcluded employees who have reached 19 years of age and have completed 1,000 hours of service are eligible to participate in the Plan. Participants are enrolled in the Plan on the first day of October of the year eligibility requirements are satisfied.

Contributions

Contributions to the Plan are discretionary and are determined each year by the Company's board of directors. Contributions may be made in cash, Company common stock, or both. For the year ended September 30, 2024, the Company contributed \$22,629 in cash to fund distributions, resulting in the reallocation of shares to participants. Employer cash contributions are generally made to fund benefits paid to participants. Unless termination is due to death, disability, or retirement, a participant must have completed 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to be eligible to receive an allocation of Company common stock or Employer contributions. Allocations are based on the proportion of each participant's eligible compensation, as defined in the Plan document, to the total of all eligible participants' compensation. Contributions are subject to certain limitations of the Code. Employee contributions are not permitted.

Participant accounts

Each participant's account is credited as of the last day of the Plan year with an allocation of shares of the Company's common stock, Employer contributions, Plan earnings, and forfeitures of terminated participants' nonvested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in Employer contributions is based upon years of continuous service as follows:

<u>Years of service</u>	<u>Vesting percentage</u>
Less than two years	0%
Two, but less than three	20%
Three, but less than four	40%
Four, but less than five	60%
Five, but less than six	80%
Six years or more	100%

Participants automatically become 100% vested upon normal retirement (attainment of age 65), early retirement (62 and completion of ten years of service in the Plan in which the participant has completed 1,000 hours of service), disability, or death. Participants who terminate for any other reason are entitled to the vested amount of their accounts.

Payment of benefits

Upon retirement, termination, disability, or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount or annual installments equal to the value of the participant's vested interest in his or her account. If the participant's balance is greater than \$10,000, the distribution will be paid in equal annual installments (generally up to three years but may be increased by one year up to five additional years if the participant's account balance exceeds a prescribed dollar amount). If the participant's balance is less than \$10,000, the distribution will be paid in a lump-sum. Upon termination, automatic distributions are required for balances of less than \$1,000. Participants who are 100% vested may take in-service distributions, not to exceed 33% of the participant's account balance, once per Plan year if he or she is an active employee of the Company and has attained age 65.

Distributions are based on the value of a participant's vested account balance at the Plan year-end coinciding with or immediately preceding the date of distribution. Distributions may be paid in cash or Company common stock, or a combination of both. For the year ended September 30, 2024, the payment of distributions consisted of \$22,629 in cash and \$718,602 in Company common stock.

Under the provisions of the Plan, the Company has the option to repurchase shares which have been distributed under the terms of the Plan. For the year ended September 30, 2024, the Company repurchased 526 shares from participants.

Voting rights

Each participant is entitled to exercise voting rights for certain transactions, as described in the Plan document, for those shares allocated to each participant's account and is notified by the trustees prior to the time that such rights are to be exercised. If participants do not timely exercise their right to vote, the trustees will vote such Company common stock. The trustees are required to vote any shares on behalf of the collective best interest of Plan participants and their beneficiaries.

Put option

Under federal income tax regulations, Company common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its common stock distributed to participants for which there is no market. The put price is representative of the fair market value of the common stock. The Company may pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to the participant's account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. The election to diversify is made subsequent to year-end based upon the shares of Company common stock in the participant's account at year-end. Diversification distributions for the year ended September 30, 2024, are shown as benefits paid to participants in the statement of changes in net assets available for benefits.

Forfeitures

Forfeitures shall be reallocated to participants based on the proportion of each participant's eligible compensation to the total of all eligible participants' compensation. The Plan had no unallocated forfeitures as of September 30, 2024 and 2023. For the year ended September 30, 2024, forfeitures in the amount of \$35 were reallocated to participants.

Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan assets.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan's valuation policies utilizing information provided by the appraiser. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are recorded on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Employer contributions are recorded as contributions once approved by the Company's board of directors for the respective Plan year.

Payment of benefits

Benefit payments are recorded when paid. There were no benefits requested before year-end that were not paid.

Subsequent events

The Plan administrator has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of September 30, 2024 and 2023. For the year ended September 30, 2023, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodologies used for assets measured at fair value:

Cash, interest bearing – Valued at cost plus accrued interest.

Company common stock – The fair value of Company common stock held by the Plan is determined based upon an independent appraisal. This appraisal is based upon a combination of the market and income valuation techniques. The appraiser takes into account historical and projected cash flows and net income, EBITDA, and anticipated capital expenditures to estimate the present value of residual free cash flows, while also considering similar growth and profitability measures for public companies in the industry and a discount for lack of marketability to estimate an overall implied enterprise value.

The valuation process involves the trustees' selection of an independent appraiser. Plan and Company management accumulates the data for the appraiser from the compiled financial statements of the Company as well as completing interviews with the appraisal team. The appraiser prepares a preliminary report which Company management reviews in detail and the trustees approve.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Related Party and Party-in-Interest Transactions

The Plan invests primarily in shares of Company common stock. Such transactions qualify as exempt party-in-interest transactions.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain administrative expenses, totaling approximately \$43,000, were paid by the Company on behalf of the Plan for the year ended September 30, 2024. The Company does not expect reimbursement from the Plan for these expenses.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employer contribution portion of their accounts.

Note 7 – Tax Status

The Internal Revenue Service has determined and informed the Company by a favorable determination letter dated October 3, 2017, that the Plan is designed in accordance with applicable sections of the Code. The Plan's determination letter is being relied on by the Plan. Although the Plan has been amended since receiving the determination letter, Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Note 8 – Risks and Uncertainties

The Plan invests primarily in Company common stock, which is exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and other similar techniques. Because of the inherent uncertainty of valuation, those estimated values may differ significantly from the values that would have been used had a ready market for those securities existed, and the differences could materially affect the amounts reported on the statements of net assets available for benefits.
