Independent Auditor's Report

To the Plan Administrator of the Constellation Software (U.S.A.) Inc. Retirement Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Constellation Software (U.S.A.) Inc. Retirement Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Opinion

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets which provide benefits under the plan and certified to by a qualified institution and assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter – Mergers

As further discussed in Note I, the following plans merged with and into the Plan during 2023 and ceased to exist as separate plans: CMS Global Soft, Inc. 401(k) Profit Sharing Plan, Allscripts Retirement Savings Plan (attributable to employees of Altera Digital Health Inc.), Globys Retirement Plan, Capitol Appraisal Group, LLC Employee 401(k) and Profit Sharing Plan, VLN Partners 401(k) Profit Sharing Plan & Trust, IMT Holdings 401(k) Plan, Mid-America Computer Corporation 401(k) Plan, Landrum Professional Employer Services Retirement Savings Plan (attributable to employees of Advanced Computer Technologies, LLC), and TriNet 401(k) Plan (attributable to employees of Chevin Computer Systems Ltd.). In addition, the following participating employers transferred out of the Plan and into the Lumine Group US Holding Inc. 401(k) Plan: Incognito USA Inc., Aleyant Systems, LLC, Velocix Solutions USA Inc., Advantage 360 Software LLC, Transmedia Dynamics, Inc. Neural Technologies., Kansys, Inc., Telarix, Inc. and Lumine Group US Holdco Inc. Our report is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN:

The following description of the Constellation Software (U.S.A.) Inc. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Trapeze Software, Inc. (the “Plan Administrator”) covering substantially all employees of the adopting employers collectively, (the “Employers”) who have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

As further discussed in Note I, the following plans merged with and into the Plan during 2023 and ceased to exist as separate plans: CMS Global Soft, Inc. 401(k) Profit Sharing Plan, Allscripts Retirement Savings Plan (attributable to employees of Altera Digital Health Inc.), Globys Retirement Plan, Capitol Appraisal Group, LLC Employee 401(k) and Profit Sharing Plan, VLN Partners 401(k) Profit Sharing Plan & Trust, IMT Holdings 401(k) Plan, Mid-America Computer Corporation 401(k) Plan, Landrum Professional Employer Services Retirement Savings Plan (attributable to employees of Advanced Computer Technologies, LLC), and TriNet 401(k) Plan (attributable to employees of Chevin Computer Systems Ltd.). In addition, the following plans transferred out of the Plan and into the Lumine Group US Holding Inc. 401(k) Plan: Incognito USA Inc., Aleyant Systems, LLC, Velocix Solutions USA Inc., Advantage 360 Software LLC, Transmedia Dynamics, Inc. Neural Technologies., Kansys, Inc., Telarix, Inc. and Lumine Group US Holdco Inc.

Contributions

Upon meeting eligibility requirements participants may contribute up to 100% of their plan compensation on a pre-tax or after-tax Roth basis, subject to Internal Revenue Code (“IRC”) limitations. Participants who are at least 50 may make an additional “catch up” contribution subject to IRC limitations. Participants may also contribute funds from another qualified plan (“rollover contributions”), subject to certain requirements. All new participants are automatically enrolled at a contribution rate of 3% of plan compensation, unless they make another affirmative election.

Participant contributions may be matched by the Employers at a percentage of the participants’ contributions, as determined by the Plan Administrator. For the plan year ended December 31, 2023, the Plan Administrator matched 50% of each participant’s deferral contributions up to 8% of the participant’s compensation, for a maximum match of 4% of compensation not to exceed \$3,500 per participant. Employees must be employed on the last day of the plan year to be eligible for matching contributions.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in that portion of their account which represents their contributions, matching contributions and the income earned thereon.

Unallocated Assets

During 2023, deposits to the account totaled \$237,334, which is included in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits. Funds in the account may be used to pay qualified plan expenses or be allocated to plan participants. During 2023, \$221,023 was used to pay plan expenses and no unallocated assets were allocated to plan participants. Unallocated assets were \$47,544 and \$30,450 at December 31, 2023 and 2022, respectively.

Distribution of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Distributions under the Plan may be made in lump sums, annuities or partial withdrawals.

A participant may also request a withdrawal of their rollover contributions, upon attainment of age 59 1/2 or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The interest rate is 1% over the Prime Rate on the first business day after the rate changes. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed. No more than two loans may be outstanding at any time. Principal and interest is generally paid ratably through payroll deductions each pay period.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Expenses of the Plan

Substantially all of the administrative expenses and participant transaction fees incurred by the Plan are paid by participants. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Expenses that are paid by the Company are excluded from these financial statements.

Payment of Benefits

Benefits are recorded when paid.

C. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts – Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Redemptions of investments in the common collective trusts are allowed daily for participants; however, the Plan is subject to a twelve-month notification period for the Morely Stable Value Fund. Participants are subject to a fifteen-day notification period for the State Street Equity 500 Index and the State Street International Index. There are no unfunded commitments.

D. INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan has investments in fully benefit-responsive traditional investment contracts as follows:

The Plan holds traditional investment contracts issued by Voya Retirement Insurance and Annuity Company ("Voya") ("the contract issuer"). The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

With traditional investment contracts, the Plan owns only the contract itself. This contract is designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuers but may not be less than 1 percent for the Fixed Account. Such interest rates are reviewed on a quarterly basis for resetting except for the fixed account that is reset annually. The contract does not have a maturity date.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Full surrenders from the Fixed Account can be paid by Voya in equal principal payments, with interest, over a period not to exceed 60 months, or a single payment adjusted by a market value adjustment. The market value adjustment is calculated considering the weighted average of certain Barclays Fixed Income Indices. This contract is not subject to a surrender charge.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would also limit the ability of the Plan to transact at contract value with the participants.

E. PARTIES-IN-INTEREST:

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the trustee are considered party-in-interest transactions.

F. TAX STATUS:

The Plan has adopted the pre-approved profit-sharing plan document of The Angell Pension Group Inc. The pre-approved plan document sponsor received a favorable opinion letter dated June 30, 2020 in which the Internal Revenue Service ("IRS") stated that the form of the pre-approved plan was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. The plan administrator believes the Plan is currently designed and, has been operated in compliance with applicable requirements of the IRC and is, therefore, exempt from federal income taxes under Section 501(a) of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. CERTIFIED INVESTMENTS:

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company, the trustee of the Plan.

H. PLAN TERMINATION:

Although the Plan was established with the intention that it will continue indefinitely, the Company retains the right to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

J. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

K. PROHIBITED TRANSACTIONS:

For the years ended December 31, 2023, 2022, and 2021, the Company inadvertently failed to deposit participant contributions and loan payments within the timeframe stated by the DOL. Such delayed deposits totaled \$93,922, \$697,513, and \$454,938 for the years ended December 31, 2023, 2022, and 2021, respectively. The Company remitted lost earnings for the late contributions and filed Form 5330 to pay applicable excise taxes in 2023 and 2022. The Company is taking corrective actions on the remaining lost earnings in 2024. The lost earnings were made from the Company's assets and not from plan assets.
