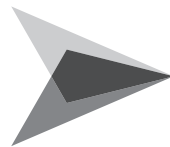

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2025 Financial Statements**

We have performed an audit of the financial statements of Grand View University Employees' Money Purchase Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Grand View University Employees' Money Purchase Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion on the 2025 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2025 Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the 2025 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(c).

## **Basis for Opinion on the 2025 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). ## **Responsibilities of Management for the 2025 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Grand View University Employees' Money Purchase Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Their report also indicated that the form and content of the 2024 supplemental schedule, other than the information in the 2024 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2024 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Notes to Financial Statements

### June 30, 2025 and 2024

---

#### **Note 1 - Description of Plan**

The following description of the Grand View University Employees' Money Purchase Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

*General and eligibility* - The Plan is a defined contribution plan that covers all full-time salaried employees of Grand View University (the University), who have reached age twenty-one, have been employed by the University for at least twelve months, and have completed at least 1,000 hours of service for the University during the twelve-month period beginning on the day the employee commenced work with the University. An hour of service is an hour for which an employee is entitled to payment because of work for the employer or an hour for which the employee is entitled to payment while on vacation, sick leave, or leave of absence. In determining an employee's eligibility to begin participating in the Plan, an employee's service with an institution of higher education within five years of becoming employed by the University shall be included as service with the University, subject to conditions as described in the Plan agreement.

The plan sponsor appointed Administrative Committee is responsible for the oversight of the Plan. The Administrative Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of ERISA.

*Entry Date* - Employees are entered into the Plan for the University's contributions on the first day of each month immediately following or coinciding with the date they satisfy the Plan's eligibility requirements.

*Contributions* - The University makes contributions to the Plan each month on behalf of each participant in an amount equal to a percentage of the participant's monthly compensation. The University contributed 7% of the eligible participants' monthly compensation during the years ended June 30, 2025 and 2024. Employees are not required or permitted to make contributions to the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

*Participant Accounts* - Each participant's account is credited with the University's contributions and an allocation of Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Investment Options* - Upon enrollment in the Plan, a participant may direct employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

*Participant Loans* - The Plan does not permit participant loans.

**Note 1 - Description of Plan (Continued)**

*Vesting* - Vesting in the University's contribution portion plus earnings of their accounts is based on consecutive years of credited services as set forth in the following table:

<u>Years of Service</u>	<u>Percentage</u>
Less than 2 years of service	0%
2 years of service	20%
3 years of service	40%
4 years of service	60%
5 years of service	80%
6 years of service	100%

*Payment of Benefits* - Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or installments as defined in the plan document upon retirement, termination of service, death or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. In-service and hardship distributions are not available to participants.

*Forfeited Accounts* - Upon termination of employment, the non-vested portion of a participant's account is forfeited. The forfeited amounts are placed in a forfeiture account and are used to pay plan administrative expenses or to reduce future Plan Sponsor contributions. At June 30, 2025 and 2024, forfeited non-vested accounts totaled \$77,587 and \$78,520, respectively. During the year ended June 30, 2025, administrative expenses and employer contributions of \$92,432 were paid from forfeited non-vested accounts.

**Note 2 - Summary of Accounting Policies**

*Basis of Accounting* - The financial statements of the Plan are prepared under the accrual basis of accounting.

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Note 2 - Summary of Accounting Policies (Continued)**

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

*Payment of Benefits* - Benefit payments to participants are recorded upon distribution.

*Administrative Expenses* - Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the University. Expenses that are paid by the University are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

*Date of Management Review* - Management has evaluated subsequent events through January 16, 2026, the date which the financial statements were available to be issued.

**Note 3 - Investments and Fair Value Measurements**

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that cannot be directly observed for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**Note 3 - Investments and Fair Value Measurements (Continued)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2025 and 2024.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 - Information Certified by Plan Custodian**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments held at June 30, 2025, and 2024, and net appreciation in fair value of investments, interest and dividends for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal (the trustee of the Plan).

**Note 5 - Contract with Insurance Company**

The Plan has entered into an investment contract with Principal Life Insurance Company (Principal). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The rate is based on a formula established by the contract issuer but may not be less than the guaranteed rate. The rate is reviewed on a quarterly basis and may be reset periodically. The guaranteed investment contract does not permit Principal to terminate the agreement prior to the scheduled maturity date.

**Note 5 - Contract with Insurance Company (Continued)**

The contract meets the criteria for a fully benefit-responsive investment contract and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the issuer and that also would limit the ability of the Plan to transact at contract value with participants.

During the year ended June 30, 2025, the Plan terminated the fully benefit-responsive contract and all assets held in that account were transferred over to other assets within the Plan.

**Note 6 - Contributions Receivable**

Employer contributions to the Plan are mandatory in accordance with the provisions of the Plan document. As of June 30, 2025, and 2024, employer contributions receivable totaled \$82,406 and \$75,000, respectively. These amounts represent mandatory employer contributions earned but not yet remitted to the Plan at year end. Subsequent to year end, the outstanding contributions were remitted to the Plan.

**Note 7 - Plan Termination**

The Plan is a money purchase pension plan that requires the University to make employer contributions in accordance with the provisions of the Plan document. Employer contributions are mandatory and may not be discontinued unless the Plan is amended or terminated in accordance with applicable provisions of the Plan and the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

**Note 7 - Plan Termination (Continued)**

Although the University has not expressed any intent to do so, the University reserves the right to amend or terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100 percent vested in their account balances, and such balances will be allocated and distributed to participants in accordance with the terms of the Plan and applicable ERISA requirements.

**Note 8 - Tax Status**

The Plan has adopted a pre-approved plan document sponsored by Principal Trust Company, which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan's management believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize as tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9 - Risks and Uncertainties**

The investments of the Plan are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the value of such investments, it is reasonably possible that changes in risks in the near term could materially affect investment balances and the amounts reported in the financial statements.

**Note 10 - Related-Party and Party-In-Interest Transactions**

Certain plan investments are shares of mutual funds managed by Principal. Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amount to \$78,217 for the year ended June 30, 2025. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

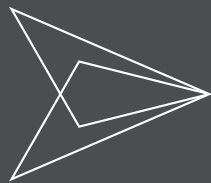
