## Independent Auditors' Report

### The Board of Trustees of Explore Charter Schools of Brooklyn 403(b) Plan

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Explore Charter Schools of Brooklyn 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### 1. Description of Plan

The following description of the Explore Charter Schools of Brooklyn 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Explore Charter Schools of Brooklyn ("School" or "Employer"), except for nonresident aliens. Participating members of the Plan include: Explore Empower Charter School; Explore Excel Charter School; and Explore Exceed Charter School. Prior service at any of these participating members will be credited as service under the Plan. An employee may join the Plan immediately on their date of hire and their salary deferral will be effective on the first day of each month. To be eligible for Employer matching contributions, an employee must be at least 21 years of age and have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Contributions**

Each year, participants may contribute up to 100% of their annual compensation on a pre-tax or Roth basis, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Unless a participant elects otherwise, the Plan provides for automatic enrollment in the amount of 3% of a participant's eligible compensation. These contributions will be made on a pre-tax basis.

The Plan provides a discretionary Employer matching contribution. For the plan year ending June 30, 2025, the Employer made a matching contribution to the Plan in an amount equal to 50% of a participant's elective deferrals up to 5% of the participant's eligible compensation.

#### **Vesting**

Participants are 100% vested in their accounts at all times.

#### **Notes Receivable from Participants**

The Plan offers a loan feature whereby a participant enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of \$50,000 or 50% of their vested account balance (whichever is less). A participant may not have more than one loan outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. The loan must be repaid within a five-year period, unless the loan is used to acquire the principal residence of the borrower, which must be repaid within thirty years from the date of the loan. Principal and interest is paid ratably through payroll deductions.

### 1. Description of Plan (*continued*)

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on a participant's earnings or account balances, as defined in the Plan document.

#### ***Payment of Benefits***

Benefits are paid upon retirement, age 59 ½, death, or other termination of employment. Upon termination of service, a participant's balance will be paid in a lump-sum amount equal to the participant's account balance, installment payments over a specified period of time, or periodic installment payments of a specified dollar amount. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Upon termination if a participant's vested account is \$5,000 or less, the participant will receive the value of his or her account in a single lump-sum distribution.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At June 30, 2025 and 2024, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

All investments of the Plan are stated at fair value except for the group annuity contract, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The group annuity contract is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

### 2. Summary of Significant Accounting Policies *(continued)*

#### ***Investment Valuation and Income Recognition (continued)***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded, when the participant severs employment with the Employer, retires, dies or becomes disabled, and takes a final distribution, or when the participant reaches the earliest date on which an in-service distribution is permitted under the Plan.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of the Plan are paid by the School and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is March 16, 2026.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC, qualified institutions.

### 4. Group Annuity Contract

The Guaranteed Interest Fund (“Fund”) is a general account product offered through a group annuity contract and is fully benefit-responsive. Participant principal and interest are fully guaranteed by the entire general account assets of Empower Annuity Insurance Company, the issuer of the Fund. The Fund credits interest daily to the group contract holder on a portfolio basis. The crediting interest rate will only be adjusted on an annual basis. The annual crediting rate applies to all money deposited in the group contract holder’s Fund account regardless of when it was deposited. Participants may transfer their account balance to any other investment option offered under the Plan at any time with no restrictions or penalties. Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events may include: premature termination of the contract by the Plan, layoffs, Plan termination, bankruptcy, mergers, and early retirement incentives. The plan administrator does not believe there are any events that are probable of occurring that might limit the ability of the Plan to transact at contract value with the issuer or participants.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as of September 30, 2025 as follows: A.M. Best (A+), Standard and Poor’s (AA), Moody’s Investors Service (Aa3), and Fitch Ratings (AA).

### 5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 6. Tax Status

On March 31, 2017, the Internal Revenue Service (“IRS”) issued an opinion letter to the prototype document preparer, Datair Employee Benefit Systems Inc., indicating that the Plan, as then designed, qualifies under Section 403(b) of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax period in progress.

### 7. Party-in-Interest Transactions

Certain investments are managed by an affiliate of the Plan’s trustees, which are Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC. Therefore, these transactions qualify as exempt party in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

### 8. Prohibited Transactions

For the 2024 plan year, the Employer failed to transmit to the Plan certain participants' contributions in the amount of \$7,633 within the period prescribed by Department of Labor regulations. Delays in remitting these amounts to the Plan were due to an administrative oversight. In January 2025, the Employer made the necessary corrections to satisfy both the Department of Labor ("DOL") and IRS guidance for \$7,270 of the contributions. The Employer is in the process of making the necessary corrections to satisfy both the DOL and IRS guidance for \$363 of the contributions.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
