### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Grand Island Clinic, Inc. Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### 1. Plan Description

---

The following brief description of the Grand Island Clinic, Inc. Profit Sharing Plan and Trust (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Grand Island Clinic, Inc. (the Company).

Effective January 1, 2024, employees are eligible to make pre-tax and after-tax Roth salary deferral contributions and receive Company non-elective and discretionary contributions after attaining age 19 (age 21 prior to January 1, 2024) and completing 30 days of consecutive service.

Eligible employees become participants on the first day of the calendar month following the date on which entry requirements are fulfilled.

#### ***Contributions***

Participants may make voluntary salary contributions of not less than 1% up to 100% of their annual eligible compensation, subject to the maximum dollar amounts allowable by law. Employees are automatically enrolled in the Plan with an initial salary deferral of 2% unless the Company is informed otherwise. Effective January 1, 2024, on January 1 of each year, participant's salary deferral rate will be increased by 1% until it reaches a maximum of 10% (5% prior to January 1, 2024) of their eligible salary. At any time, a participant can elect not to contribute or may increase or decrease the deferral rate to any rate allowed under Plan provisions. Participants may also contribute amounts representing distributions from other qualified plans. The Company will make a non-elective contribution of 7% of each participant's eligible compensation. The Company may also make a discretionary contribution. All participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of a) the Company's non-elective and discretionary contributions and b) Plan earnings or losses. The Company's non-elective and discretionary contribution are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are currently maintained in individual member accounts managed by Principal Trust Company (Principal).

### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions credited to participants' accounts is based on years of continuous service. A participant becomes 100% vested in Company contributions at normal retirement age, death, or disability. Effective February 1, 2022, a participant is 25% vested after two years of credited service and vesting increases 25% per year until a participant is 100% vested after five years of credited service. For participants who entered the Plan prior to February 1, 2022, a participant is 20% vested after one year of credited service and vesting increase 20% per year until a participant is 100% vested after five years of credited service.

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. The terms of the notes must not be greater than five years, unless the loan is for the purchase of a primary residence, in which case a longer term, up to fifteen years, may be permitted. Principal, interest, and note fees are paid through payroll deductions.

### *Payment of Benefits*

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive either a lump-sum, ad-hoc, and installment payments equal to the value of the vested funds allocated to the participant's account. Effective January 1, 2024, the Plan will require that distribution payments between \$1,000 and \$7,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. If a participant's balance is less than \$1,000, a distribution will be paid out to the participant unless they elect another payout option. Participants may also receive in-service, as permitted in the Plan document. Benefits are recorded when paid.

### *Deposits with Insurance Company*

The guaranteed investment contract, which is part of the investment contract with Principal, credits interest daily. The average credit interest rate during the year ended December 31, 2024, was 4.75%. The crediting interest rate is reset upon the maturity of the contract. The guaranteed investment contract was not part of the Plan assets for the year ended December 31, 2023.

### *Forfeitures*

Upon a participant's termination of employment before normal retirement or death, the portion of their Company contributions not then vested shall be forfeited. Forfeitures related to Company contributions may be re-allocated to remaining participants, used to reduce employer contributions, or pay Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$554, respectively. The Company used approximately \$113,300 and \$34,400, to reduce Company contributions and pay Plan expenses in 2024 and 2023, respectively.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments, except for fully benefit-responsive contracts, are reported at fair value. Fair value is the price that would be received to buy or sell an investment in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through a guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Participant notes receivable are deemed past due and in default after a scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment. These are treated as a deemed distribution from the Plan.

### *Other*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. All fees and expenses of the custodian which are incurred in connection with the Plan are paid by the Plan and recorded in administrative expenses. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts. Investment related expenses are included in net appreciation in fair value of investments.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 9, 2025, noting no items requiring disclosure.

## 3. Information Certified by Principal

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

*Collective Investment Trusts:* Trusts: Valued at the net asset value (NAV) based on the fair value of its underlying investments. FASB ASC 820, Fair Value Measurement and Disclosures, allows NAV to serve as a practical expedient to estimate fair value as long as certain requirements are met. It is in the Plan’s assessment that these trusts meet those requirements since the participants have the ability to redeem these trusts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment Contract with Principal

The Plan has entered into a group annuity contract issued by Principal Life Insurance Company to Principal as the custodian. Principal maintains the contributions in a guaranteed investment contract.

As the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment account. Contract value, as reported to the Plan by Principal, represents contributions made under the account, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### 6. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### 7. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution to participants of the account balances would be made as soon as practicable after the termination date.

#### 8. Related Party Transactions

---

Certain Plan investments are collective investment trusts and a guaranteed investment contract managed by Principal. Principal is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest.
