A. Effective Date – November 15, 1972.

B. Eligibility - On the January 1 nearest one Year of Service and attainment of age 21.

C. Benefit Service - All Plan Years (Jan. 1-Dec. 31) of 1000 hours are counted.

D. Retirement Dates - Normal - The first of the month following age 65 or the later completion of 5 Years of Plan participation..

### VI. Actuarial Assumptions

A. Funding - The following actuarial assumptions were used in the calculation of the required/allowable contributions:

- 1) Interest Rate – Segment rates of 5.05%/5.05%, 5.31%/5.31% and 5.37%/5.50% were used for the Maximum and Minimum respectively. The Effective Interest rate is 5.29%.
- 2) Mortality Table - The 2025 Applicable Mortality Table (Unisex Basis) was used for the post-retirement period.
- 3) Salary Scale – Salaries are not relevant since there are no active employees.
- 4) Severance Discount – No severance discount was assumed in the calculation of the Target Normal Cost.
- 5) Retirement Age - It was assumed that all employees would retirement on their Normal Retirement Date or immediately if later.
- 6) Asset Valuation - Assets were valued at market value for all purposes.
- 7) Actuarial Cost Method – No longer applicable. Method is now mandated.
