Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Placer Community Action Council, Inc. 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 24, 2025 (Plan Merger) and December 31, 2024, and the related statement of changes in net assets available for benefits for the period from January 1, 2025 through March 24, 2025 (Plan Merger), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 24, 2025 and December 31, 2024, and for the period from January 1, 2025 through March 24, 2025 (Plan Merger), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: Description of Plan

The following description of the Placer Community Action Council, Inc. 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on November 1, 1992, as restated effective January 1, 2018, to provide eligible employees of Placer Community Action Council, Inc. (the Organization) with retirement benefits in accordance with section 403(b) of the Internal Revenue Code (the IRC). All employees who work more than 20 hours per week, over the age 18 are eligible to participate in the Plan after 90 days of service. Eligible employees who have attained 90 days of service are eligible to receive employer contributions.

On March 10, 2025, the Plan sponsor approved a formal resolution to merge the Plan into another defined contribution plan, with an effective date of March 24, 2025. As a result of the merger, the Plan ceased to exist as a separate plan as of the effective date, and all net assets and participant account balances were transferred to the receiving plan, which is the surviving plan. The accompanying financial statements reflect the Plan's assets and transactions through the date of the merger.

Contributions

Employees may elect to make pre-tax contributions and/or Roth contributions in an amount up to 100% of their annual eligible salary, not to exceed limits set by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Each participant may elect to have their individual account invested in any combination of funds held by the Plan custodian.

Effective October 1, 2020, the Plan was amended and all employees upon meeting the eligibility requirements are automatically enrolled in the Plan at a deferral rate of 1%. Unless participants elect otherwise, this deferral rate will automatically escalate each October 1 by 1% up to a maximum of 10% of compensation.

The Organization may make discretionary non-elective contributions. The Organization made non-elective contributions of 3% of employee salaries during the period ending March 24, 2025.

Participant Accounts

Each participant's account is credited with the participant's and employer's contributions and an allocation of net earnings from investments and changes in investment values. Allocations are based on participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account balance.

Note 1: Description of Plan (Continued)

Vesting

Participants are vested immediately in their salary deferral contributions, qualified rollovers or transfers from other retirement plans, and employer matching contributions, plus earnings thereon.

Payment of Benefits

Upon termination of employment due to retirement, death, disability or separation from service, the balances in the participants' accounts will be distributed to the participants or to their beneficiaries in either a lump sum, equal installments in the form of nontransferable annuity, or some combination of the foregoing, at the election of the beneficiary.

Notes Receivable from Participants

Through May 31, 2019, participants could borrow from their vested interest in their account in the form of a loan. Loans bear interest at prevailing market rates and generally must be repaid within fifteen years. Loans to participants are stated at the principal amount outstanding, which approximates fair value. Participants could only have one loan outstanding at any time. Effective June 1, 2019, the Plan was amended to eliminate participant loans.

Administrative Expenses

The Organization, as Plan sponsor, pays certain administrative expenses on behalf of the Plan. Participant's accounts are adjusted for fees pertaining to loan or termination processing, and are charged for expenses incurred by the custodians in the performance of their duties.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value and contract value as certified by the Plan's custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be default, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

In preparing the financial statements in accordance with accounting principles generally accepted in the United States of America, management makes estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Note 3: Information Certified by the Custodians

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at March 24, 2025 and December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2025 through March 24, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company and Equitable Financial Life Insurance Company (the custodians of the Plan).

Note 4: Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 24, 2025 (Plan Merger) and December 31, 2024.

Pooled-separate accounts (PSA): The Plan holds assets that are invested in separate accounts with American United Life Insurance Company and Equitable Financial Life Insurance Company. These investments are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA minus its liabilities, and then divided by the number of units outstanding. The Plan does not own shares in any particular mutual fund, but rather owns accumulation units of the investments held by the trust. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information. There were no unfunded commitments or redemption restrictions as of March 24, 2025 (Plan Merger) and December 31, 2024.

Lifecycle Funds seek high total return over time through a combination of capital appreciation and income. Each of the Nuveen Lifecycle Funds are designed to provide a single diversified portfolio managed with a target retirement date in mind. The target date is the approximate date when investors expect to begin withdrawing money from the Fund. Each portfolio invests in several underlying equity, fixed-income, and direct real estate funds. Over time, the Fund's target allocation will gradually become more conservative, moving to target allocations. The Fund may deviate from these target allocations by up to 10% depending upon current market conditions and outlook.

Note 5: Insurance Company Contracts

Guaranteed Investment Contract with Insurance Company

The Plan entered into a fully benefit-responsive guaranteed investment contract with AXA Equitable Insurance Company (AXA). AXA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the guaranteed investment contract is fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by AXA, represents contributions made under the contract, plus interest earned, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value less an early withdrawal charge, when applicable.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The guaranteed interest contract issuer may not terminate the guaranteed interest contract at any amount less than the contract value. The guaranteed interest contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero. Such interest rates are reviewed on a quarterly basis for resetting.

The guaranteed investment contract totaled \$0 and \$407,714 as of March 24, 2025 (Plan Merger) and December 31, 2024, respectively.

Stable Value Investment Contract

The Plan has a fully benefit-responsive group annuity contract with American United Life Insurance Company (AUL), which is called the AUL Stable Value Account (the stable value contract). AUL maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses. AUL is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan, determined annually.

Stable Value Investment Contract (Continued)

Because the stable value contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with AUL. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. AUL may not terminate the stable value contract at any amount less than the contract value.

The stable value contract totaled \$0 and \$24,496 as of March 24, 2025 (Plan Merger) and December 31, 2024, respectively.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor reserves the right to terminate the Plan at any time. In the event of Plan termination, all accounts become fully vested and non-forfeitable. Plan assets would first be used to pay any expenses properly charged to the Plan. The remainder would then be distributed to participants in a lump sum.

Note 7: Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b).

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period.

Note 8: Party-in-Interest Transactions

Certain Plan investments include shares of registered investment company funds managed by Equitable Financial Life Insurance Company and American United Life Insurance Company. As Equitable Financial Life Insurance Company and American United Life Insurance Company are the custodians of the Plan, transactions with these entities qualify as exempt party-in-interest transactions.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10: Subsequent Events

In preparing the accompanying financial statements, management has considered events that have occurred after March 24, 2025 (Plan Merger), through March 17, 2026, the date these financial statements were available for issuance. Except for the matters discussed above, management was not aware of any subsequent events requiring additional recognition or disclosure.
