Note 1. Description of the Southerland, Inc. Profit-Sharing Plan

General

The following description of the Southerland, Inc. Profit-Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan was a defined contribution Plan sponsored by Southerland, Inc. (Company) for the benefit of its employees who had at least one year of service and are age 21 or older. Related employers who also participated in the Plan include Southerland Transport, LLC and Tualatin Sleep Products, Inc. (Tualatin). The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Access Retirement Services LLC (Access) served as the Plan recordkeeper. Bryan Smith was the trustee of the Plan. Principal Life Insurance Company (Principal Life) served as Plan custodian.

Contributions

The Plan permitted eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover contributions were also permitted. The Company made matching contributions equal to a discretionary percentage to be determined by the Company's board of directors. Company profit-sharing contributions were discretionary as determined by the Company's board of directors. There were no Company matching contributions for the period ended from January 1, 2025, through August 15, 2025, and the year ended December 31, 2024. There were no profit-sharing contributions for the period ended from January 1, 2025, through August 15, 2025, and the year ended December 31, 2024. Contributions were subject to certain limitations.

Participant Investment Account Options

Each participant had the option of directing their contributions into any of the various investment options offered by the Plan and could change the allocation daily.

Participant Accounts

Each participant's account was credited with the participant's contribution, the Company's contribution, and Plan earnings and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions, plus earnings thereon. Vesting in the Company's contribution portion of their accounts, plus earnings thereon, was based on years of continuous service. A participant was fully vested after six years of continuous service.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant could receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

As discussed in Note 8 of the financial statements, on December 13, 2024, the Plan Sponsor was acquired by another entity. As a result, the Company terminated the Plan and liquidated participant accounts on August 15, 2025. In accordance with accounting principles generally accepted in the United States of America, the Plan presented the 2025 and 2024 financial statements under the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's interests in the pooled separate accounts were valued at the net asset value (NAV) of the units of the pooled separate accounts. The NAV was used as a practical expedient to estimate fair value of the pooled separate accounts.

The fair value of guaranteed investment contracts (excluding fully benefit-responsive investment contracts) were calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold, as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2025 and 2024 excess contributions to the applicable participants before March 15, 2025 and 2024, respectively.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Administrative Expenses

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodian

The Plan administrator elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life, a qualified institution and the custodian of the Plan, has certified the following information included in the accompanying financial statements are complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of August 15, 2025 and December 31, 2024.
- Investment income as shown in the statements of changes in net assets available for benefits for the period ended from January 1, 2025, through August 15, 2025, and year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such information to the related information included in the financial statements.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments were units of pooled separate accounts and a guaranteed interest account managed by Principal Life, which was the custodian as defined by the Plan agreement. Therefore, these transactions qualified as party-in-interest transactions. The Plan sponsor paid directly any other fees related to the Plan's operations.

The Plan paid \$10,145 and \$20,988 of recordkeeping and other fees to Principal Life during the period ended from January 1, 2025, through August 15, 2025, and the year ended December 31, 2024, respectively. The Company provided certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quotes prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. Note 7. Investment Contract with Insurance Company

The Plan entered into investment contracts with Principal Life. Principal Life maintained contributions in its general account. The contracts were included in the financial statements at fair value because they were not fully benefit responsive. The contract value of the investment contracts at August 15, 2025 and December 31, 2024, was \$0 and \$488, respectively.

The crediting interest rates were based on an agreed-upon formula with the issuer but cannot be less than zero. The contracts did not provide a minimum rate. The investment contracts could have been subject to withdrawal charges upon contract termination. The crediting interest rates ranged from 0.17%–4.62% for contracts at December 31, 2024. There were no investments held by the Plan at August 15, 2025.

Note 8. Plan Termination

Effective December 13, 2024, the Plan Sponsor was acquired by another entity. As a result, the Company terminated the Plan and liquidated all participant accounts on August 15, 2025. All participants became 100% vested in their benefits at this time.

Due to the liquidation basis being used in presenting the 2025 and 2024 financial statements, accrued net investment loss of \$46,383 in liquidation was recorded as of December 31, 2024. Additionally, the Plan recorded \$4,970 of expenses incurred in liquidation during the year ended December 31, 2024. No liquidation adjustments were recorded as of August 15, 2025, and for the period from January 1, 2025, through August 15, 2025.

Note 9. Tax Status

The Plan operated under a volume submitter Plan document sponsored by Access. The volume submitter document had been filed with the appropriate agency. The Plan had not obtained or requested a determination letter. However, the Plan administrator believed the Plan and related trust were designed and operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified, and the related trust was tax exempt as of the financial statement date.
