We have performed audits of the accompanying financial statements of Unified Door and Hardware Group 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of April 14, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period from January 1, 2025 to April 14, 2025, and the related notes to the financial statements.

In April 2025, the Plan was merged into the Foundation Building Materials 401(k) Profit Sharing Plan and Trust (the "Surviving Plan"). As a result of the merger, all assets of the Plan were transferred to the Surviving Plan as of April 14, 2025 and the Plan ceased to exist as of that date.

Our opinion is not modified with respect to these matters.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. Description of Plan

The following description of the Unified Door and Hardware Group 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all eligible employees of Unified Door and Hardware Group, LLC (the "Employer" or "Company"). An employee became eligible to make deferrals upon attainment of 21 years of age. An employee became eligible for Employer matching and non-elective contributions upon attainment of 21 years of age and completion of six months of service. Employees who were not eligible to participate in the Plan were those employees who were: a resident of Puerto Rico; employees covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan; or a nonresident alien. Other participating Employers in the Plan were Joffe Millwork & Supply, LLC, L.I.F. Industries, Inc. dba Long Island Fireproof Door, Liberty Door Systems, LLC, New Door Installation, LLC, Next Door Distribution, LLC, and Prevent Alarm Company, LLC. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective December 31, 2024, the Plan was amended to freeze participants' and Employer contributions to the Plan. In April 2025, the Plan was merged into the Foundation Building Materials 401(k) Profit Sharing Plan and Trust (the "Surviving Plan"). As a result of the merger, all assets of the Plan were transferred to the Surviving Plan as of April 14, 2025 and the Plan ceased to exist as of that date.

Contributions

Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

For the period from January 1, 2025 to April 14, 2025, no participant or Employer contributions were received by the Plan.

Participant Accounts

Each participant's account was credited with the participant's contributions and allocations of (a) the Employer contributions and (b) Plan earnings (losses). Allocations were based on a participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

A participant was 100% vested in their contributions at all times. A participant vested in Employer matching and non-elective contributions as follows:

Forfeitures

If a participant terminated employment and was less than 100% vested in their Employer matching and non-elective contributions, the participant forfeited the non-vested portion of their account. At April 14, 2025 and December 31, 2024, forfeited non-vested accounts totaled \$0 and \$22,529. These accounts could be used to reduce future Employer contributions or administrative expenses. During 2025, forfeitures of \$2,346 were used to reduce administrative expenses.

Plan Credit Account

The Plan and Fidelity Management Trust Company (the "Trustee") entered into a revenue sharing arrangement whereby a portion of the revenue earned by the Trustee from certain funds was passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Company created the Revenue Credit Account under the Plan. The Revenue Credit Account was an account within the Plan and was used to record-keep the redistribution of Plan-generated fund revenue that exceeded the costs associated with Plan administration. The Revenue Credit Account balance was \$0 and \$186,854 at April 14, 2025 and 2024. During 2025, eligible credits received totaled \$14,165 and reduced administrative expenses on the statement of changes in net assets available for benefits.

Payment of Benefits

Participants were eligible to receive benefit payments when they terminate service or reach age 59 ½. On termination of service, a participant could elect to receive a distribution in the amount equal to the participant's vested interest in their account. Benefit payments were also permitted for death, disability and hardship. In-service withdrawals of vested Employer contributions may be withdrawn from the Plan after 60 months of participation in the Plan, due to prior plan protection.

Notes Receivable from Participants

Participants could borrow from their account balance a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant could only have one loan outstanding at any time. The loans were secured by the balance in the participant's account and bear interest at rates that were commensurate with local prevailing rates as determined by the plan administrator. Loan repayments were made through payroll deductions over a term not to exceed 5 years unless the proceeds of the loan were used to purchase the participant's principal residence, in which case the term could not exceed 10 years. Principal and interest was paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP."), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. The mutual funds and money market fund held by the Plan were open-end funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily NAV and to transact at that price. These funds were deemed to be actively traded. The common/collective trust was valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded as a deemed distribution.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Company and were excluded from these financial statements. Investment related expenses were included in the NAV of the respective funds and, consequently, those expenses were not separately reflected but were a component of net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is March 31, 2026.

5. Common/Collective Trust

Participants had the option to invest in the Galliard Stable Return Fund M (the "Fund"), which is a common/collective trust. The Fund invests all of its assets in Galliard Stable Return Fund Core, a collective trust fund sponsored by SEI Trust Company. SEI Trust Company is the trustee of the Fund.

The net asset value of the Fund is calculated daily, and net investment income and realized and unrealized gains on investments are not distributed but rather reinvested and reflected in the net asset value of the Fund. Units of the Fund are issued and redeemed at the current net asset value. Redemptions by participating plans for large-scale withdrawals or plan termination occur at net asset value following a 12-month notice period.

6. Tax Status

The Internal Revenue Service ("IRS") issued an opinion letter to the prototype plan document preparer, Fidelity Management Research Co., dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by the taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Exempt Party-in-Interest Transactions

Certain Plan investments were managed by Fidelity Management Trust Company. Fidelity Management Trust Company was the trustee as defined by the Plan and, therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants in the statements of net assets available for benefits.
