NOTE 1 DESCRIPTION OF THE PLAN

The following description of Versability Resources, Inc. Fringe Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Versability Resources, Inc. Fringe Benefit Plan was established on September 1, 2009, to provide health and other benefits to eligible employees and covered dependents of Versability Resources, Inc (Employer). Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility and Contributions

The Employer will make a contribution to the Plan on behalf of each covered prevailing wage employee in an amount equal to the applicable fringe rate prescribed by the specific wage determination under the federal Service Contract Act ("SCA") or as otherwise required under the federal contract governing the services performed by the employee. The amount of Employer contributions otherwise payable on an employee's behalf to the Plan for any period will be reduced by the following:

- Any amounts paid by the Employer to another *bona fide* fringe benefit plan on behalf of the employee for such period; and
- Any payments paid to you in lieu of a contribution to the Plan.

In addition to deductibles and copayments, participants contribute specified amounts based on applicable premiums for their respective benefit elections. Payroll deductions for voluntary benefits are established annually based on cost projections and will be deducted on a pre-tax or post-tax basis. The premium rates for payroll deductions are set by the Company and are announced each year during the open enrollment period.

The Employer makes contributions to the Plan as needed to fund benefits in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Employer on a pay-as-you-go basis.

Benefits

The Plan provides health benefits (medical, dental, vision and prescription drugs), life insurance, accidental death and dismemberment benefits, short-term disability, accident, hospital indemnity, critical illness, and prepaid legal to eligible members and to their beneficiaries and dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Insured Benefits

The Plan fully insures all benefits offered. The Employer purchases annual insurance contracts for these insured benefits. Premiums are paid to the insurance company from the assets of the VEBA trust. Effective September 1, 2026, the Plan moved from a fully-insured arrangement to a self-insured arrangement for medical and prescription drugs.

Premium Reserve Account (PRA)

A separate fringe benefit premium reserve account is maintained for each participant. Each participant's premium reserve account is credited with contributions made on the participant's behalf, and any additional contributions made by the employee. Premium reserve accounts are reduced for premiums paid by the Plan, or for payments made on behalf of the employee for other bona fide fringe benefit plans maintained by the Plan Sponsor.

Upon termination of employment, PRA balances are credited on the participant's behalf to the Employer's qualified retirement plan, or to another bona fide fringe benefit plan. The PRA liability included in the statements of benefit obligations, represents surplus contributions that will be used to pay premiums by the Plan or fund other bona fide fringe benefit plans.

Retirement Benefit

Participants can opt out of certain plan benefits and have their surplus PRA fringe contributions allocated to a retirement account as described above. After subtracting premiums and fees incurred by the Plan, the Plan forwards the surplus PRA fringe contributions to the Employer's retirement plan, or to another benefit plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through March 18, 2026, the date the financial statements were available to be issued.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Concentration of Credit Risk

The Plan maintains its cash balances with financial institutions that are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per institution. At times, the Company's cash balances may exceed the insured limits.

Contributions and Contributions Receivable

Contributions from participants are recorded in the year in which the employee contributions are withheld from compensation. Employer contributions for SCA fringe benefits are based on SCA hours worked by the employee and are recorded in the year in which the employee has earned the fringe benefit. All other Employer contributions are funded as needed to pay benefits.

Employer Funding Advance

Employer Funding Advance represents the portion of the fringe benefit allocated to retirement that has been remitted directly to the retirement plan provider by the Plan sponsor. In addition, any amounts received from the Employer in advance of SCA fringe benefits being earned by the employees and are recorded as deferred revenue as received and recorded as contribution income in the month the fringe benefits are earned.

Payment of Benefits

Premiums paid by either the Employer or the VEBA trust are recorded as premium payments in the accompanying the statements of changes in net assets available for benefits.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of recordkeeping fees to the third-party administrator of the SCA trust. These expenses are reported on the statements of changes in net assets available for benefits as Administrative Expenses, Certain other administrative expenses, such as professional fees, are either paid by the Plan or by the Employer on behalf of the Plan.

NOTE 3 TAX STATUS

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2025 - 2023 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

NOTE 3 TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Employer or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are managed by the third-party administrator of the Plan. As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
