INDEPENDENT AUDITORS' REPORT

To Plan Management
Donegal Construction Corporation Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Donegal Construction Corporation Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period from January 1, 2025 through June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Donegal Construction Corporation Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Pursuant to the merger statement, all assets and liabilities of the Donegal Construction Corporation Profit Sharing Plan were transferred to the SurfaceCycle, Inc. 401(k) Plan. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, and to determine the benefits due or which may become due to such participants.

June 30, 2025 and December 31, 2024

Note 1 – Description of the Plan:

The following description of the Donegal Construction Corporation Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Donegal Construction Corporation (the “Company”) who have two years of service and are age twenty-one or older and are not covered by a collective bargaining agreement. The Company includes the following related employers: Donegal Construction Corporation, Donegal Transport, Inc. and Delta Contracting, Inc. As of September 8, 2023, the Company was purchased by an entity named SurfaceCycle. As a result of the sale, the accounts of all participants were transferred into the SurfaceCycle, Inc. 401(k) Plan (an existing plan controlled by the acquiring company) as of June 4, 2025. See Note 11. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan’s Trustees control and manage the operation and administration of the Plan.

Participant Accounts

Each participant’s account is credited with their allocation of the Company’s contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations of earnings and expenses are credited to a participant’s account by applying the formula $A / B \times C$, where A is the market value of the participant’s account at the beginning of the Plan Year, or other valuation period; B is the market value of the total accounts of all participants at the beginning of the Plan Year, or other valuation period, and C is the net gain or loss on the investments for the Plan Year, or other valuation period as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participant accounts are valued annually as specified in the Plan.

Vesting

Participants become 100% vested in their account balance once they reach two years of service. Prior to completing two years of service participants are 0% vested in their account balances.

Payment of Benefits

On termination of services due to death, disability, or normal retirement, a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account as of the most recent valuation. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

No vested benefit under this Plan shall be subject to forfeiture for cause.

Note 2 – Summary of Significant Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The Plan's investment custodians receive fiduciary fees for investment advisory services. These expenses are paid directly from the Plan's assets and are included in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

Reclassifications

The Plan has reclassified amounts reported in prior year financial statements where necessary.

Note 3 – Certified Investments

Certain information related to investments disclosed in the accompanying financial statements related to certain investments held at December 31, 2024 and net appreciation in fair value of investments, interest and dividends for the period from January 1, 2025 through June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Commercial Bank and Trust of PA, custodian of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 4 – Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2- Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 4 – Fair Value Measurements (Continued):

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value: There have been no changes in the methodologies used at June 30, 2025 and December 31, 2024.

Money Market Funds: These investments are public investment vehicles using \$1 for the net asset value (NAV).

Note 7 – Related-Party and Party in Interest Transactions:

Findley provides third party participant recordkeeping, including non-discrimination testing, Federal Form 5500 preparation and other administrative services to the Plan. Their fees for these services are absorbed by the Company and are excluded from these financial statements.

On November 2, 2020, USI Insurance Services, a national insurance brokerage and consulting firm headquartered in Valhalla, New York with over 8,000 industry professionals in over 200 offices, acquired Findley. Effective May 23, 2025, the Plan has merged into the SurfaceCycle, Inc. 401(k) Plan, another qualified plan sponsored by the Company, and thus identified as a party-in-interest.

Note 8– Plan Termination:

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 9- Income Tax Status:

This IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by the IRS and various taxing jurisdictions however, there are currently no audits for any tax period in progress.

Note 10 – Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market inflation, international and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11 – Plan Merger

Effective May 23, 2025, the Donegal Construction Corporation Profit Sharing Plan was merged with and into the SurfaceCycle, Inc. 401(k) Plan. In connection with the merger, assets totaling \$5,381,049 were transferred from the Plan on June 4, 2025. The transfer of assets was approved by the Company, and the merger was designed to comply with Section 414(I) of the Internal Revenue Code, ensuring that participants' benefits immediately after the merger were equal to or greater than the benefits they were entitled to immediately before the merger. Following the merger, participants of the Donegal Construction Corporation Profit Sharing Plan became eligible to participate in the SurfaceCycle, Inc. 401(k) Plan, and their accounts were fully vested to the extent that they were vested under the Donegal Construction Corporation Profit Sharing Plan.

Note 12 – Subsequent Events:

The Plan has evaluated subsequent events for potential recognition and disclosure through April 2, 2026 the date the financial statements were available to be issued.
