To whom it may concern,

This letter is in response to your notification of not receiving form 5500 for the plan year ending in 2023.

C.T.I. Underground, LLC closed business in April 2022 due to the death of the owner James R. Unger. At that time, I did not know there were any funds in a 401K plan through ADP Retirement Co. ADP was our payroll company. From what I was told, the plan had been terminated in 2009. The plan administrator was the company bookkeeper that had not worked for the company for about 10 years. The funds sat dormant until I was notified in 2022 by ADP about the account. With ADP's help, I went through the process to become the plan administrator and filed 5500 forms for 2017, 2018, 2019, 2020 and 2021 as directed. I spoke with ADP again in September of 2022 to confirm the account was closed and that nothing else needed to be done.

No monies, profits or expenses passed through C.T.I. Underground for this account in 2022. Or, for many previous years.
