NOTE 1: DESCRIPTION OF PLAN

The following description of the Preferred Primary Care Physicians, Inc. Group Medical Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General – The Plan provides health benefits to eligible employees of Preferred Primary Care Physicians, Inc. (the “Company”) All regular full-time employees of the Company working at least thirty (30) hours per week are eligible for coverage. Physicians and executives are eligible upon date of hire. All other employees are eligible for coverage only after they have been employed by the Employer for sixty (60) days. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

Benefits – The Plan provides medical benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Stop Loss Coverage – The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-insured Benefits – The Plan’s medical benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan’s trust, or the general assets of the Company. Despite the Plan’s utilization of third-party claim’s processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The ASO retained the rights to the pharmacy benefit manager rebates.

Contributions – In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Company makes contributions to the Plan as needed to fund claims in excess of participants’ contributions. Any deficiency of the Plan’s net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Plan Administration – Highmark, Inc. and VERIS Benefits Consortium, LLC serve as third-party providers. Highmark is a third-party claims processor under an administrative services only (ASO) arrangement. VERIS provides brokerage and administrative services including claims payment, eligibility determination and preparation of plan documents.

NOTE 2: SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting and Income Recognition – The Plan prepares its financial statements using the accrual method of accounting.

Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits – Premiums paid by either the Company or the trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statement of net assets available for benefits.

Stop Loss – Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling approximately \$245,000 have been netted with claims paid in the accompanying statement of changes in net assets.

Subsequent Events – The Plan has evaluated subsequent events through March 31, 2026, the date the financial statements became available to be issued, and determined that no adjustments or additional disclosures are necessary.

NOTE 3: Claims Incurred but not Reported

Plan obligations at June 30 for claims incurred but not reported (IBNR) are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment. At 6/30/25, the IBNR is \$410,869. There are no other benefit obligations for the Plan other than the IBNR.

NOTE 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted

quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan's cash account is level 1.

NOTE 5: TAX STATUS

The Plan had previously received a favorable determination letter from the IRS. The Plan has been amended since receiving the determination letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan's management evaluates tax positions taken by the Plan and recognizes any tax asset or liability if management believes the positions to be uncertain and more likely than not would not be sustained upon examination by the IRS. No provision for income taxes has been included in the Plan's financial statements.

The IRS may examine the Plan's annual informational returns for each of the years in the three-year period ended June 30, 2025. Should the Plan be subject to any penalties or interest assessed by the IRS, the Plan may account for such expenses as an administrative expense or may seek reimbursement from the Company.

NOTE 5: PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 6: RISKS AND UNCERTAINTIES

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

NOTE 7: RELATED PARTY TRANSACTIONS

As described in Note 1, the Plan has arrangements with service providers. These transactions are party in interest transaction under ERISA.
