Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of GreenPower Motor 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the GreenPower Motor 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement or the summary plan description for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering the employees of GreenPower Motor, Inc., Lion Truck Body, Inc., GreenPower Manufacturing WV, Inc. (collectively the Company), except for those employees whose compensation and conditions of employment are established by the terms of a collective bargaining agreement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees of the Company are eligible to participate in the Plan upon completing two consecutive months of service as long as they have reached the age of 21. Entry to the Plan is automatic on the first of the month, following eligibility.

Plan Administration: The Plan is administered by the President of the Company (Plan Administrator). The custodian for the Plan is Ascensus Trust Company (Custodian).

Contributions: The Plan includes an automatic enrollment feature under which eligible employees who do not make an affirmative salary deferral election are automatically enrolled at a deferral rate of 6% of eligible compensation, as defined by the Plan. Unless the participant elects otherwise, the automatic deferral rate is increased by 1 percentage point on the first day of each plan year until the deferral rate reaches 10%, after which no further automatic increases occur. Participants may also make contributions to the Plan on an after-tax basis by designating deferrals as Roth deferrals. The maximum employee contribution permitted by the Internal Revenue Service (IRS) was \$23,000 and \$22,500 for calendar years 2024 and 2023, respectively. In addition, participants who had attained age 50 by year end could also make catch-up contributions of \$7,500 for calendar years 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Employer contributions include required, discretionary contributions and profit sharing contributions. The discretionary and profit sharing contributions are determined by the Company. For the years ended December 31, 2024 and 2023, no profit sharing contributions were made. For the years ended December 31, 2024 and 2023, the Company applied a discretionary matching formula of 100% of employee 401(k) deferrals, up to 2% of eligible compensation, subject to an annual employer matching limit of \$2,000 per participant, for each employee participating in the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and rollovers, any employer contributions and plan earnings which are allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Vesting: For the salary deferral contributions, participants are immediately vested in their contributions plus actual earnings. Employer matching contributions will vest based on the years of service with 0% vested with less than one year of service, and building to 100% vested after two or more years of service. Profit sharing contributions will vest based on the years of service with 0% vested with less than one year of service, and building to 100% vested after four or more years of service.

Forfeitures: Forfeitures of non-vested plan assets are used to reduce any employer contributions. There were \$0 in forfeitures used for the year ended December 31, 2024 and there were \$688 and \$668 forfeitures available as of December 31, 2024 and 2023, respectively.

In-service Distributions: Participants who have reached age 59 1/2 may make a cash withdrawal at any time.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or they may take timely periodic distributions, not exceeding \$5,000. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the vested amount of a participant's account does not exceed \$5,000, the vested balance can be distributed to an IRA without prior approval of the participant.

Hardship Distributions: Participants may request a distribution based on financial hardship subject to the provisions of the Plan.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of plan assets and liabilities and changes therein at the date of the financial statements. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contribution Receivable: Employee and employer contributions are recorded as receivables in the period in which they are due to the Plan, pursuant to the provisions of the plan document. Contributions related to participant payrolls or employer matching/profit-sharing for services rendered and withheld from payroll before year-end, and are remitted to the Plan subsequent to year-end within the time frame prescribed by applicable law, are accrued as contributions receivable and included in net assets available for benefits. Contributions receivable are stated at the amount expected to be collected and are written off when deemed uncollectible. Management believes no allowance for doubtful accounts is necessary at December 31, 2024 and 2023.

The Plan presents in the statement of changes in net assets the net appreciation in the fair value of its investments, which consists of realized gains or losses and the unrealized appreciation or depreciation on those investments.

Risks and Uncertainties: The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan invests in various investment options that invest in securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currency, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Payment of Benefits: Benefits are recorded when paid.

Plan Expenses: The Company pays all plan expenses except investment fees, which are allocated among participants, and loan and distribution fees.

Participant Contributions: Participant contributions are recorded and remitted to the custodian each bi-weekly payroll period and recorded in the year withheld from a participant's check.

NOTE 3. SUBSEQUENT EVENTS

The Plan Administrator has evaluated its December 31, 2024 and 2023 financial statements for subsequent events through April 6, 2026, the date the financial statements were available for issuance.

During 2025, the Company undertook a restructuring that resulted in involuntary termination of over 20 percent of employees participating in the Plan. Management has concluded that these actions constituted a partial plan termination under Internal Revenue Code Section 411(d)(3), and all affected participants were fully vested in employer contributions credited to their accounts as of the partial termination date.

No additional material subsequent events were identified for recognition or disclosure.

NOTE 4. FAIR VALUE MEASUREMENTS

The fair value measurement topic of the Financial Accounting Standards Board Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1. Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2. Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the net asset value of shares held by the Plan at year end.
-
- *Common Collective Trust Funds*: Valued at the net asset value (NAV) of the units held by the Plan at year end, which is based on the fair value of the underlying investments using information reported by the investment advisor. The NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust fund, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The common collective trust funds held by the Plan include a stable value fund whose underlying investments are composed primarily of fully benefit responsive investment contracts. The remaining funds invest primarily in target retirement date funds that invest in other investment pools or investment products which are affiliated mutual funds, collective investment trusts, private vehicles/funds or other pooled investment vehicles advised by the advisors or sub-advisors.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Participants may borrow from their fund accounts 50% of their non-forfeitable account balance not to exceed \$50,000, in aggregate of all outstanding loans. Loans shall not exceed 5 years unless it is used to acquire a dwelling unit which will be used as the principal residence of the Participant. The loans are secured by the balance in the participant's account and bear a reasonable interest rate. The notes are re-paid ratably through payroll deductions over the term of the loan.

However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan qualifies and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authority. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 8. PARTICIPANT WITHDRAWALS AND DISTRIBUTIONS

At December 31, 2024 and 2023, there were no unpaid distributions included in accounts of participants who have elected to withdraw from participation in the Plan.

NOTE 9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

NOTE 10. PARTY-IN-INTEREST TRANSACTIONS

As of December 31, 2024 and 2023, certain plan investments are invested in shares of mutual funds managed by Vanguard, the Plan's Trustee. Therefore, these transactions qualify as party-in-interest transactions under ERISA.

NOTE 11. PROHIBITED TRANSACTIONS

Delinquent Contributions: During the year ended December 31, 2024, the Company inadvertently failed to deposit \$1,519 of participant deferrals timely. The Department of Labor considers late deposits to be prohibited transactions. The participant deferrals have been corrected as of the date of these financial statements and the Plan Sponsor will correct the lost earnings in the Plan year ended December 31, 2026.
