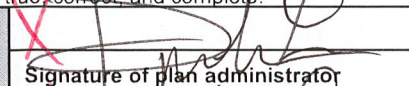

Schedule SB, Line 25 – Change in Method

Effective August 31, 2025, the plan was amended to terminate. As part of this, the plan's valuation date was changed from December 31 to August 31.

In accordance with Treasury regulations section 1.430(a)–1(b)(5)(i), if a plan's termination date occurs during a plan year but before the last day of a plan year, then, for purposes of section 430 of the Internal Revenue Code, the plan is treated as having a short plan year that ends on the termination date. However, for all other purposes, the plan year remains unchanged.

In addition, Treasury regulations section 1.430(a)–1(b)(5)(ii), requires that if a plan's termination date is before the date that would otherwise have been the valuation date for a plan year, then the valuation date for the plan year must be changed so that it falls within the short plan year pursuant to Treasury regulations section 1.430(g)–1(b)(2)(i). Treasury regulations section 1.430(g)–1(b)(2)(iv) provides automatic approval of these types of changes in the valuation date.
