In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Ohio Associated Enterprises, LLC 401(k) Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Ohio Associated Enterprises, LLC 401(k) Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Ohio Associated Enterprises, LLC 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

A. PLAN DESCRIPTION

The following description of the Ohio Associated Enterprises, LLC (the “Company” or “Plan Sponsor”) 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan with an Internal Revenue Code (“IRC”) Section 401(k) arrangement which allows Plan participants to defer current taxation on a portion of their salaries by electing a percentage of their salary to be contributed to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

During 2022, the Plan Sponsor was acquired by Qnnect, Inc. On November 30, 2022, Plan assets were liquidated and merged into the Qnnect 401(k) Plan. The KeyBank EB MaGIC Fund includes a 12-month put provision in which assets may be held for up to 12 months. These assets are expected to transfer to the Qnnect Retirement Plan in October 2023.

Eligibility - Through July 31, 2021, the Plan covered substantially all employees of the Company who had six months of service and were aged twenty-one or older. Effective August 1, 2021, the Plan was amended to change eligibility requirements to three months of service and age requirements to age 18 or older. A year of service is a twelve consecutive month period during which an employee has at least 1,000 hours of service, as defined in the Plan document and adoption agreement.

Contributions - Participants may voluntarily contribute a minimum of 1% to a maximum of 100%, limited to the IRC 402(g) limit of their compensation on a pre-tax or post-tax (“Roth”) basis. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. The Company, however, may be required to limit contributions of certain employees to comply with the IRC.

The Company may, at its option, match a portion of participants’ voluntary contributions. Effective August 1, 2021, the Plan Sponsor elected to match 100% of each dollar of contributions up to 4% of participants’ compensation.

Effective January 1, 2022, the Plan became a safe harbor 401(k) plan. The Plan requires the Plan Sponsor to make a safe-harbor matching contribution of 100% of each dollar of contributions up to 4% of participants’ compensation. Matching contributions totaled \$185,544 for 2022.

The Company may make additional nonelective contributions to the Plan. All eligible employees, as defined, may receive these nonelective contributions but must be actively employed as of December 31. The Company did not make any nonelective contributions during the year ended December 31, 2022.

The Plan also permits rollover contributions from other qualified retirement plans.

Participant Accounts - Each participant’s account is credited with the participant’s contributions, employer matching and nonelective contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants may direct their contributions to any or all of the various investment funds provided. Participants may change their allocation of contributions or transfer money between investment options any time during the year.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service, and a participant became 100% vested after five years of credited service through July 31, 2021. Effective August 1, 2021, the Plan was amended so that participants are immediately vested in matching contributions plus actual earnings thereon.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their account balance. The note is secured by the balance in the participant's account and bears interest at a rate determined at the time the loan is taken based on prime plus 1% (7.50% and 4.25% as of December 31, 2022 and 2021, respectively). Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - A participant or his or her beneficiary, upon termination, death, or retirement, receives his or her vested interest in his or her participant account in the form of a single lump sum payment or in periodic installments. Additionally, the Plan has provisions for an active participant to make withdrawals from his or her account, subject to limitations and restrictions.

Forfeited Accounts - Unvested amounts forfeited by terminated participants may be used by the Plan for the payment of Plan expenses, reduction of employer matching contributions, or reduction of discretionary profit sharing contributions. Forfeitures used to reduce employer matching contributions totaled \$2,876 for the year ended December 31, 2022. There were no accumulated and unused forfeitures as of December 31, 2022. Accumulated and unused forfeitures totaled \$3,298 for the year ended December 31, 2021.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and trustee. See Note D for discussion of fair value instruments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Administrative expenses, including third party administrative expenses and investment management fees, are paid by the Company. Fees attributable to loans, distributions, and deferred payouts are paid by the participants. Investment related expenses are included in net depreciation of fair value of investments. See Note E.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default upon a distributable event, the participant loan balance is reduced, and a benefit payment is recorded.

C. INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected to restrict the scope of the auditor's examination with regard to statements or information prepared and certified by Capital Bank and Trust Company ("Capital Bank"), the trustee of the Plan.

Capital Bank has certified as to the completeness and accuracy of the investments it holds and changes in net assets arising from said investment activity as of December 31, 2022 and 2021, and for the year ended December 31, 2022.

Capital Bank has certified as to the accuracy of the schedule of assets (held at end of year) as of December 31, 2022.

D. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The levels of the fair value hierarchy under Financial Accounting Standards Board guidance in these financial statements are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (“SEC”). These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust (“CCT”): The fair value of the CCT is estimated based on the NAV derived from the fair value of the underlying investments. NAV is used as a practical expedient. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by the trustee of the Plan. The transactions involving these investments are allowable party in interest transactions under ERISA.

Capital Bank provides certain administrative services to the Plan pursuant to a Service Agreement ("SA") between the Company and Capital Bank. Capital Bank receives revenue from certain mutual fund service providers for services Capital Bank provides to the funds. The revenue is reported at the gross amount received on the Statement of Changes in Net Assets.

If the revenue received by Capital Bank from such mutual fund service providers exceeds the amount owed under the SA, Capital Bank remits the excess to the Plan's trust on a quarterly basis. During 2022, there were \$23,445 in excess amounts. Such amounts may be applied to pay Plan administrative expenses, allocated to the accounts of the participants, or applied as revenue sharing income. In 2022, the excess amounts were applied against expenses. The Plan or Plan Sponsor may make a payment to Capital Bank for administrative expenses not covered by revenue sharing. Expenses paid to Capital Bank during 2022 totaled \$1,063

F. PLAN DECONVERSION AND MERGER INTO QUALIFIED PLAN

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant would have a non-forfeitable right to his or her total account balance as of the date of termination.

On April 12, 2022, the Plan Sponsor was acquired by Qnnect, Inc., the Plan Sponsor of the Qnnect 401(k) Plan. Effective November 30, 2022, the Plan was deconverted and merged into the Qnnect 401(k) Plan and assets totaling \$4,391,121 were transferred. Due to a discretionary put provision, the remaining \$412,735 of assets held in the KeyBank EB MaGIC Fund are expected to be transferred in October 2023. Effective with the deconversion and merger, the participants' rights and vesting remained intact in the Qnnect 401(k) Plan.

In accordance with generally accepted accounting principles in the United States of America, the Plan has recorded a payable and corresponding transfer of Plan assets for the amounts remaining in the KeyBank EB MaGIC Fund totaling \$412,735.

G. FEDERAL INCOME TAX STATUS

The plan has adopted a pre-approved plan sponsored by Capital Bank, which received an IRS Opinion Letter dated June 30, 2020. The Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. PLAN AMENDMENTS

Effective January 1, 2022, the Plan was restated as a safe harbor 401(k) plan.

Effective August 1, 2021, the Plan was restated to amend eligibility requirements from 21 years of age to 18 years of age and to change service requirements from 6 months of service to 3 months of service. As part of this restatement, the Plan implemented a discretionary matching contribution of 100% of the first 4% of each participant's compensation. As part of this restatement, the Plan was amended to comply with the Bipartisan Budget Act of 2018, Cycle 3 restatement, and other legislative and regulatory changes.

The Plan adopted the distribution provision of the Coronavirus Aid, Relief, and Economic Security ("CARES") Act that was signed into law on March 27, 2020. A CARES Act distribution allows the Plan's participants to take a COVID-19 related distribution up to \$100,000 from the Plan beginning on or after January 1, 2020 and before December 31, 2020. There were no distributions repaid during the year ended December 31, 2022.

I. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

J. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2023, the date that the Plan's annual financial statements were available to be issued.
