Dear sir or madam,

I am writing to formally request an abatement of the penalty assessed for the late filing of Form 5500-[SF] for the 2025 plan year.

We believe this penalty should be abated based on reasonable cause. We exercised ordinary business care and prudence in our tax obligations, yet were unable to file by the prescribed deadline due to the final 5500 being located in a different online platform and we were not aware of the change until it was too late. Further, we were also not aware that we had to file another 5500 the year after we officially terminated our 401k. In addition, we were in the process of building a new salon location and moving to the new salon location in 2025 and our work computers were down for a few months during the move and throughout the permit approval process. The notification of change in platform was not received until it was too late.

Specifically, the platform we were always required to use was www.mykplan.com/sponsor and it changed to <https://rgf.fisglobal.com/5500Client/Site/Security/Login?ReturnUrl=%2F5500Client%2FHome.aspx%3Fid%3DEC8GaVgkHueAZKPjsLUzaQe1q2ua88le1q2ua88l>.

Our salon location changed from 5015 WESTHEIMER RD STE 2290 to 5135 W ALABAMA ST #5280, HOUSTON, TX, 77056

Upon discovering this error, we immediately contacted our ADP 401k contact and they advised us that the platform had changed and that we were supposed to file another 5500 even though it was a year after we terminated our 401k. This will never happen again, as we have terminated our 401k due to financial hardship and will not be participating again.
