I am writing this letter to explain that when Deanna and the ADP rep created our 401(k) account, we were not made aware that we would be required to sign and authorize the Form 5500 report annually. This requirement was not disclosed to us at the time. I was informed by multiple sources that ADP would handle the authorization of the report each year, allowing us to be hands-free regarding our 401(k) plan administration. The plan was set up by Deanna & ADP rep in 2021, and since then, we have not signed off on the Form 5500 because we were unaware of this responsibility. Is there any way to have these files amended given that we were not informed about this obligation?

We would please request that these four years be filed correctly and that the filings be corrected and submitted for each year. If there is still a fee associated with these filings, we request that we are not required to pay it, that it be forgiven due to our lack of knowledge when creating this 401(k) account.
