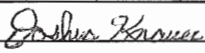

- Maximum benefit is \$18,000 per month
- Maximum percent of salary is 100%

Normal form of benefit: A benefit payable for the life of the participant.

Early retirement age: Attainment of age 57.

Early retirement benefit: 1% per year reduction from age 65 starting at age 57.

Accrued benefit:

The normal retirement benefit described on the previous page calculated based on salary and/or service on the calculation date, and payable on the normal retirement date.

Termination benefit:

Upon termination for any reason other than death, disability or retirement a participant shall be entitled to a portion of the actuarial equivalent of his accrued benefit in accordance with the following vesting schedule:

Disability benefit:

Equal to accrued benefit payable immediately.
