Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Howard L. Zimmerman, Architects & Engineers, D.P.C. 401k Plan, (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 26, 2025 and December 31, 2024 (liquidation basis), and the related statement of changes in net assets available for benefits (liquidation basis) for the period ended June 26, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 26, 2025 and December 31, 2024 (liquidation basis), and for the period ended June 26, 2025 (liquidation basis), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Board of Trustees voted to terminate the Plan effective October 24, 2024, and management determined that liquidation is imminent. The assets of the Plan have been distributed. As a result of the termination, the Plan changed its basis of accounting from modified cash basis to liquidation basis used in presenting the 2025 and 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the basis of accounting described in Note 2, and for determining that the basis of accounting are an acceptable basis for the preparation of financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. 1. Description of Plan

The following description of Howard L. Zimmerman, Architects & Engineers, D.P.C. 401k Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan covering all eligible employees of Howard L. Zimmerman, Architects & Engineers, D.P.C. (the “Company” or “Employer”) as defined in the Plan document. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Trustees were responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

On October 25, 2024, the Company elected to terminate the Plan as a result of their merger with Milrose Consultants, LLC. Participants had the option to start contributing to the Milrose Consultants, LLC 401(k) Profit Sharing Plan in November 2024. As a result of the election to terminate the Plan, all employees became 100% vested in their accounts, all contributions ceased and funds have been distributed.

Eligibility

Eligible employees were eligible to participate in the Plan upon having attained the age of twenty-one and completion of three months of service. Employees were eligible to receive Employer contributions upon completion of one year of service.

Participant Accounts

Each participant’s account was credited with the participant’s contribution and an allocation of the Company’s contribution and Plan earnings (losses) thereon. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant was entitled to was the benefit that could be provided from the participant’s vested account. All investments were participant directed.

1. Description of the Plan (*continued*)

Vesting

Upon termination of the Plan participants became 100% vested.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant could elect to receive a lump sum amount equal to the value of the participant's vested account. For termination of service for other reasons, a participant could receive the value of the vested account as a lump sum distribution or have the payment made as a "direct rollover" to an Individual Retirement Account or to another employer's qualified plan.

Benefits could be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Notes Receivable from Participants

Participants could borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest was paid ratably through payroll deductions. The loan must be repaid within a period not to exceed 5 years from the date the participant receives the loan, unless the loan is for the purchase of the participant's principal residence, in which case the loan must be repaid within the period permitted by commercial lenders for similar loans, however, not to exceed 30 years.

2. Summary of Significant Accounting Policies

Basis of Accounting

As a result of the Plan termination (see Note 1), the Plan changed its basis of accounting for the 2025 and 2024 Plan years from the modified cash basis to the liquidation basis. During the year ended December 31, 2024, the Plan was required to accrue and separately present activity for future periods related to (1) any contributions by the Employer, (2) any costs that it expects to incur, (3) any interest and dividends it expects to earn during liquidation; and (4) any adjustments to investments through the liquidation period.

Use of Estimates

The preparation of financial statements required the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan followed U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. The mutual funds were valued at the daily closing price as reported by the funds. These funds held by the Plan are open-end funds and are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price and are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest and dividends are recorded when received.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance. If a participant ceases to make loan repayments and the participant loan is deemed to be in default, the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in the NAV of the respective funds and, consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

5. Tax Status

The Plan's prototype plan document preparer has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

Participants who were active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants in the statement of net assets available for benefits.

Certain employees of the Employer perform administrative services related to the Plan; the Employer pays the salaries of these individuals and no costs are charged to the Plan.

7. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
