Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the 401(a) Profit-Sharing Plan for Employees of Edwin Gould Services for Children and Families (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For



information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of the Plan

The following description of the 401(a) Profit-Sharing Plan for Employees of Edwin Gould Services for Children and Families (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a noncontributory defined contribution pension plan sponsored by Edwin Gould Services for Children and Families (the Plan Sponsor or Employer) for the benefit of its employees. Employees are eligible to enter the Plan upon reaching age 21 and completing one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Mutual of America Life Insurance Company (Mutual of America) serves as the custodian of the Plan.

Effective July 1, 2018, Edwin Gould Services for Children and Families entered into an affiliation agreement with Rising Ground, Inc. As part of this agreement, all employees became employees of Rising Ground, Inc., effective January 1, 2019 and became eligible to participate in the 401(k) Profit-Sharing Plan for Employees of Rising Ground, Inc. As such, this Plan was frozen on January 1, 2019. These financials do not include any activity of the 401(k) Profit-Sharing Plan for Employees of Rising Ground, Inc.

Contributions

In any year that contributions are made, the contributions are determined by the Plan Sponsor each year and are allocated to each eligible participant's account in the ratio that the compensation of each eligible participant bears to the total compensation of all eligible participants. The Plan does not permit participant contributions but permits rollover contributions into the Plan. The Plan Sponsor made no contributions to the Plan for the years ended June 30, 2023 and 2022.

Participant Investment Account Options

Upon enrollment in the Plan, a participant may direct Employer contributions to the available choice of investments offered by the Plan.

Participant Accounts

Each participant's account is credited with the Employer's discretionary contribution, if any, and the Plan earnings, and charged with an allocation of administrative expenses. Allocations of administrative expenses are made to each participant in the same ratio as each participant's compensation bears to the total of such compensation of all participants. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Plan Sponsor's contribution portion of participants' accounts plus earnings thereon is based on years of continuous service. The Plan uses a graded vesting schedule, as follows:

Years of Service	Vesting (%)
Less than 2	-
2 but less than 3	20
3 but less than 4	40
4 but less than 5	60
5 but less than 6	80
6 or more	100

Benefits are also fully vested upon the participant reaching the age of 55, death, or total and permanent disability.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Partial withdrawals or installments are only permitted for participants or beneficiaries who must receive required minimum distributions under the Internal Revenue Code (IRC) Section 401(a)(9).

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the investment contract that is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 6 for a discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of the Plan are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - This level consists of inputs to the valuation methodology, which include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

Notes to Financial Statements

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Pooled Separate Accounts

These assets are valued at their accumulation unit value (AUV) as a practical expedient to measuring fair value. The AUV is determined daily based on the net asset value (NAV) of shares of the underlying fund and the separate account charges (i.e., the daily asset charge). The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments. The underlying funds of the pooled separate accounts are generally invested in registered investment companies whose investment strategies are to seek capital appreciation through investment in common and preferred stocks and debt securities.

The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice period and no unfunded commitments.

The Plan's investments in the pooled separate accounts are \$720,063 and \$677,904 at June 30, 2023 and 2022, respectively. The pooled separate accounts are measured at fair value using the NAV per unit (or its equivalent) practical expedient and are not categorized in the fair value hierarchy.

The Plan had no financial assets that were measured at fair value on a non-recurring basis during the years ended June 30, 2023 and 2022.

There have been no changes in the methodology used at June 30, 2023 and 2022.

5. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of June 30, 2023 and 2022, and net appreciation (depreciation) in fair value of investments and interest income for the years ended June 30, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, a qualified institution.

6. Guaranteed Interest Contract

The Plan has a fully benefit-responsive guaranteed interest contract with Mutual of America as of June 30, 2023 and 2022. Mutual of America's general account is a group annuity product issued by Mutual of America. Because the guaranteed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed annuity contract. Payment obligations and the fulfillment of any guarantees specified in the group annuity contract are insurance claims supported by the full faith and credit of Mutual of America. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

7. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Mutual of America. Mutual of America is the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. The Plan Sponsor provides certain administrative services at no cost to the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, each participant will become 100% vested and the net assets of the Plan will be distributed, as prescribed by ERISA.

9. Tax Status

The Plan relies on the opinion letter, dated November 30, 2020, for the Mutual of America Life Insurance Company Non-Standardized Pre-Approved Profit Sharing/Money Purchase/Cash or Deferred Arrangement (CODA) Plan, in which the Internal Revenue Service (IRS) stated that the form of the prototype plan is acceptable under the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is also subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Subsequent Events

The Plan has evaluated subsequent events through November 24, 2025, the date the financial statements were available to be issued.
