In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated April 14, 2025 indicated that in their opinion (a) the amounts and disclosures in the 2024 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2024 supplemental schedule, other than the information in the 2024 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2024 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of Plan

The following description of 403(b) Thrift Plan for Employees of Person Centered Care Services, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established on July 1, 2015 and restated on December 1, 2023, is a defined contribution plan covering substantially all employees of Person Centered Care Services, Inc. (the "Sponsor"). Employees are eligible upon hire to begin making elective deferrals to the Plan except for non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan Administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. The custodian and recordkeeper of the Plan is Voya Retirement Insurance and Annuity Company ("Voya," the "Recordkeeper," or the "Custodian").

Contributions

Each year, participants may contribute up to 100% of eligible annual compensation, as defined in the Plan, provided that such contributions do not exceed the limitations under the Internal Revenue Code (the "Code") of \$23,500 for 2025 and \$23,000 for 2024, plus a maximum of \$7,500 in catch-up contributions for participants who have attained age 50 before the end of the Plan year. For 2025, there is an additional "super" catch-up contribution for participants between the ages 60 through 63 to contribute an additional \$3,750 for a total of \$11,250 of catch-up contributions. Contributions may be made as a pre-tax deferral. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Highly compensated employees are subject to additional limits set forth in the Code. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Sponsor may make discretionary employer contributions. Eligibility requirements for participants to receive discretionary employer contributions include a minimum of one service year with the Plan Sponsor. Employer contributions are invested as directed by the participant. In 2025, the Sponsor made employer contributions of \$13,000.

Participant Accounts

Each participant's account is credited with the participant's contributions and rollover contributions, as well as allocations of the Sponsor's contributions and the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's employer contributions portion of their accounts is based on years of continuous service as follows:

Year 1	20%
Year 2	40%
Year 3	60%

Year 5 or more years	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. The loans are secured by the balance in the participant's account and bear a reasonable rate, as defined by the Plan. The interest rate is determined as of the date of origination and is fixed for the loan term. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the funds are used to acquire a principal residence, in which case the maximum repayment period is ten years.

Payment of Benefits

On termination of service due to death, disability, or retirement, if a participant has vested benefits in excess of \$5,000, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or have the account balance converted to an annuity. If the vested benefit is less than \$5,000, the participant or their beneficiaries will receive a single lump-sum distribution. The Plan also allows certain withdrawals at age 59½ and hardship withdrawals.

Forfeitures

At June 30, 2025 and 2024, forfeited nonvested accounts totaled \$690 and \$717, respectively. These accounts will be used to pay Plan expenses or reduce future employer contributions. There were no forfeitures used during the year ended June 30, 2025.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 and 2024. Delinquent notes receivable from participants are reclassified as distributions once the participant misses payments and is not cured by the last business day of the quarter in which it becomes delinquent or once a loan is not paid off by the last business day of the month following the month of its maturity date. Participant loan interest rates are set at the prime rate plus 1%. The interest rates on loans outstanding at June 30, 2025 ranged from 8.50% to 9.50%.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

Note 3 - Information Certified By Custodian

The following information, including investments and notes receivable from participants at June 30, 2025 and 2024, and investment income and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

Note 4 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at June 30, 2025.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact that price. The mutual funds held by the Plan are deemed to be actively traded.

Voya Fixed Account: The Plan invests in a guaranteed income fund with Voya Retirement Insurance and Annuity Company, which maintains the contributions in a general account. Because certain events limit the ability of the Plan to transact at contract value with the issuer, the Plan has determined that the guaranteed income fund is not fully benefit-responsive. Therefore, it is presented on the face of the statements of net assets available for benefits at fair value.

Note 4 - Fair Value Measurement (cont'd.)

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value at June 30, 2025 and 2024. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. For the year ended June 30, 2025, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 5 - Voya Fixed Account

The Plan has an investment with Voya. Under the terms of the contract, Voya maintains contributions in a general account. The Plan has determined that the investment does not meet the requirements necessary to be considered fully benefit-responsive for the year ended June 30, 2025, and thus it is presented on the statements of net assets available for benefits at fair value. The account is credited with earnings on the underlying investments and is charged for Plan withdrawals and administrative expenses. The crediting interest rate is based on a formula agreed upon with the issuer and is reviewed periodically for resetting. Withdrawals from the investment other than the payment of benefits to participants may be subject to a market value adjustment and a surrender charge.

Note 6 - Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of funds managed by Voya, the custodian and recordkeeper of the Plan. Therefore, the transactions related to these investments qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 8 - Tax Status

The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71 and the draft Listing of Required Modifications issued April 4, 2009. The Plan is required to operate in conformity with the code to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan administrator and Sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that at June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after June 30, 2025 through April 15, 2026, which is the date that the financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure.
