#### **NOTE 1 - DESCRIPTION OF THE PLAN**

##### ***General and Eligibility***

The following description of Zivaro, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document and Summary Plan Description, which are available from the Plan Administrator, for a more complete description of the Plan's provisions.

The Plan was a defined contribution plan sponsored by Zivaro, Inc. (the "Company") for the benefit of substantially all of its employees who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan's recordkeeper was ADP Retirement Services ("ADP"). Effective January 1, 2025, the responsibility of the Plan's trustee and custodian transitioned from Reliance Trust Company ("Reliance") to ADP Retirement Trust Services ("ADP Trust").

##### ***Company Acquisition and Plan Freeze***

On December 19, 2024, the Company was acquired by Trace3, LLC (the "Acquirer"). As part of the post-acquisition integration, the Plan was frozen effective March 31, 2025 (the "Freeze Date"). After the Freeze Date:

- No further contributions, whether participant or employer, were permitted; however, participant account balances continued to accrue earnings or losses based on investment performance.
- No employees of the Company, whether existing as of the Freeze Date or hired thereafter, became newly eligible to participate in the Plan. Instead, such employees became eligible to participate in the Acquirer's plan.

##### ***Plan Merger***

Effective June 30, 2025 (the "Merger Date"), the Plan was merged into the Trace3 401(k) Plan (the "Receiving Plan"), an existing defined contribution plan sponsored by the Acquirer. Under the terms of the merger, \$20,101,550, representing all assets of the Plan, were transferred to the Receiving Plan as of the Merger Date. All participant account balances were reallocated to designated participant accounts in their names within the Receiving Plan on a participant-by-participant basis. All participants of the Plan became participants of the Receiving Plan and are subject to the terms of that plan.

Following the transfer on the Merger Date, the Plan held no remaining assets and no further contributions, distributions, or administrative activities occurred. Accordingly, the Plan ceased to exist as a separate reporting entity on the Merger Date.

The merger did not constitute a plan termination under ERISA. As such, the Plan continued to apply the accrual basis of accounting through the Merger Date; the liquidation basis of accounting was not applicable.

Prior to the Plan merger, provisions of the Plan were as follows:

##### ***Contributions***

The Plan permitted eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 90% of eligible compensation. Employee rollover, catch-up and Roth contributions were also permitted. Effective February 1, 2023, the Plan was amended to allow the Company to make discretionary employer matching contributions and employer nonelective contributions as determined by the Company's Board of Directors. For the period from January 1, 2025 through June 30, 2025, the discretionary matching contributions were 100% of the first 3% of eligible compensation deferred

by participants. For the period from January 1, 2025 through June 30, 2025, and the year ended December 31, 2024, there were no employer nonelective contributions.

Contributions were subject to certain Internal Revenue Service limitations.

***Participant Investment Account Options***

Participants could select one or more predetermined investment options for the investing of contributions and allocated earnings. Contributions were deposited directly into the participant-elected investment vehicles.

***Participant Accounts***

Each participant's account was credited with the participant's contribution, discretionary employer matching contributions and employer nonelective contributions, if any, and plan earnings and was charged with an allocation of investment and administrative expenses. An individual participant's account was charged a fee for certain participant-initiated transactions, such as the ongoing maintenance of notes receivable from participants and utilization of the self-directed brokerage option. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

***Vesting***

Participants were immediately vested in their voluntary contributions, plus earnings thereon. Vesting in the discretionary employer matching contribution and employer nonelective contribution portions of their accounts plus earnings thereon was based on years of continuous service. For discretionary employer matching contributions, a participant was fully vested after three years of continuous service, and participants were credited 33.33% for each year of service. For employer nonelective contributions, a participant was fully vested after five years of continuous service, and participants were credited 20% for each year of service. The non-vested balance was forfeited upon termination of service.

***Payment of Benefits***

Upon termination of service, a participant could elect to receive a lump-sum amount equal to the value of his or her account, installment payments, or could choose to maintain the account in the Plan and continue to share in investment earnings. Effective January 1, 2024, for terminated participants with an account balance equal to or less than \$7,000, the participant's benefit was paid a lump-sum amount equal to the value of his or her account.

***Forfeited Accounts***

Forfeitures could be used for the payment of any plan expenses or used to reduce discretionary matching contributions. For the period from January 1, 2025 through June 30, 2025, \$8,512 of forfeitures were used to reduce employer contributions, and no forfeitures were used to pay administrative expenses. As of June 30, 2025 and December 31, 2024, there was no balance in the forfeitures account.

***Notes Receivable from Participants***

The Plan document included provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan was \$1,000. The maximum amount of a participant's loans was determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans were covered by demand notes and were repayable over a period not to exceed five years through payroll withholdings unless the participant was paying the loan in full. Interest on the loans

was based on local prevailing rates as determined by the Plan Administrator. Participants were permitted to have two outstanding loans at one time.

***Administrative Expenses***

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP required management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in the fair value of investments included the Plan's realized gains and losses on investments bought and sold during the period, and the unrealized gains and losses on those investments held at the end of the period.

***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.

***Payment of Benefits***

Benefit payments to participants were recorded upon distribution.

**NOTE 3 - CERTIFICATION OF PLAN TRUSTEE AND CUSTODIAN**

The Company elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's trustees and custodians provided certification of the information detailed below for the periods covered by these financial statements.

Effective January 1, 2025, custodial responsibility for the Plan's assets transitioned to ADP Trust, who served as the trustee and custodian for the period January 1, 2025 through the Merger Date of June 30, 2025. ADP Trust certified that the net investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period from January 1, 2025 through June 30, 2025, included in the accompanying financial statements, was complete and accurate to the best of their knowledge and belief.

For the year ended December 31, 2024, Reliance served as the Plan's trustee and custodian. Reliance certified that the investments and notes receivable from participants as shown in the statement of net assets available for benefits as of December 31, 2024, included in the accompanying financial statements, was complete and accurate to the best of their knowledge and belief.

**NOTE 4 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

During the period from January 1, 2025 through June 30, 2025 and the year ended December 31, 2024, notes receivable from participants qualify as party-in-interest transactions.

**NOTE 5 - FAIR VALUE MEASUREMENT**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1 - Quoted prices in active markets for identical assets or liabilities.

Level 2 - Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 or Level 2 inputs as components of the overall fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Fund:* The Principal Self-Directed Brokerage Account includes common stocks and exchange traded funds (ETF), which are valued at the closing price reported on the active market on which the individual securities are traded.

*Collective Trust:* Valued at NAV per unit as determined by the collective trusts as of the valuation date. The unit values are determined based upon the fair value of the underlying assets. The NAV, as provided by the Trustee, was used as practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. There was no redemption period for this investment and there are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All assets were transferred to the Receiving Plan on the Merger Date; therefore, no investments remained in the Plan as of June 30, 2025, and there are no investments presented within a fair value hierarchy table as of June 30, 2025. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024:

## NOTE 6 - TAX STATUS

The Plan operated under a non-standardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by ADP, Inc., dated October 6, 2020. Although the Plan has been amended since the date of the letter, the Plan Administrator believes that the Plan was designed and operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2025, and December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities prior to the Merger Date. Investment securities are exposed to a number of risks, including interest rate, market, and credit risks. These risks transferred to the participants under the Receiving Plan on the Merger Date, when all investments and participant balances were transferred to that plan. As of June 30, 2025, the Plan held no investments and therefore was no longer subject to investment-related risks.
