We have performed audits of the financial statements of TMS Environmental, LLC (formerly Kent Materials 401(k)) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2021 and 2020, and the related statement of changes in net assets available for benefits for the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). 1. Description of Plan

The following brief description of TMS Environmental, LLC (formerly Kent Materials 401(k)) (the Plan) provides only general information. Participants should refer to the comprehensive Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of TMS Environmental, LLC (formerly Kent Materials) (the Company or Plan Sponsor). Employees become eligible to participate at age 18 and after completion of two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

On January 29, 2021, TMS Environmental, LLC acquired the business and assets of Kent & Smith Holdings, LLC, located in Port Allen, Louisiana. In connection with the acquisition, TMS Environmental, LLC assumed the Plan. On March 26, 2021, the Plan name was changed to TMS Environmental, LLC.

Custodian and Administration of the Plan

The Plan's custodian and recordkeeper is John Hancock Life Insurance Company (U.S.A.) (John Hancock).

Contributions

Each year, participants may contribute up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may make discretionary employer matching contributions as a percentage of eligible compensation deferred by participants. The Company matched 100% of participant contributions up to 3% of eligible compensation for the year ended December 31, 2021.

The Company may also make discretionary profit-sharing contributions. Participants must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to be eligible. No discretionary profit-sharing contributions were made for the year ended December 31, 2021.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on

participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon. Participants become 100% vested in the Company's profit-sharing contributions and employer matching contributions after three years of credited service.

Forfeitures

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures may be used to restore forfeitures, reduce Company contributions, or to pay reasonable Plan expenses. At December 31, 2021 and 2020, forfeited non-vested accounts totaled \$1,448. During the year ended December 31, 2021, no forfeitures were used.

Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's vested account and bear an interest rate which is determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions as determined by the pay frequency of the participants.

Payment of Benefits

Distributions from the Plan's assets are made upon the participant's death, disability, retirement, termination of service, or other circumstances as described in the Plan Document. Distributions may be made in the form of a lump sum payment, or an alternate form of payment as permitted in the Plan Document. Participants who have attained age 59½ and who have not separated from service may obtain distributions of their account balances. Upon termination of service, a participant whose vested account balance does not exceed \$5,000 valued at the time of distribution will receive an immediate lump-sum payment. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Profit-sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of December 31, 2021 and 2020, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodology used at December 31, 2021 and 2020. The following is a description of the valuation methodology used for assets measured at fair value.

Pooled Separate Accounts (PSAs) - PSAs are valued at the net asset value of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by John Hancock, is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs

provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments.

The preceding methods may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) Depending on the proximity to its target date, the funds will seek to achieve the following objectives to varying degrees: growth, income, and conservation of capital. The funds will increasingly emphasize income and conservation of capital by investing a greater portion of its assets in bond, equity-income, and balanced funds as it approaches and passes its target date. In this way, the funds seek to balance total return and stability over time.

(b) This category includes funds seeking growth of capital. The 500 Index Fund seeks to achieve the approximate aggregate total return of a broad U.S. domestic equity market index.

(c) This category includes funds seeking to provide capital appreciation.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by John Hancock. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. Fees paid by the Plan to John Hancock for administrative services totaled \$5,305 for the year ended December 31, 2021. Investment advisory fees paid to John Hancock and Wilshire totaled \$3,614 for the year ended December 31, 2021. Other Plan administrative costs paid by the Plan to Dyatech, LLC totaled \$660 for the year ended December 31, 2021. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

7. Tax Status

The Plan adopted a pre-approved plan document sponsored by Dyatech, LLC. Dyatech, LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Subsequent Events

The Plan has evaluated subsequent events through the date that the financial statements were available to be issued, March 19, 2026, and determined that the following events require disclosure:

On September 27, 2022, Plan management adopted a formal resolution to begin the process of freezing participation in the Plan. Effective January 1, 2023, the Plan became frozen and ceased all employer and employee contributions. All accounts in the Plan as of January 1, 2023 became fully vested.

9. Delinquent Participant Contributions

During the Plan year ended December 31, 2021, participant contributions and loan repayments totaling \$64,809 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The employer is in the process of correcting these transactions. The related lost earnings are expected to be remitted to the Plan during 2026.
