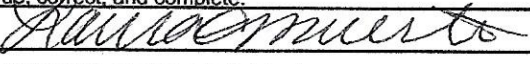

Therefore, Section 4.01 IRS Revenue Procedure 2017-56 provides automatic approval for this change in funding method for a takeover plan.
