Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Northfield Retirement Communities, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

December 31, 2022 and 2021

1. Plan Description

The following description of the Northfield Retirement Communities, Inc Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Northfield Retirement Communities, Inc. (the Home) and was established January 1, 2003.

Employees are eligible to make pre-tax and after-tax Roth salary reduction contributions after attaining age 21 and completing 90 days of service. Eligible employees become participants on the first day of the month following the date on which entry requirements were fulfilled. Participants are also eligible to participate in the discretionary matching contributions and qualified non-elective contributions after attaining age 21 and completing one year of service with 1,000 hours of service.

Contributions

Participants may make salary reduction contributions up to 100% of their annual eligible compensation, subject to the maximum dollar amount allowable by law. Employees are automatically enrolled in the Plan with an initial salary deferral of 3% unless the Plan is informed otherwise. At any time, a participant may elect not to contribute or may increase or decrease their deferral rate. Participants may also contribute amounts representing distributions from other qualified plans. All participants who are eligible to make deferral contributions who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Home may also make a discretionary matching contributions and qualified non-elective contributions. During the years ended December 31, 2022 and 2021, the Home elected to make discretionary matching contributions equal to 100% of elective deferrals up to 3% of eligible compensation, plus 50% of elective deferrals which are over 3% but are not over 5% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of (a) the Home's discretionary matching contributions and qualified non-elective contributions, and (b) Plan earnings or losses. The Home's discretionary matching contributions are allocated among participants based upon each eligible participant's elected salary deferral. The Home's qualified non-elective contributions are based on eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Principal Trust Company (Principal).

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Home's discretionary matching and qualified non-elective contributions credited to participants' accounts is based on years of continuous service. A participant is 20% vested after one year of service and vesting increases 20% per year until a participant is 100% vested after five years of service for discretionary matching and qualified non-elective contributions.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may receive lump sum or installment payments equal to the value of the vested funds allocated to the participant's account. Participants may also receive in-service and hardship distributions, as permitted in the Plan document. The Plan requires mandatory distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event that the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability or death, the portion of the Home's contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay Plan expenses, reduce the Home's contributions, or be re-allocated to remaining participants. As of December 31, 2022 and 2021, the Plan held \$0 in forfeited, non-vested accounts. The Home used a total of \$5,870 and \$9,235 to reduce the Home's contributions and pay Plan expenses in 2022 and 2021, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investment is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on the fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Other

The Home pays a portion of the administrative expenses incurred. Expenses that are absorbed by the Home are excluded from the financial statements. Other expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. The Plan and the Home have considered such events or transactions through November 30, 2023, noting no items requiring disclosure.

3. Information Certified by Principal

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Collective Investment Trusts: Valued at the net asset value (NAV) of units of the collective trusts as a practical expedient. The NAV, as provided by the trustee, is used to estimate fair value. The NAV is based on the fair value of underlying investments held by the trust less its liabilities. Participant transactions (purchases and sales) may occur daily.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

6. Plan Termination

Although it has not expressed any intent to do so, the Home has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distributions to participants of the account balances would be made as soon as practicable after the termination date.

7. Related Party Transactions

The Plan investments are collective investment trusts managed by Principal. Principal is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.
