Plan Sponsor SPM Qualified 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2021 Financial Statements

We have performed an audit of the financial statements of SPM Qualified 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (an ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

December 31, 2021

1. Description of the Plan

The following description of SPM Qualified 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees (except union employees) of Southeastern Psychiatric Management, Inc. (the Company) upon employment. Participants are eligible to receive Company contributions after completion of one year of service (1,000 hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 31, 2020, Empower Retirement, LLC (Empower Retirement) acquired the Massachusetts Mutual Life Insurance Company's (Mass Mutual) retirement business. Pursuant to this transaction, business written and administered by Mass Mutual is reinsured by Great-West Life & Annuity Insurance Company (Great-West). The certified information, described in Note 3, was certified for the entire 2021 Plan year by Great-West.

Contributions

Each year, participants may contribute up to 100 percent of pretax and after-tax annual compensation (as defined in the Plan document), not to exceed federal limits, as an elective deferral, Roth or voluntary after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes matching contributions equal to 25 percent of the first six percent of compensation that a participant contributes to the Plan. The Company may also make discretionary matching and profit sharing contributions each year. For the year ended December 31, 2021, no discretionary matching or profit sharing contributions were made to the Plan. Contributions are subject to certain limitations. Participants direct the investment of their contributions and Company matching and discretionary matching and profit sharing contributions into various investment options offered by the Plan.

SPM Qualified 401(k) Plan

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contributions, Plan earnings or losses from that account's investment activities, and an allocation of the Company discretionary profit sharing contribution. Allocations are based on the participant's compensation ratio to that of total compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

Benefit Payments

On termination of service due to separation, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or the purchase of an annuity. Hardship and other in-service withdrawals and Roth in-plan rollovers may be obtained as defined in the Plan document.

Forfeitures

Forfeitures of terminated, nonvested participant accounts may be used to pay administrative expenses or reduce future Company contributions.

Administrative Expenses

Certain administrative expenses, including accounting and custodial fees, have been paid by the Company. Participant initiated distribution fees are charged directly to the participant's account. All other administrative expenses and investment transaction fees (including investment-related expenses which are included in net appreciation in fair value of investments) are paid by the Plan.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Company determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan provides for investments in various investment securities that in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Basis of Presentation

The financial statements of the Plan have been prepared on the accrual basis of accounting.

3. Investment Information

All investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2021, and net appreciation in fair value of mutual funds and dividends for the year then ended, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Great-West, on behalf of Talcott Resolution Life Insurance Company, the custodian.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Mutual funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Company adopted a prototype non-standardized 401(k) profit sharing plan with a cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on March 31, 2014, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

6. Subsequent Events

Management of the Company evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through March 5, 2026, which is the date the financial statements were available to be issued.

Effective May 25, 2022, the Plan was amended and restated to comply with the IRS' Cycle 3 restatement requirements.
