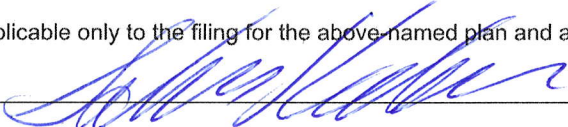

SUMMARY ANNUAL REPORT

For Menorah Wholesale, Inc. 401(k) Plan

This is a summary of the annual report Form 5500-SF Annual Return/Report of Small Employee Benefit Plan for Menorah Wholesale, Inc. 401(k) Plan, EIN 95-4041117, Plan No. 001, for period January 1, 2025 through December 31, 2025. The Form 5500-SF annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single-employer defined contribution plan.

Basic Financial Statement

Benefits under the plan are provided by a Group Annuity Contract with Sentry Life Insurance Company. Plan expenses were \$692. These expenses included \$692 in administrative expenses. A total of 7 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons may have earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,769,907 as of December 31, 2025, compared to \$1,430,378 as of January 1, 2025. During the plan year the plan experienced an increase in its net assets of \$339,529. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$340,221, including employer contributions of \$20,032, employee contributions of \$78,366, and earnings from investments of \$241,823.
