Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the accompanying financial statements of Alton Steel, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended September 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Alton Steel, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of September 30, 2025 and 2024, and for the year ended September 30, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

1. Description of Plan

The following description of Alton Steel, Inc. 401(k) Plan (the “Plan”), provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan sponsored by Alton Steel, Inc. (the “Company”) covering all eligible employees of the Company. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Administrator, which is the Company, is responsible for oversight of the Plan. The Plan Administrator, along with the Plan’s investment advisor, determines the appropriateness of the Plan’s investment offerings and monitors investment performance. Effective May 9, 2025, the Plan approved the transfer of assets from the Alton Steel, Inc. Employee Stock Ownership Plan totaling \$1,000,000.

Employees are eligible to enter the Plan when they have reached 18 years of age. For non-union employees, an employee’s entry date is the first day of the Plan quarter following the date he or she meets the eligibility requirements. For union employees, the entry date is the first day after an employee completes the 90-day probationary period described in the collective bargaining agreement with the union, provided the employee meets eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

Each year, the participants may contribute up to 100% of their pretax and after-tax annual compensation, as defined in the Plan Document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

For each eligible participant, the Company contributed \$2.03 per service hour for the period from October 1, 2024, through March 31, 2025, and contributed \$2.13 per service hour from April 1, 2025, through September 30, 2025. The Company contributed \$2.03 per service hour for each eligible participant from October 1, 2023, through September 30, 2024. Pursuant to a collective bargaining agreement, contributions for union employees are funded by the Company to the Steelworkers’ Pension Trust rather than to the Plan, and, accordingly, are not included in these financial statements.

b. Contributions (Continued)

Contributions per service hour totaled \$228,640 for the year ended September 30, 2025. Additional profit-sharing contributions may be made at the discretion of the Company based on a quarterly profitability calculation. For the year ended September 30, 2025, there were no profit sharing contributions.

c. Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of Company discretionary contributions and Plan earnings and charged with withdrawals and an allocation of Plan's gain or losses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately vested in their voluntary salary deferral contributions, Company discretionary contributions plus the earnings thereon.

e. Forfeited Accounts

Under provisions of the Plan, when certain terminations of participants in the Plan occur, the non-vested portion of the participants account represents a forfeiture. Forfeitures may be utilized to restore forfeitures or reduce (or reallocate) employer contributions to the Plan. There was no balance in the forfeiture account at September 30, 2025.

f. Investments

Participants direct the investment of their contributions into various investment options offered by the Plan.

g. Payment of Benefits

Prior to separation from service with the Company, a participant may request a distribution of rollover contributions. Effective April 2024, participants may also request vested participant funds for federally declared disaster withdrawals, emergency expense withdrawals, or domestic abuse withdrawals. In the event of a financial hardship, certain vested participant funds, as defined in the Plan Document, may be requested for distribution.

g. Payment of Benefits (Continued)

In-service distributions may also be requested by the participants who are at least 59 ½. On termination of service by: (1) retirement, (2) death, (3) total and permanent disability, or (4) termination of employment, a participant's account is payable in a lump-sum. Upon termination of employment for reasons other than retirement, total disability, or death, the participant's account balance will be distributed in a manner based on the balance of the account. If the separated participant's account does not exceed \$5,000, the participant will receive an involuntary cash-out distribution. Benefits are recorded when paid.

h. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to (1) the lesser of \$50,000 reduced by the highest outstanding balance of any prior loans from the plan during the prior one-year period, or (2) 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

The following are the significant policies followed by the Plan:

a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

b. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amount of net assets available for benefits and the changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Plan's investments in fully benefit-responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is accrued on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2025. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

e. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are quarterly asset fees, contract charges, and quarterly fund expenses which are charged to participant accounts pro rata based on participant account balances.

f. Subsequent Events

The Plan was frozen as to eligibility and benefit accruals effective February 28, 2026. No new employee or employer contributions are permitted after that date. In addition, the Plan Sponsor approved a resolution to terminate the Plan effective April 30, 2026. Following termination, the Plan's assets will be distributed to participants and beneficiaries in accordance with the Plan document and applicable provisions of ERISA and the Internal Revenue Code.

Subsequent events have been evaluated up to April 23, 2026, the date these financial statements were available to be issued.

3. Fair Value of Financial Instruments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are selected to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of September 30, 2025.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Investments at Contract Value

The Plan entered into fully benefit-responsive investments contracts for which contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

4. Investments at Contract Value (Continued)

The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Putnam, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal of the plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The contract allows the contract holder and the insurance company to terminate the contracts with 46 days advance written notice to the other party.

5. Information Prepared by and Certified by Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

The Company has adopted a volume submitted profit sharing plan whose sponsor obtained its opinion on June 30, 2020, in which the IRS stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The volume submitter plan has been amended since receiving the opinion letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
