- A) Eligibility - The employees are eligible to participate on the first day of the plan year following the attainment of age 21 and the completion of one year of service, or the first day of the seventh month of the plan year following the satisfaction of the above.
- B) Benefit Formula - 5% of Average Annual Compensation per year of participation (to a maximum of 10 years).
- C) Accrued Benefit - The participant's Normal Retirement Benefit earned to date.

In the event of termination of employment, a participant shall have a nonforfeitable interest in the Accrued Benefit based upon his years of service to date of termination and compensation in effect at such date; such vested percentage is as follows:

E) Death Benefit -

Should a participant die prior to retirement, the beneficiary will receive the actuarially determined reserve plus the death benefit provided by any insurance policy on the participant's life less any cash value at date of death. If no option has been elected as of the date of death, the beneficiary has the right to determine the time and manner of payments. Should a participant die after his retirement, the beneficiary shall receive any remaining amounts payable under the payment option in effect.
