Changes Since the Prior Valuation

- There were no assumption changes since the prior valuation.
- There is a change in the actuarial method for the plan year that qualifies for automatic approval under Revenue Procedure 2017-56, Section 4.02 (“Approval for change in funding method due to change in valuation software”). Both the enrolled actuary for the plan and the business organization providing actuarial services to the plan are the same as in the prior plan year. The funding target, target normal cost (without regard to any adjustments for employee contributions and plan-related expenses) and actuarial value of assets, as determined by the new valuation software as of the valuation date for the prior plan year, are both within 2% of those values as determined by the prior valuation software, and approval under Section 4.02 was not used in the prior plan year. The other requirements of Section 4.02 are also satisfied.

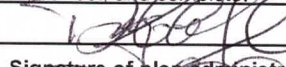
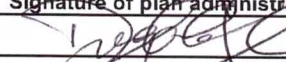

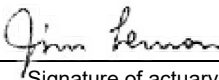
