INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
RTI/Community Management Associates, Inc. 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of RTI/Community Management Associates, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of April 8, 2025 (in liquidation) and December 31, 2024 (ongoing), and the related statement of changes in net assets available for benefits for the period ended April 8, 2025 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RTI/Community Management Associates, Inc. 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 8, 2025 and December 31, 2024, and for the period ended April 8, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of RTI/Community Management Associates, Inc. 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note 4 to the financial statements, the Plan Sponsor approved a plan of liquidation on January 1, 2025, and management determined liquidation is imminent. As a result, RTI/Community Management Associates, Inc. 401(k) Savings Plan changed its basis of accounting from the going concern basis used in presenting the December 31, 2024 financial statements to the liquidation basis of accounting used in presenting the April 8, 2025 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Notes to Financial Statements

1 - Description of Plan

The following description of the RTI/Community Management Associates, Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

A. General - The Plan became effective on January 1, 2021 and is a defined contribution 401(k) plan covering all eligible employees of RTI/Community Management Associates, Inc. (the “Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and is intended to be a qualified retirement plan under the Internal Revenue Code (“IRC”).

B. Plan Amendments - Effective January 1, 2024, the Plan was amended to add several exclusions to the definition of plan compensation.

C. Contributions - Participants may voluntarily contribute to the Plan up to an annual maximum of 100% of eligible compensation, pursuant to a salary reduction arrangement. Total participant contributions in any calendar year are restricted to the applicable limit under IRC Section 402(g). The applicable limit for the period ended April 8, 2025 is \$23,500 with an additional \$7,500 catch-up provision for participants age fifty or older. The Plan allows for the Sponsor to make discretionary matching contributions equal to a uniform percentage of salary deferrals at the end of each plan year. The Sponsor matches an amount equal to 50 percent of each participant’s contribution up to 6 percent of the participant’s compensation. The participants direct the investment of the employee deferrals and the Sponsor discretionary matching contributions to the various investment options offered by the Plan.

D. Expenses of Administering the Plan - Administrative expenses recorded in the financial statements represent expenses that were absorbed by participants related to the administration of the Plan.

E. Participants' Accounts - Each participant's account is credited with the participant's contributions, the Sponsor’s discretionary matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific transactions, as defined within the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

F. Eligibility and Vesting - Employees of the Sponsor become eligible to participate in the Plan once they have reached the age of 21 and completed six months of service with the Sponsor.

Participants’, Sponsor discretionary matching contributions plus actual earnings thereon are 100% vested at all times. A participant is 100% vested upon termination by reason of retirement, death, or disability. Upon termination, any amount in which the participant is not vested shall be forfeited.

G. Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000, and up to a maximum of the lesser of 50% of their vested account balance or \$50,000. The loans bear interest at variable rates and are secured by the balances in the participants’ accounts. Principal and interest payments are redeposited in the participants’ accounts based on their current allocation elections within the Plan. Participants may have no more than one loan outstanding at one time.

H. Payment of Benefits - Upon termination of service or retirement, participants entitled to payment under the Plan will have the option of receiving a lump sum distribution equal to their vested account balance or rolling their distribution to an IRA or another qualified retirement plan.

1 - Description of Plan (continued)

I. Forfeited Accounts - Forfeitures may be used to reduce future Sponsor contributions or to pay administrative expenses. As of April 8, 2025, there were no forfeited non-vested accounts. During the period ended April 8, 2025, no forfeited non-vested accounts were used to reduce Sponsor contributions.

2 - Summary of Significant Accounting Policies

A. Basis of Presentation - The accompanying financial statements were prepared on the accrual basis of accounting. Therefore, revenues are recognized when earned, and expenses are recorded when the obligation is incurred. The 2024 financial statements were prepared on the going concern basis of accounting, which contemplates the continued operation of the Plan and the realization of assets and the settlement of liabilities in the normal course of business. As discussed in Note 4, the Plan's governing body approved a plan of liquidation during 2025, and management determined that liquidation is imminent. Accordingly, the 2025 financial statements have been prepared using the liquidation basis of accounting.

B. Valuation of Investments - Interest in registered investment companies, and interest in common/collective trusts are stated at fair value as determined and certified by Empower Retirement, LLC (the "Trustee"). Funds held in insurance company general account are stated at contract value as determined and certified by the Trustee. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

C. Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. During the period ended April 8, 2025, there were \$17,027 in deemed distributions of notes receivable from participants.

D. Payment of Benefits - Benefits are recorded when paid. Corrective distributions generally represent the distribution of certain assets to employees in order for the Plan to comply with ERISA nondiscrimination rules. There were no corrective distributions paid during the period ended April 8, 2025.

E. Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

F. Subsequent Events - The Sponsor has evaluated subsequent events through March 3, 2026, the date the financial statements were available to be issued.

3 - Information Certified by the Trustee

The Sponsor elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan has certified that all of the following data included in the accompanying financial statements is complete and accurate:

Investments, as shown in the statements of net assets available for benefits as of April 8, 2025 and December 31, 2024.

Net investment loss from registered investment companies, as shown in the statement of changes in net assets available for benefits for the period ended April 8, 2025.

4 - Plan Termination

The Company reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On January 1, 2025, the Plan Administrator approved the termination of the Plan. As a result of the termination, all affected participants became fully vested in their account balances as of the termination date.

Upon termination of the Plan, the assets remaining after payment of all Plan expenses will be allocated to participants and beneficiaries in accordance with the provisions of the Plan and applicable law. The Plan administrator will distribute account balances to participants and beneficiaries as soon as administratively feasible following the termination.

On January 1, 2025, the Plan Administrator approved a formal plan of liquidation, and management determined that liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2024 financial statements to the liquidation basis of accounting for the 2025 financial statements. Under the liquidation basis, assets are stated at their estimated net realizable values, and liabilities are stated at their estimated settlement amounts. All plan benefits became fully vested upon termination and will be distributed as soon as practicable after the termination date.

5 - Income Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7 - Fair Value Measurements

As required by the Fair Value Measurements topic of the Financial Accounting Standards Board *Accounting Standards Codification* ("FASB ASC"), all financial assets and liabilities are measured at fair value on a recurring basis. The topic establishes a framework for measuring fair value and enhances disclosure requirements for fair value measurements. The topic defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The topic establishes market or observable inputs as preferred sources of values, followed by assumptions based on hypothetical transactions in the absence of market inputs. The topic establishes a hierarchy for grouping these assets and liabilities, based on the significance level of the following inputs:

Level I – Quoted prices in active markets for identical assets or liabilities.

Level II – Quoted prices in active markets for similar assets and liabilities, quoted prices for identical or similar instruments in markets that are not active and model-derived valuations whose inputs are observable or whose significant drivers are observable.

Level III – Significant inputs to the valuation model are unobservable.

Interest in registered investment companies includes money market and mutual funds that are valued using quoted prices on nationally recognized securities exchanges.

Interest in common/collective trusts consists of collective investment funds that are valued daily using models developed by the Plan's trustee. The units of these pooled funds are not traded on an exchange or over-the-counter.

The preceding methods described may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8 - Funds Held in Insurance Company General Account

The Plan has entered into a fully benefit-responsive investment contract with the Trustee. The Trustee maintains the contributions in a general account where they are invested in accordance with the Trustee's general account investment policy. The objective of the investment policy is to maximize long-term, risk-adjusted returns. The Trustee's general account assets are predominately fixed-income investments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

9 - Parties-in-Interest Transactions

The Plan pays fees for various administrative and custodial services provided during the year. Fees paid using Plan assets during the period ended April 8, 2025 for these services totaled \$15,016. These fees were based on customary and reasonable rates for such services.

The Sponsor provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged and pays annual auditing fees on behalf of the Plan.
