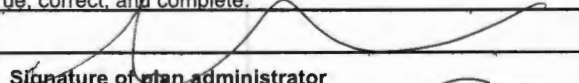
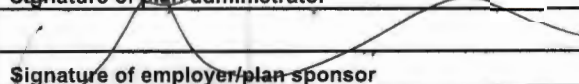

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust fund.

Plan expenses for the period were \$ 6,405,154 . These expenses included \$ 0 in administrative expenses, \$ 6,405,154 in benefits paid to participants and beneficiaries, and \$ 0 in other expenses. A total of 17 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these people had yet earned the right to receive benefits.

The plan had total income of \$ 939,359 including employer contributions of \$ 0 and earnings from investments of \$ 939,359.
