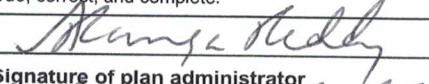

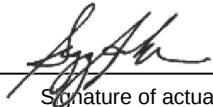

- Compensation - Use current compensation to calculate the benefit accrual rate for 401(a)(26)
- Testing Age - Normal retirement age or attained age, if older
