### Note 1 - Description of plan:

The following description of the OSG Ship Management, Inc. Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan was a defined contribution plan for employees of OSG Ship Management, Inc. and Alaska Tanker Company, LLC. (collectively the Company) that were not non-resident aliens who received no compensation from the employer which constitutes U.S. source income, leased employees, interns, individuals working in the capacity of a licensed deck officer, or governed by a collective bargaining agreement unless the collective bargaining agreement expressly provides for participation. During the period from January 1, 2025 through August 1, 2025 (date of merger) and year December 31, 2024, there were no union employees participating in the Plan. There was no minimum service period or minimum age requirements for employees to be eligible to participate in the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan merged out of existence into the Saltchuk Companies 401(k) Plan effective August 1, 2025 (Note 6).

#### Contributions

Prior to merger out of existence, participants were allowed to make pre-tax or post-tax Roth contributions to the Plan of up to 100% of compensation. A participant's total contributions in any year could not exceed the maximum amounts for that year as specified in Sections 401(k) and 415 of the Code and regulations there under. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically-enrolled participants had their deferral rate set at 4% of eligible compensation and their contributions invested in a designated default investment fund until changed by the participant. Deferral percentages automatically increased 1% annually, until reaching 8% of eligible compensation.

The Company made matching contributions of 100% of the first 4% of base compensation and 50% of the next 4% of base compensation that a participant contributed to the Plan for a total of \$484,817 for the period from January 1, 2025 through August 1, 2025 (date of merger).

Any participant who had attained, or would have attained, age 50 prior to the end of a Plan year could make catch-up contributions (in whole percentages only).

#### Contributions - continued

Rollover contributions were accepted from other employers' qualified plans for new employees joining the Plan.

#### Investment options

Prior to merger out of existence, participants directed the investment of their contributions into various investments offered by the Plan. Participants could invest in various funds, each with different risk exposure and return potential. The Plan offered various mutual funds, a money market fund, and a common/collective trust fund as investment options for participants. Participants could change their investment options daily.

#### Participant accounts

Prior to merger out of existence, each participant's account was credited with the participant's contributions and an allocation of the Company's contributions. Each participant's account was reduced by any withdrawals or distributions and an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled was the vested benefit that can be provided from the participant's account.

#### Vesting

Prior to merger out of existence, participants were immediately vested in their contributions plus actual earnings. Vesting in Company contributions plus actual earnings thereon was achieved at the completion of three years of continuous service. Participants were immediately vested at the participant's normal retirement date, or upon death or becoming disabled while an employee of the Company.

#### Forfeitures

At August 1, 2025 (date of merger) and December 31, 2024, forfeited non-vested accounts totaled approximately \$0 and \$34,000. The forfeiture balance at the time of merger into the Saltchuk 401(k) Plan was approximately \$18,000, which was transferred into the Saltchuk 401(k) Plan. During 2025, approximately \$24,000 of forfeitures were used to reduce Company contributions.

### Note 1 - Description of plan - continued:

#### Payment of benefits

Prior to merger out of existence, upon termination of service due to death, disability, or retirement, a participant or beneficiary could elect to receive a lump-sum, installment, direct rollover, or deferred payment in an amount equal to the value of the participant's vested interest in his or her account. A participant could request a withdrawal from the Plan while still under employment of the Company upon reaching the age of 59.5 or for reasons of financial hardship, as defined.

For termination of service due to other reasons, and if the vested account balance exceeded \$5,000, a participant could elect to receive a lump-sum distribution, have his or her balance rollover to the participant's eligible retirement account, obtain installment payments, or have his or her account balance remain in the Plan. If the vested account balance was less than \$5,000, the Plan administrator would distribute the participant's entire vested balance as a lump-sum distribution as soon as administratively feasible.

#### Notes receivable from participants

Prior to merger out of existence, participants could borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance within the Plan and any other plan of the Plan Sponsor. Note terms ranged from six months to five years. The notes were secured by the vested balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the Plan Sponsor. Interest and principal were paid ratably through payroll deductions. Participants were allowed a maximum of two outstanding notes at any point in time.

#### Administrative expenses

Prior to merger out of existence, certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Investment valuation and income recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

#### Common/collective trust fund

The common/collective trust fund, at the fund level, was composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. These contracts were not considered fully benefit-responsive to the Plan as the underlying contracts were not direct investments between the Plan and the issuer. These contracts consisted of guaranteed interest contracts (GICs) issued by insurance companies, investment contracts issued by banks, synthetic investment contracts (SICs) issued by banks, insurance companies, and other issuers, and securities supporting such SICs, and other similar instruments which were intended to maintain a constant net asset value. The Plan had elected to value the collective trust fund using the net asset value (NAV) as a practical expedient to determine fair value.

#### Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when incurred. No allowance for credit losses had been recorded as of December 31, 2024. If a participant ceased to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded when a distributable event occurs.

### Note 2 - Summary of significant accounting policies - continued:

#### Payment of benefits

Benefits were recorded when paid.

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Risks and uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it was at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the period from January 1, 2025 through August 1, 2025 (date of merger) and year ended December 31, 2024. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the period from January 1, 2025 through August 1, 2025 (date of merger) and year ended December 31, 2024.

#### Subsequent events

The Plan has evaluated subsequent events through May 14, 2026, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of August 1, 2025 (date of merger), have been incorporated into these financial statements.

Note 3 - Investments and information prepared and certified by the trustee:

Vanguard Fiduciary Trust Company (Vanguard) was the trustee for the Plan. Vanguard held the Plan's investment assets and executed investment transactions. Management has determined that Vanguard is a qualified institution and the information prepared and certified by Vanguard meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at August 1, 2025 (date of merger) and December 31, 2024, and net appreciation in fair value of investments, interest income on notes receivable from participants, and dividend and interest income for the period from January 1, 2025 through August 1, 2025 (date of merger), was obtained and derived from information supplied to the Plan Administrator and certified as complete and accurate by Vanguard.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification No. 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### Note 4 - Fair value measurements - continued:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at August 1, 2025 (date of merger) and December 31, 2024.

- Mutual funds were valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges. Mutual funds were classified as Level 1 of the valuation hierarchy.
- Money market funds were valued at quoted prices and were classified within Level 1 of the valuation hierarchy.
- Units of participation of the common/collective trust funds were valued at the net asset value (NAV) provided by the fund's trustee as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it was determined to be probable that the fund would sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiated a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

### Note 5 - Transactions with parties-in-interest:

The Plan invested in shares of mutual funds, a money market fund, and a common/collective trust fund managed by an affiliate of Vanguard, the trustee of the Plan. Transactions in such investments qualified as party-in-interest transactions, which were exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair values of investments.

Note 5 - Transactions with parties-in-interest - continued:

The Plan's administrative expenses were paid in part by the Employer and in part by the Plan, as provided by the Plan document. In addition, certain administrative functions were performed by employees of the Company. No such employee received compensation from the Plan.

Note 6 - Plan merger and termination:

During 2025, the board of directors of the Company approved the merger of the Plan into the Saltchuk Companies 401(k) Plan, a Plan sponsored by the Company's parent. The Plan was merged out of existence effective August 1, 2025, at which time all participants became 100% vested in their accounts. All of the Plan's assets were transferred on July 31, 2025, and the Plan was merged out of existence on August 1, 2025.

Note 7 - Tax status:

The underlying pre-approved plan had received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and; therefore, the related trust was tax-exempt. The plan administrator had determined that it was eligible to and has chosen to rely on the current IRS non-standardized prototype plan opinion letter. Once qualified, the Plan was required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan was being operated in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan was qualified and the related trust was tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
