Management has obtained certifications from qualified institutions as of July 31, 2025 and December 31, 2024 and for the period January 1, 2025 through July 31, 2025, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS AS OF JULY 31, 2025 AND DECEMBER 31, 2024 AND FOR THE PERIOD ENDED JULY 31, 2025

1. DESCRIPTION OF PLAN

The following description of the Amundi US, Inc. Retirement Benefit Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General — The Plan was a defined contribution (target benefit) plan qualified under Section 401 of the Internal Revenue Code (the "IRC") covering all eligible U.S. employees, as defined, of Amundi US, Inc., and its wholly owned subsidiaries (the "Company" and "Plan Sponsor"), who have reached the age of 21 and have completed one year of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Substantially all investments were participant directed.

The Company, a Delaware corporation, and its subsidiaries, were wholly owned subsidiaries of Amundi Holdings US, Inc. ("AHUS"), a wholly owned subsidiary of Amundi Asset Management ("Amundi"), a global asset manager headquartered in Paris, France.

The Retirement Plan's Committee of the Company was the plan administrator and was responsible for the general administration of the Plan, including compliance with the reporting and disclosure requirements of ERISA.

On July 9, 2024, Amundi entered into a definitive agreement to sell AHUS and its subsidiaries to Victory Capital Holdings, Inc. ("Victory Capital"), subject to regulatory and shareholder approval and customary closing conditions. The transaction was completed on April 1, 2025, and AHUS was combined into Victory Capital in exchange for 21.2% economic stake in Victory Capital. Effective July 31, 2025, the Amundi US, Inc. Retirement Benefit Plan merged into the Victory Capital Management Inc. 401k Savings Plan.

Contributions Determined by the Actuary — Contributions to the Plan were made solely by the Company on the basis of the target benefit objective and contribution formulas stated by the plan document in an amount not to exceed the maximum allowable for federal income tax purposes.

The monthly target retirement benefit was 1.2% of average monthly compensation plus 0.5% of average monthly compensation, as defined, in excess of \$10,000, excluding compensation exceeding \$350,000 annually (as adjusted in accordance with IRC Section 401(a)(17)), multiplied by projected years of service (not exceeding 30 years). The actuarial calculation assumed an annual return of 5.4%, the commencement of benefits on a participant's 65th birthday, and the mortality table as described in Rev Ruling 2001-62, with a 50% female and 50% male mix. The contribution limit for 2025 is the lower of 100% of a participant's total compensation or \$70,000.

Participant Accounts — Individual accounts were maintained for each participant. Each participant’s account was credited with the contributions of the Company and earnings thereon and debited with withdrawals. Net realized gains or losses, dividends, interest, and other distributions from any mutual fund were reinvested in shares of that mutual fund based on each participant’s account balance. The benefit to which a participant was entitled was his or her vested account balance.

Investment Options — All participants were entitled to direct their investments to a core list of certain of the Pioneer Family of Mutual Funds, third party mutual funds, and common/collective trusts, or they were able to direct their investments to other mutual funds via a self-directed account managed by Bank of America, N.A. (the “Trustee”). The self-directed brokerage account allowed plan participants to invest in a wide array of securities, mainly registered investment companies, beyond those offered under the standard Plan offering. The allocation was able to be changed and an election to transfer all or part of an account balance between investment options could have been made at any time by the participant.

Vesting — Vesting of participants’ accounts was based on years of continuous service. A participant was 100% vested after six years of credited service. A participant also became fully vested upon attainment of normal retirement age or due to death or disability. Vesting percentages for the Plan were as follows:

Payment of Benefits — The Plan provided for benefits to be paid to participants who have reached retirement age (normally age 65) and who had retired from active service with the Company. Such benefits were based on the amount in the participant’s account as of the distribution date. The Plan also provided for the payment of benefits in the event of death, disability, or termination of employment. The normal form of benefit was to apply the balance of a participant’s account or accounts to purchase an annuity contract providing, in the case of a married participant, an annuity to the participant for life and a survivor annuity of one-half of the participant’s annuity to the spouse of the participant, for life, if the spouse survived the participant. In the case of an unmarried participant, an annuity for life was purchased. The Plan offered several alternative forms of benefit payment, such as a lump-sum payment, periodic payments, or a fixed ten-year annuity.

Forfeited Accounts — When certain terminations of participation in the Plan occurred, the non-vested portion of the participant’s account, as defined by the Plan, represented a forfeiture. As of December 31, 2024, forfeited, non-vested amounts totaled \$84. Forfeitures were retained in the Plan and were first used to pay administrative expenses. Any remaining amounts were used to reduce employer contributions payable under the Plan. For the period January 1, 2025 to July 31, 2025, \$72,894 of forfeitures were generated and \$65,155 of forfeited nonvested accounts were used to reduce employer contributions and pay administrative expenses.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Presentation — The accompanying financial statements of the Plan were prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investments, Investment Valuation and Income Recognition — Investments were stated at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded as earned. Net appreciation of investments represented realized gains (losses) and the change in unrealized appreciation. The average-cost basis was used in calculating realized gains and losses from the sales of investments in mutual funds during the year.

Contributions — Contributions were recorded and paid to the Plan semi-annually.

Unit Values — Individual participant accounts for the common/collective trust funds were maintained on a unit value basis. Participants did not have ownership in the specific underlying securities or other assets in the funds but did have an interest therein represented by units which are valued daily. The funds earned dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund were converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants’ accounts were charged or credited with the number of units properly attributable to each participant.

Risks and Uncertainties — The Plan provided for various investment options which were exposed to interest rate, market, credit, and other risks depending on the nature of the specific fund or other investment security. Market risks included global events such as an international conflict which could impact the value of investment securities. Accordingly, it was at least reasonably possible that these factors would result in changes in the value of the Plan’s investments which could have materially affected amounts reported in the statements of net assets available for benefits, the statement of changes in net assets available for benefits, and the related participants’ account balances in the near term.

Use of Estimates — The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities, at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Expenses — Administrative expenses of the Plan were deducted from participant accounts as provided in the plan document. Under the terms of a fee schedule entered into December 6, 2016, between the Plan and the recordkeeper, the recordkeeper may have been required to deposit into the Plan’s trust a Credit Account, as defined in the fee schedule, which could have been used to pay administrative expenses of the Plan or can be allocated to participant account balances. During the period ended July 31, 2025, \$40,382 was paid to the recordkeeper.

As of December 31, 2024, \$13 was remaining in the Plan related to the Credit Account. There were no administrative expenses paid or amounts allocated to participant accounts from the Credit Account during the period January 1, 2025 to July 31, 2025. The amount remaining in the Credit Account was used to pay administrative expenses or allocated to participant accounts.

Subsequent Events — The Plan has evaluated subsequent events through May 15, 2026, the date that the financial statements are available to be issued. No significant matters for disclosure were identified during this evaluation.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds (Pioneer, Third Party, and Self-Directed Brokerage Accounts) — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. Shares of open-end registered investment companies (including money market mutual funds) were valued at NAV. The mutual funds held by the Plan were deemed to be actively traded.

Common/Collective Trust — Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may have occurred daily. Were the Plan to initiate a full redemption of the collective trusts, the investment adviser reserved the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations were carried out in an orderly business manner. In accordance with Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

5. TAX STATUS

The Internal Revenue Service (“IRS”) had determined and informed the Company by a letter dated June 29, 2015 that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Company and plan management believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continued to be tax-exempt. Therefore, no provision for income taxes had been included in the Plan’s financial statements.

6. UNCERTAIN TAX POSITIONS

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain of the Company’s wholly owned subsidiaries earned fees on assets invested by the Plan in the Pioneer Family of Mutual Funds. Additionally, certain investments managed by the Trustee earned fees on assets invested by the Plan. Investments in the Pioneer Family of Mutual Funds and Common/Collective Trusts represent party-in-interest transactions.

8. INFORMATION CERTIFIED BY TRUSTEE

The following is a summary of the unaudited information regarding the Plan as of July 31, 2025 and December 31, 2024, and for the period January 1, 2025 through July 31, 2025. This information was prepared by, or derived from information prepared by Bank of America, N.A., the Trustee of the Plan, and furnished to the Plan Administrator. The plan administrator has obtained certifications from the Trustee that such information is complete and accurate. The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.
