INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 - PLAN DESCRIPTION

The following description of the Haven Behavioral Healthcare Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan and Trust agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan maintained under Section 401(k) of the Internal Revenue Code and covers all eligible employees of Haven Behavioral Healthcare, Inc. and its subsidiaries (the "Company"). Eligible employees included all employees who had been employed for 30 days. The employees were automatically enrolled at a deferral rate of 2% upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time.

Contributions: Each year, participants could contribute any percentage of annual compensation as defined by the Plan as either pretax or Roth deferrals, subject to maximum limits established by the Internal Revenue Service. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company could make matching contributions equal to a discretionary percentage that is to be determined by the Company, and could also make other discretionary contributions in an amount determined by the Company. For the year ended December 31, 2024, the Company made a discretionary match of 25% of an employee's contribution, up to 4% of eligible compensation.

Participant Accounts: Each participant's account was credited with the participant's contribution and allocations of the Company's contribution and Plan earnings, and was charged with the participant's withdrawals and an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants could direct all contribution sources in their account to selected investments as made available and determined by the Company. Participants could change their investment options at any time throughout the year.

Vesting: Participants were immediately vested in their voluntary employee contributions plus actual earnings thereon. Vesting in Company contributions plus actual earnings thereon were based on years of continuous service. The participant vesting schedule was as follows:

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan allowed for in-service withdrawals from vested amounts for any reason after the participant attains age 59½ and upon proving financial hardship.

Notes Receivable from Participants: Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever was less. The loans were secured by the balance in the participants' accounts and bore interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were paid through payroll deductions. Defaults on loans would reduce a participant's nonforfeitable accrued benefit by the lesser of the amount in default (plus accrued interest) or the Plan's security interest in that nonforfeitable accrued benefit.

Forfeitures: Participant forfeitures of employer matching contributions were used to offset future employer matching contributions or administrative expenses of the Plan. No forfeitures were used to offset employer contributions during 2025.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants were paid by the participant. Fees due to Principal Life Insurance Company are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees were charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan were paid by the Company.

Plan Transfer Due to Merger: Effective May 15, 2025, the Plan was merged into the Oceans Healthcare 401K Plan. In connection with the merger, all assets of the Plan were transferred to the Oceans Healthcare 401K Plan on May 15, 2025.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive contracts, are reported at fair value as further described in Note 4. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan held various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 - CERTIFIED INFORMATION

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivables from participants held at May 15, 2025 and December 31, 2024 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivables from participants for period from January 1, 2025 through May 15, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the trustee of certain assets of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan held a fully benefit-responsive investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contracts, by general type, are presented below:

Traditional Guaranteed Investment Contract: At December 31, 2024, the Plan held a fully benefit-responsive investment contract with Principal Life Insurance Company ("Principal"; "Issuer") through its investment in the Fixed Income Guarantee Option. Principal maintained the contributions in its general account. The Issuer guaranteed the Plan a return of principal and interest under the terms of the contract. The interest crediting rate was updated semi-annually based upon contract provisions, and it may not be less than zero. Principal's general account was credited with earnings on the underlying investments and was charged for participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Under the contract, the Plan's investment in the contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limited the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan held a guaranteed investment contract issued by Principal Life Insurance Company. The Plan also invested in collective trust accounts managed by Principal Global Investors Trust Company, an affiliate of Principal Life Insurance Company and Principal Trust Company. Principal Life Insurance Company managed the Plan's investments and was also the Plan recordkeeper. Therefore, these transactions and the Plan's payment of recordkeeping and investment management fees to Principal Life Insurance Company qualify as party-in-interest transactions. Notes receivable from participants also reflected party-in-interest transactions.

NOTE 7 - INCOME TAX STATUS

The Plan received its opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 15, 2025 and December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.
