Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Liquidation Basis of Accounting

As discussed in Notes 1 & 2 to the financial statements, on April 11, 2025, the Plan Sponsor authorized the termination of the Plan, and the Plan determined liquidation was imminent. As a result, the Plan has changed its basis of accounting as of and for the year ended December 31, 2025 from the going concern basis to a liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

As of December 31, 2025 and 2024

Note 1 – Description of Plan

The following description of CSE Insurance Services 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by CSE Insurance Services, Inc (the Plan Sponsor and Company) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and any adopting participating employers. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

All employees of the Company and any participating affiliates are subject to the following eligibility requirements:

- Age: None
- Service: None
- Status Exclusions:
 - a. Members of collective bargaining agreement
 - b. Non-resident aliens with no U.S. earned income
 - c. Residents of Puerto Rico
 - d. Temporary employees
 - e. Leased employees

Upon satisfying the eligibility requirements, employees were able to participate in the Plan immediately upon eligibility.

The Securing a Strong Retirement Act of 2022 (SECURE 2.0) was signed into law on December 29, 2022, and includes mandatory and optional provisions with effective dates in 2025 and later. The Plan Administrator determined the optional provisions to elect and amended the Plan document accordingly effective April 11, 2025.

Plan Termination

On April 11, 2025, the Plan Sponsor authorized the termination of the Plan effective September 30, 2025 via Plan amendment, and the Plan determined liquidation was imminent. This termination plan occurred in conjunction with the Plan Sponsor's acquisition by Compre Group Holdings Limited on April 16, 2025. Participants had the opportunity to transfer their existing Plan balances into an IRA account, into another eligible retirement plan, or take a distribution. Plan balances were liquidated and distributed to participants in accordance with the planned termination on October 2, 2025.

CSE Insurance Services 401(k) Plan

Notes to Financial Statements (Continued)

Note 1 – Description of Plan (Continued)

The certification, further described in Note 3, covers the period through May 12, 2026, the date upon which all Plan investments were fully liquidated and the trust was initially zeroed out. While the financial statements cover

the full calendar year for compliance purposes as described below, no further investment activity occurred following this liquidation date.

Following the October 2, 2025 liquidation distribution, management identified uncorrected operational errors related to incorrect vesting calculations in 2024 totaling \$4,169. Because the corrective contributions for the 2024 errors were not fully resolved and distributed by December 31, 2025, the Plan is not considered terminated as of and for the year ended December 31, 2025. The Plan is not considered fully terminated and liquidated until all remaining corrective distributions are made to the affected participants.

Contributions

The Plan was funded through employee elective deferrals and Company contributions. Each year, participants could have elected to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants may have been permitted to deposit or “rollover” into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The following contribution types were allowed by the Plan:

- Roth deferrals
- Elective deferrals
- Rollover contributions
- Employer safe harbor
- Employer matching
- After-tax voluntary employee contribution

The Company had elected to operate the Plan as a safe harbor 401(k) plan, which makes the plan exempt from certain compliance testing requirements. Effective January 1, 2024, the Plan was amended to reflect safe harbor match of 100% of participant deferrals up to 4% of compensation. In addition, the Company could have made additional discretionary contributions as determined by the Company's board of directors. The Company did not make a discretionary contribution for the years ended December 31, 2025 and 2024.

Effective January 1, 2025, the Plan was amended to remove the option for rollover contributions.

Notes to Financial Statements (Continued)

Note 1 – Description of Plan (Continued)

Participant Accounts

Each participant's account was credited with the participant's contribution, allocation of the Company's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses that was paid by the Plan. Allocations could be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions, rollover contributions, employer safe harbor contributions, and actual earnings thereon. Prior to 2025, vesting in the Company discretionary contributions was based on years of service, and vested as follows: 25% after one year, 50% after two years, 75% after three years, and 100% after four years with immediate vesting in the event of death, disability or retirement during the Company's employment.

Effective January 1, 2025, the Plan was amended and participants became immediately 100% vested in all balances.

Forfeited Accounts

Forfeitures represent unvested portions of terminated participants' accounts. The Plan allowed forfeitures of non-vested Company contributions to be used as follows:

- Pay administrative expenses
- Reduce Company contributions

As of December 31, 2025 and 2024, forfeited non-vested accounts totaled \$0 and \$18, respectively. During the year ended December 31, 2025, forfeited non-vested amounts of \$108 were used.

Investment Options

Upon enrollment in the Plan, a participant could direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant could change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Notes Receivable from Participants

Participants who were active employees could borrow against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, were secured by the balance in the participant's account, and bore interest at reasonable rates, which were commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest were paid ratably through payroll deductions and generally repaid within 5 years.

Note 1 – Description of Plan (Continued)

Effective January 1, 2025, the Plan was amended and loans were no longer permitted.

Benefits Paid to Participants

Upon termination of service, disability, or retirement, a participant was entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account would be made to the designated beneficiary.

The following types of distributions were also allowed by the Plan:

- In service
- Hardship
- Involuntary cash-outs
- Termination partial withdrawal
- Rollover source withdrawal at any time

Plan Expenses

The Plan's expenses were paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company were excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan were recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses were included in net appreciation (depreciation) in fair value of investments.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

As a result of the plan termination described in Note 1, the Plan's financial statements as of and for the year ended December 31, 2025 have been prepared on the liquidation basis of accounting. Under the liquidation basis of accounting, assets were measured and presented at their net realizable values, which was the amount expected to be collected in settling or disposing the assets. Liabilities were stated at their estimated settlement amounts. Estimates for future costs expected to be incurred during the liquidation year, including costs to dispose of assets, have been accrued. In addition, any income, including dividends and interest, expected to be earned and collected on investments during the liquidation year had been recorded.

The Plan's financial statements as of December 31, 2024 have been prepared on the going concern basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2 – Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value (except for any fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments were recorded on the trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year end, were presented in the statement of changes in net assets available for benefits.

The Plan held no investments as of December 31, 2025.

Contributions

Contributions from Plan participants and employer contributions, if any, were recorded in the year in which the participant contributions were withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. If a participant ceased to make scheduled repayments and the Plan Administrator deemed the participant note receivable to be in default, the participant note receivable balance was reduced and a benefit payment recorded.

As of January 1, 2025, participant loans were no longer allowed by the plan.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events

Subsequent events were evaluated through May 12, 2026, which is the date the financial statements were available to be issued.

In April and May 2026, the Plan Sponsor funded the corrective contributions and associated lost earnings related to the uncorrected operational errors disclosed in Note 1. The final distributions were processed on May 5, 2026, effectively bringing the Plan's asset balance to \$0 and completing the final liquidation and termination of the Plan.

Note 3 – Certified Investments

Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2025 and December 31, 2024.

Mutual Funds

Mutual funds were valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted market prices.

Self Directed Brokerage

Consists of publicly traded securities and mutual funds. Publicly traded securities were valued at the closing price or last bid price. Valuation methodology of mutual funds is described above.

Investment Contracts

Consists of a guaranteed investment contract that is not considered to be fully benefit responsive; therefore, carried at its fair value using a discounted cash flow valuation methodology based on the interest rate of the contract. This contract was deemed to not be fully benefit-responsive following the partial plan termination in 2023 which could limit the Plan's ability to transact at contract value. Therefore, the investment contract was recorded at fair value.

Note 5 – Related Party Transactions and Transactions with Parties-in-Interest

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees were covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but were not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2025, the Plan made direct payments of \$61,144 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor paid directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services were included in the net appreciation (depreciation) in fair value of the related investment, as they were paid using investment earnings rather than a direct payment.

Note 6 – Tax Status

The Plan sponsor adopted a plan which received a favorable determination letter from the Internal Revenue Service dated November 14, 2022, which stated that the Plan was designed in accordance with the applicable sections of the IRC and was, therefore, not subject to tax under present income tax law. The Plan was required to operate in conformity with the IRC to maintain its qualification. Management was not aware of any course of action or series of events that had occurred that might adversely affect the Plan's qualified status.

U.S. GAAP required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator had analyzed the tax positions taken by the Plan and had concluded that as of December 31, 2025 there were no uncertain positions taken or expected to be taken. The Plan had recognized no interest or penalties related to uncertain tax positions. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax years in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.
