NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Houck Group, Inc. Employee Benefits Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

General

The Plan, adopted January 1, 2024, provides certain health benefits as well as other benefits to eligible employees sponsored by Houck Group, Inc (the Plan Sponsor) and its subsidiary entities. All regular full-time employees of Houck Group, Inc. and subsidiary entities working at least 30 hours per week are eligible to participate in the Plan in the month following 60 days of employment. Part-time, seasonal employees and interns are excluded from the Plan. Subsidiary entities include Heidler Roofing, LLC, Houck & Company, Houck Industrial, LLC, Houck Services, Inc., ACI Harrisburg, LLC, PSI Pumping Solutions and Commercial Structural Restoration, LLC. Houck Group, Inc. and affiliated entities are collectively referred to as "the Company".

Plan assets are held in Houck Group, Inc. Employee Benefit Trust ("the Employee Benefit Trust"). These assets are used to provide health care and other employee benefits under one or more plans established by the Plan Sponsor. The Employee Benefit Trust was established on December 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides health benefits (medical, prescription drugs, vision and dental), life insurance, short-term disability, AD&D insurance, and Paid-Time-Off (PTO) benefits. PTO benefits under the Plan are limited to field employees. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA"). Additionally, the Plan provides a healthcare and dependent care flexible spending accounts (FSA).

The Plan pays participant medical claims up to \$80,000 per individual. Any medical claims in excess of this amount are covered by the Company's stop-loss coverage policy. The funds needed to pay medical claims are paid from the Employee Benefit Trust.

Insured Benefits

The Plan fully insures vision, dental, short-term disability, basic life, and AD&D benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums for vision and dental are deducted from the employee's pay and paid to an insurance company from the Employee Benefit Trust. Premiums for short-term disability and basic life, AD&D insurance are fully funded by the Company.

Self-Insured Benefits

Medical and prescription benefits are self-insured. The claims for self-insured medical benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Employee Benefit Trust. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The plan utilizes a pharmacy benefit manager ("PBM") which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Other Benefits

The Plan has healthcare and dependent care FSA's that are funded solely through participant contributions. The FSA's allows eligible participants to be reimbursed tax free for qualified medical care and dependent care expenses subject to a specified ceiling. Amounts remaining at the end of the year cannot be carried over to the next year. These amounts are maintained in the Plan and netted against flexible spending account expenses.

Contributions

In addition to deductibles and co-payments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Contributions are made by the Company on behalf of Plan participants on a monthly basis. If at any point during the year contributions are insufficient to pay claims, the Company is required to make additional contributions to fund claims as deemed necessary by the Plan administrator. The contributions of the Company is determined by the Plan administrator in order to provide the Plan with assets sufficient to meet benefit obligations. The Company may elect to collect a certain portion of the contributions from their employees throughout the Plan year via payroll deductions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay as-you-go basis.

PTO benefits are contributed to the Plan when earned as per the Company's PTO policy. PTO contributed to the Plan during the year is included in employer contributions on the statement of changes in net assets available for benefits.

FSA contributions are elected annually by the employee in advance and are limited to \$3,200 for 2024, except for dependent care which has a limit of \$5,000.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements, in accordance with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Payment of Benefits

Premiums paid by either the Company or the Employee Benefit Trust are recorded as premiums paid in the accompanying statement of changes in net assets available for benefits.

Medical and prescription drug claim payments are recorded when paid by the third-party claims processor. Amounts due to the third-party claims processor that have yet to be reimbursed by the Plan are recorded as claims payable to third-party service providers in the accompanying statements of net assets available for benefits.

Vacation benefits are paid out to participants by the Company when PTO is used and then reimbursed by the Trust. PTO paid out to participants totaled \$424,164 and is included in vacation benefits paid on the statement of changes in net assets available for benefit.

Flexible Spending Accounts

Flexible spending account claim payments are recorded when paid by the third-party claims processor and included in claims paid, net on the statement of changes in net assets available for benefits. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable to third-party service providers in the accompanying statements of net assets available for benefits.

Stop-Loss

Premiums for stop-loss insurance are paid by the Employee Benefit Trust and are included in premiums paid the accompanying statement of changes in net assets available for benefits. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Stop-loss refunds totaling \$479,853 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits during the year ended December 31, 2024.

Refunds

Refunds due from the Plan's PBM and third-party claims processor are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$208,440 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits during the year ended December 31, 2024.

Administrative Expenses

Administrative expenses consist primarily of administrative fees paid to the third-party claims processor and professional fees. These expenses are paid from the Employee Benefit Trust and are included on the statement of changes in net assets available for benefits as administrative expenses.

Subsequent Events

Management evaluated subsequent events through May 7, 2026, the date the financial statements were available to be issued.

3. CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at December 31, 2024 for claims incurred but not reported are estimated based on claims data provided by the Plan's third-party claims processor. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. PLAN TERMINATION

Although they have not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue their contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

5. TAX STATUS

The Plan is funded through a Voluntary Employees' Beneficiary Association (VEBA) trust. For federal income tax purposes, the VEBA trust files Internal Revenue Service (IRS) Form 1041 as required for certain employee welfare benefit arrangements. The VEBA trust may be exempt from federal income tax under IRC 501(c)(9). However, investment income of the trust may be subject to income tax if it

constitutes unrelated business taxable income (UBTI). No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that “more likely than not” would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RISK AND UNCERTAINTIES

The Plan maintains cash balances at a financial institution. The cash balances are secured by the Federal Deposit Insurance Corporation (FDIC) up to applicable FDIC limits. At times, the Plan’s deposits may exceed insured limits.

The Plan Sponsor’s estimate of benefit obligations is subject to certain assumptions that are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

7. PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

As described in Note 1, the Plan has several arrangements with service providers. During the year ended December 31, 2024, the Plan’s non-interest-bearing cash was held by Fulton Bank, the custodian of the Plan. These transactions are party-in-interest transactions under ERISA.
