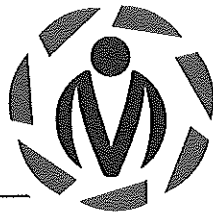

Midwest Members Credit Union respectfully requests a waiver of penalties related to the late filing of Form 5500-SF for the plan year ending December 31, 2022.

The delay in filing was due to reasonable cause and not willful neglect.

In November 2021, Midwest Members Credit Union completed a merger with Processors Industrial Federal Credit Union. As part of this merger, the retirement plan maintained by Processors Industrial Federal Credit Union was transitioned to new service providers and incorporated into Midwest Members Credit Union's administration.

At the time of the merger, Midwest Members Credit Union relied on its third-party administrators, including Paychex and CUNA Mutual Group, to coordinate and complete all required plan filings associated with the transition.

The Form 5500 for the 2021 plan year was prepared and filed, and based on our understanding of the merger process, we believed this filing represented the final required filing for the plan.

We were not aware that a final Form 5500-SF for the 2022 plan year was required. Additionally, Paychex, which had historically prepared and filed Form 5500 for the plan, did not prepare or file a 2022 return and did not notify us that an additional filing was required following the transfer and liquidation of plan assets.

Upon receiving correspondence regarding the missing filing, Midwest Members Credit Union immediately began working with both Paychex and CUNA Mutual Group to determine responsibility for the filing and to confirm the appropriate reporting requirements following the merger.

This situation was the result of a good-faith misunderstanding during a complex plan transition and reliance on third-party administrators who had historically handled all Form 5500 filings on behalf of the plan.

Upon becoming aware of the issue, we took prompt action to address the oversight and ensure the required filing was completed.

Midwest Members Credit Union has a strong history of compliance and takes its reporting obligations seriously. This was an isolated issue resulting from the merger and transition of plan administration.

Based on the circumstances described above, we respectfully request that any penalties associated with this late filing be waived due to reasonable cause.

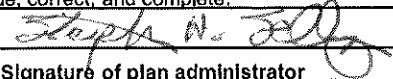
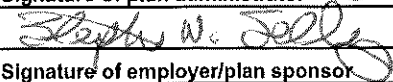
